9	shall not be enforced.

11	enforcement officers or other employees, but the rule or requirement shall be no more restrictive than requiring such personnel to reside within a one-hour response time.
12	311.620. 1. No person shall be appointed as agent, assistant, deputy or inspector under the
14	provisions of the liquor control law who shall have been convicted of or against whom any
15	indictment may be pending for any offense; nor shall any person be appointed as such agent,
16	assistant, deputy or inspector who is not of good character or who is not a citizen of the United
17	States, and who is not [or has not been] a resident taxpaying citizen of the state [for a period of three
18	years previous to his] at the time of his or her appointment; or who is not able to read and write the
19	English language or who does not possess ordinary physical strength and who is not able to pass
