Possession of a firearm in a vehicle on the premises of any adult, juvenile detention, or correctional
institution, prison or jail shall not be a criminal offense so long as the firearm is not removed from
the vehicle or brandished while the vehicle is on the premises;

16 (4) Any courthouse solely occupied by the circuit, appellate or supreme court, or any 17 courtrooms, administrative offices, libraries or other rooms of any such court whether or not such 18 court solely occupies the building in question. This subdivision shall also include, but not be 19 limited to, any juvenile, family, drug, or other court offices, any room or office wherein any of the 20 courts or offices listed in this subdivision are temporarily conducting any business within the jurisdiction of such courts or offices, and such other locations in such manner as may be specified 21 22 by supreme court rule pursuant to subdivision (6) of this subsection. 31 (5) Any meeting of the governing body of a unit of local government; or any meeting of the 32 general assembly or a committee of the general assembly, except that nothing in this subdivision 33 shall preclude a member of the body holding a valid concealed carry permit or endorsement from 34 carrying a concealed firearm at a meeting of the body which he or she is a member. Possession of a 35 firearm in a vehicle on the premises shall not be a criminal offense so long as the firearm is not 36 removed from the vehicle or brandished while the vehicle is on the premises. Nothing in this 37 subdivision shall preclude a member of the general assembly, a full-time employee of the general 38 assembly employed under Section 17, Article III, Constitution of Missouri, legislative employees of 39 the general assembly as determined under section 21.155, or statewide elected officials and their 40 employees, holding a valid concealed carry permit or endorsement, from carrying a concealed 41 firearm in the state capitol building or at a meeting whether of the full body of a house of the 42 general assembly or a committee thereof, that is held in the state capitol building;

(6) The general assembly, supreme court, county or municipality may by rule,
administrative regulation, or ordinance prohibit or limit the carrying of concealed firearms by permit
or endorsement holders in that portion of a building owned, leased or controlled by that unit of
government. Any portion of a building in which the carrying of concealed firearms is prohibited or
limited shall be clearly identified by signs posted at the entrance to the restricted area. The statute,
rule or ordinance shall exempt any building used for public housing by private persons, highways or
rest areas, firing ranges, and private dwellings owned, leased, or controlled by that unit of

government from any restriction on the carrying or possession of a firearm. The statute, rule or ordinance shall not specify any criminal penalty for its violation but may specify that persons violating the statute, rule or ordinance may be denied entrance to the building, ordered to leave the building and if employees of the unit of government, be subjected to disciplinary measures for violation of the provisions of the statute, rule or ordinance. The provisions of this subdivision shall not apply to any other unit of government;

7 (7) Any establishment licensed to dispense intoxicating liquor for consumption on the 8 premises, which portion is primarily devoted to that purpose, without the consent of the owner or 9 manager. The provisions of this subdivision shall not apply to the licensee of said establishment. 10 The provisions of this subdivision shall not apply to any bona fide restaurant open to the general public having dining facilities for not less than fifty persons and that receives at least fifty-one 11 12 percent of its gross annual income from the dining facilities by the sale of food. (9) Any place where the carrying of a firearm is prohibited by federal law;

22 (10) Any higher education institution or elementary or secondary school facility without the 23 consent of the governing body of the higher education institution or a school official or the district 24 school board, unless the person with the concealed carry endorsement or permit is a teacher or 25 administrator of an elementary or secondary school who has been designated by his or her school 26 district as a school protection officer and is carrying a firearm in a school within that district, in 27 which case no consent is required. Possession of a firearm in a vehicle on the premises of any 28 higher education institution or elementary or secondary school facility shall not be a criminal 29 offense so long as the firearm is not removed from the vehicle or brandished while the vehicle is on 30 the premises;

(11) Any portion of a building used as a child care facility without the consent of the
 manager. Nothing in this subdivision shall prevent the operator of a child care facility in a family
 home from owning or possessing a firearm or a concealed carry permit or endorsement;

(12) Any riverboat gambling operation accessible by the public without the consent of the
owner or manager pursuant to rules promulgated by the gaming commission. Possession of a
firearm in a vehicle on the premises of a riverboat gambling operation shall not be a criminal
offense so long as the firearm is not removed from the vehicle or brandished while the vehicle is on
the premises;

(13) Any gated area of an amusement park. Possession of a firearm in a vehicle on the
premises of the amusement park shall not be a criminal offense so long as the firearm is not
removed from the vehicle or brandished while the vehicle is on the premises;

(14) Any church or other place of religious worship without the consent of the minister or
person or persons representing the religious organization that exercises control over the place of
religious worship. Possession of a firearm in a vehicle on the premises shall not be a criminal
offense so long as the firearm is not removed from the vehicle or brandished while the vehicle is on
the premises;

47 (15) Any private property whose owner has posted the premises as being off-limits to
48 concealed firearms by means of one or more signs displayed in a conspicuous place of a minimum
49 size of eleven inches by fourteen inches with the writing thereon in letters of not less than one inch.

The owner, business or commercial lessee, manager of a private business enterprise, or any other 1 2 organization, entity, or person may prohibit persons holding a concealed carry permit or 3 endorsement from carrying concealed firearms on the premises and may prohibit employees, not 4 authorized by the employer, holding a concealed carry permit or endorsement from carrying 5 concealed firearms on the property of the employer. If the building or the premises are open to the 6 public, the employer of the business enterprise shall post signs on or about the premises if carrying a 7 concealed firearm is prohibited. Possession of a firearm in a vehicle on the premises shall not be a 8 criminal offense so long as the firearm is not removed from the vehicle or brandished while the 9 vehicle is on the premises. 12 (16) Any sports arena or stadium with a seating capacity of five thousand or more. 13 Possession of a firearm in a vehicle on the premises shall not be a criminal offense so long as the 14 firearm is not removed from the vehicle or brandished while the vehicle is on the premises;

15 (17) Any hospital accessible by the public. Possession of a firearm in a vehicle on the 16 premises of a hospital shall not be a criminal offense so long as the firearm is not removed from the 17 vehicle or brandished while the vehicle is on the premises.

18 2. Carrying of a concealed firearm or knuckles in a location specified in subdivisions (1) to 19 (17) of subsection 1 of this section by any individual who holds a concealed carry permit issued 20 pursuant to sections 571.101 to 571.121, or a concealed carry endorsement issued prior to August 28, 2013, shall not be a criminal act but may subject the person to denial to the premises or removal 21 22 from the premises. If such person refuses to leave the premises and a peace officer is summoned, 23 such person may be issued a citation for an amount not to exceed one hundred dollars for the first 24 offense. If a second citation for a similar violation occurs within a six-month period, such person 25 shall be fined an amount not to exceed two hundred dollars and his or her permit, and, if applicable, 26 endorsement to carry concealed firearms shall be suspended for a period of one year. If a third citation for a similar violation is issued within one year of the first citation, such person shall be 27 28 fined an amount not to exceed five hundred dollars and shall have his or her concealed carry permit, 29 and, if applicable, endorsement revoked and such person shall not be eligible for a concealed carry permit for a period of three years. Upon conviction of charges arising from a citation issued 30 pursuant to this subsection, the court shall notify the sheriff of the county which issued the 31 32 concealed carry permit, or, if the person is a holder of a concealed carry endorsement issued prior to 33 August 28, 2013, the court shall notify the sheriff of the county which issued the certificate of 34 qualification for a concealed carry endorsement and the department of revenue. The sheriff shall 35 suspend or revoke the concealed carry permit or, if applicable, the certificate of qualification for a 36 concealed carry endorsement. If the person holds an endorsement, the department of revenue shall 37 issue a notice of such suspension or revocation of the concealed carry endorsement and take action 38 to remove the concealed carry endorsement from the individual's driving record. The director of 39 revenue shall notify the licensee that he or she must apply for a new license pursuant to chapter 302 40 which does not contain such endorsement.
