23	claim a tax credit against the taxpayer's state tax liability in an amount equal to fifty percent of the
24	taxpayer's eligible expenses for establishing an urban farm in a food desert.
25	3. The amount of the tax credit claimed shall not exceed the amount of the taxpayer's state
26	tax liability in the tax year for which the credit is claimed, and the taxpayer shall not be allowed to
27	claim a tax credit under this section in excess of one thousand dollars for each urban farm.
28	However, any tax credit that cannot be claimed in the tax year the contribution is made may be
29	carried over to the next three succeeding tax years until the full credit is claimed.

41	an area containing a group of individuals whose members have been subjected to racial or ethnic
42	prejudice because of the identity of such individuals as members of a group without regard to the
43	individual qualities of such individuals.
44	2. There is hereby created within the department of agriculture the "Socially Disadvantaged
45	Communities Outreach Program" to connect historically unserved and underserved urban
46	communities with access to healthy fresh food and knowledge and skills related to food production.
47	3. The outreach program shall:
48	(1) Provide financial assistance for people growing food in socially disadvantaged
49	communities through programs such as those authorized in section 135.1610;

1	(2) Encourage activities that support and promote urban agriculture in socially
2	disadvantaged communities;
3	(3) Provide educational and skills training related to food production in socially
4	disadvantaged communities; and
5	(4) Address food deserts in urban socially disadvantaged communities through programs

7	4. The department shall designate an employee to administer and monitor the socially
8	disadvantaged communities outreach program and to serve as a liaison to affected communities.
9	The duties of such employee shall include, but not be limited to:
10	(1) Providing leadership at the state level to encourage participation in programs to meet the
11	goals under subsections 2 and 3 of this section;
12	(2) Conducting workshops and other sessions that provide educational and skills training
13	related to food production to residents of socially disadvantaged communities; and
14	(3) Seeking grants, private donations, or other funding sources to support the socially
15	disadvantaged communities outreach program.
16	5. On or before December thirty-first of each year, the department shall submit a report to
17	the general assembly detailing the number of residents who received training under this section, the
18	number of tax credits issued under sections 135.1610 and 135.1620, and any recommendations for
19	legislative action to improve the program."; and
