4	"115.277. 1. Except as provided in subsections 2, 3, 4, and 5 of this section, any registered
5	voter of this state may vote by absentee ballot for all candidates and issues for which such voter
6 7	would be eligible to vote at the polling place if such voter expects to be prevented from going to the polls to vote on election day due to:
8	(1) Absence on election day from the jurisdiction of the election authority in which such
9	voter is registered to vote;
10	(2) Incapacity or confinement due to illness or physical disability, including a person who is
11	primarily responsible for the physical care of a person who is incapacitated or confined due to
12	illness or disability;
13	(3) Religious belief or practice;
14	(4) Employment as an election authority, as a member of an election authority, or by an
15	election authority at a location other than such voter's polling place;
16	(5) Incarceration, provided all qualifications for voting are retained;
17	(6) Certified participation in the address confidentiality program established under sections
18	589.660 to 589.681 because of safety concerns; or
19	(7) For an election that occurs during the year 2020, the voter has contracted or is in an at-
20	risk category for contracting or transmitting severe acute respiratory syndrome coronavirus 2. This
21	subdivision shall expire on December 31, $[2020]$ 2021.
22	2. Any covered voter who is eligible to register and vote in this state may vote in any
23	election for federal office, statewide office, state legislative office, or statewide ballot initiatives by
24 25	submitting a federal postcard application to apply to vote by absentee ballot or by submitting a
25 26	federal postcard application at the polling place even though the person is not registered. A federal
26 27	postcard application submitted by a covered voter pursuant to this subsection shall also serve as a
27	voter registration application under section 115.908 and the election authority shall, if satisfied that
28 29	the applicant is entitled to register, place the voter's name on the voter registration file. Each covered voter may vote by absentee ballot or, upon submitting an affidavit that the person is
30	qualified to vote in the election, may vote at the person's polling place.

  and vice presidential electors, United States senator, representative in Congress, statewide elected

- 6 5. Any new resident may vote by absentee ballot for presidential and vice presidential
