1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 403, Page 4,
2 Section 135.690, Line 97, by inserting after all of said section and line the following:
3

4 "170.047. 1. Beginning in the 2017-18 school year, any licensed educator may annually complete up
5 to two hours of training or professional development in youth suicide awareness and prevention as part of the
6 professional development hours required for state board of education certification. Beginning in the 2021-22
7 school year and continuing in subsequent school years, such training or professional development in youth
8 suicide awareness and prevention shall contain at least one unit relating to stress management strategies for
9 students and faculty members.

10 2. The department of elementary and secondary education shall develop guidelines suitable for
11 training or professional development in youth suicide awareness and prevention. The department shall
12 develop materials that may be used for such training or professional development.

13 3. For purposes of this section, the term "licensed educator" shall refer to any teacher with a
14 certificate of license to teach issued by the state board of education or any other educator or administrator
15 required to maintain a professional license issued by the state board of education.

16 4. The department of elementary and secondary education may promulgate rules and regulations to
17 implement this section.

18 5. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the
19 authority delegated in this section shall become effective only if it complies with and is subject to all of the
20 provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable,
21 and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the
22 effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of
23 rulemaking authority and any rule proposed or adopted after August 28, 2016, shall be invalid and void.

24 170.048. 1. By July 1, 2018, each district shall adopt a policy for youth suicide awareness and
25 prevention, including plans for how the district will provide for the training and education of its district
26 employees.

27 2. Each district's policy shall address and include, but not be limited to, the following:

28 (1) Strategies that can help identify students who are at possible risk of suicide;

29 (2) Strategies and protocols for helping students at possible risk of suicide; and

30 (3) Protocols for responding to a suicide death.

31 3. By July 1, 2017, the department of elementary and secondary education shall develop a model
32 policy that districts may adopt. When developing the model policy, the department shall cooperate, consult
33 with, and seek input from organizations that have expertise in youth suicide awareness and prevention. By
34 July 1, 2021, and at least every three years thereafter, the department shall request information and seek
35 feedback from districts on their experience with the policy for youth suicide awareness and prevention. The
36 department shall review this information and may use it to adapt the department's model policy. The
37 department shall post any information on its website that it has received from districts that it deems relevant.
38 The department shall not post any confidential information or any information that personally identifies any
39 student or school employee.

40 4. (1) Beginning July 16, 2022, a public school or charter school that serves any pupils in seventh

1 grade to twelfth grade and that issues pupil identification cards shall have printed on either side of the cards

4 (a) The telephone number for the National Suicide Prevention Lifeline, 988;

5 (b) The Crisis Text Line, which can be accessed by texting HOME to 741741; and

6 (c) A local suicide prevention hotline telephone number if available.

7 (2) If, on July 16, 2022, a public school or charter school subject to the requirements of this
 8 subsection has a supply of unissued pupil identification cards that do not comply with the requirements of
 9 subdivision (1) of this subsection, the school may issue such cards until that supply is depleted.

10 (3) The provisions of subdivision (1) of this subsection shall apply to a pupil identification card
 11 issued for the first time to a pupil and to a card issued to replace a damaged or lost card.

12 173.1200. 1. Each public institution of higher education shall develop and implement a policy to
 13 advise students and staff on suicide prevention programs available on and off campus that includes, but is not
 14 limited to:

15 (1) Crisis intervention access, which includes information for national, state, and local suicide
 16 prevention hotlines;

17 (2) Mental health program access, which provides information on the availability of local mental
 18 health clinics, student health services, and counseling services;

19 (3) Multimedia application access, which includes crisis hotline contact information, suicide warning
 20 signs, resources offered, and free-of-cost applications;

21 (4) Student communication plans, which consist of creating outreach plans regarding educational
 22 and outreach activities on suicide prevention; and

23 (5) Post intervention plans, which include creating a strategic plan to communicate effectively with
 24 students, staff, and parents after the loss of a student to suicide.

25 2. Such policy shall also advise students, faculty, and staff, including residence hall staff, of the
 26 proper procedures for identifying and addressing the needs of students exhibiting suicidal tendencies or
 27 behavior, and shall provide for training, where appropriate.

28 3. Each public institution of higher education shall provide all incoming students with information
 29 about depression and suicide prevention resources available to students. The information provided to
 30 students shall include available mental health services and other support services, including student-run
 31 organizations for individuals at risk of or affected by suicide.

32 4. The information prescribed by subdivisions (1) through (4) of subsection 1 of this section shall be
 33 posted on the website of each institution of higher education in this state.

34 5. Any applicable free-of-cost prevention materials or programs shall be posted on the websites of
 35 the public institutions of higher education and the department of higher education and workforce
 36 development.

37 6. (1) Each public institution of higher education shall establish and maintain methods of
 38 anonymous reporting concerning unsafe, potentially harmful, dangerous, violent, or criminal activities, or the
 39 threat of such activities.

40 (2) Such methods shall ensure that the identity of the reporting party remains unknown to all persons
 41 and entities, including law enforcement officers and employees or other persons, except when criminal, civil,
 42 or administrative action is initiated regarding unsafe, potentially harmful, dangerous, violent, or criminal
 43 activities, or the threat of such activities.

44 7. (1) Beginning July 16, 2022, a public institution of higher education that issues student
 45 identification cards shall have printed on either side of the cards the telephone number described in paragraph
 46 (a) of this subdivision and may have printed on either side of the cards the telephone numbers described in
 47 paragraphs (b) to (d) of this subdivision;

48 (a) The telephone number for the National Suicide Prevention Lifeline, 988;

49 (b) The Crisis Text Line, which can be accessed by texting HOME to 741741;

50 (c) The campus police or security telephone number or, if the campus does not have a campus police
 51 or security telephone number, the local law enforcement authority's telephone number; and

52 (d) A local suicide prevention hotline telephone number if available.

53 (2) If, on July 16, 2022, a public institution of higher education subject to the requirements of this

1 subsection has a supply of unissued student identification cards that do not comply with the requirements of
2 subdivision (1) of this subsection, the institution may issue such cards until that supply is depleted.

3 (3) The provisions of subdivision (1) of this subsection shall apply to a student identification card
4 issued for the first time to a student and to a card issued to replace a damaged or lost card."; and
