## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Revenue (DOR)** assume the following regarding this proposal:

#### **Administrative Impact**

To implement the proposed legislation, the Department will be required to:

- Work with the driver license issuance vendor to modify driver license and non-driver license card design to allow for placement of the proposed data string detailing the requested medical notation;
- Complete user acceptance testing of the Missouri Electronic Driver License (MEDL) issuance system and supporting applications for the notation and folio change;
- Submit a change request to the current license vendor to modify the driver license and non-driver identification card and request a placeholder for a veteran notation on the front of the license;
- Update forms, manuals, correspondence letters, and the Department website;
- Update the mail-in application forms for military renewal application;
- Update the on-line and printed versions of the Missouri Driver Guide, Missouri Motorcycle Guide and Commercial Driver License Manual;
- Update policies, procedures, and the Uniform License Issuance Manual (ULIM); and
- Train staff.

**Oversight** assumes DOR will use existing staff and will not hire additional FTE to conduct these activities; therefore, Oversight will not reflect the administrative costs DOR has indicated on the fiscal note.

## License Vendor Cost FY 2022

The Department implemented a new driver license issuance system upgrade and card design as part of the new vendor contract as of July 2020. <u>The Department will be required to modify the card design to include the new veteran notation on the front of the card; therefore, there will be an estimated one-time cost for the vendor of **\$28,000**.</u>

**Oversight** does not have information to the contrary and therefore, Oversight will reflect the estimate as provided by DOR.

**Oversight** assumes OA-ITSD is provided with core funding to handle a certain amount of activity each year. Oversight assumes OA-ITSD could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, OA-ITSD could request funding through the appropriation process.

#### FISCAL DESCRIPTION

Currently, a veteran may have a veteran designation placed on his or her driver's license if he or she provides specified information. Currently, it is up to the Department of Revenue to determine where the designation appears on the license.

This bill requires the Department to place the designation on the front of the driver's license.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
