FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of the State Courts Administrator, the Department of Social Services, the Attorney General's Office and the Department of Health and Senior Services each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight notes that according to the Annual Judicial Statistical Reports from the Office of the State Courts Administrator, a 5 year average shows 7,409 cases of abuse and neglect are filed annually for juveniles out of a total of 16,814 and 43,254 cases of adult abuse are filed annually out of a total of 100,692 domestic relations cases filed in the State of Missouri. Oversight is unclear of how many of these cases are representative of certain persons with disabilities.
