#### **FISCAL ANALYSIS**

#### **ASSUMPTION**

§210.950 – Abandonment of newborn children

Officials from the Department of Health and Senior Services, the Department of Social Services, the Crestwood Police Department, the Ellisville Police Department, the Kansas City Police Department, the St. Louis County Police Department, the Crawford County 911 Board, the Nodaway County Ambulance District and the Hermann Area Hospital District each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **St. Clair Fire Protection District** indicated this proposal would have a fiscal impact on their organization but did not indicate what that impact would be. The fire protection district did not respond to a request for additional information. Based on the no impact responses of other local governments, **Oversight** assumes this proposal will have a minimal fiscal impact on the St. Clair Fire Protection District and will present it as "no impact" for fiscal note purposes.

#### **Rule Promulgation**

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The Secretary of State's office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to Secretary of State's office for Administrative Rules is less than \$5,000. The Secretary of State's office recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other police departments, sheriffs' departments, ambulance and EMS, and hospitals were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
