FISCAL ANALYSIS

ASSUMPTION

Officials from the Department of Commerce and Insurance (DCI), the Department of Corrections, the Office of the State Courts Administrator, the Office of the State Public Defender, the Office of Prosecution Services, the Department of Public Safety - Missouri Highway Patrol, the Missouri State University, the State Technical College of Missouri and the University of Central Missouri each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that several agencies have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Office of Administration - Administrative Hearing Commission** anticipate that this legislation will not significantly alter is caseload. If similar bills pass, resulting in more cases, there will be a fiscal impact. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for this agency.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other colleges and universities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

Oversight notes that DCI reports that there are currently 71 licensed athlete agents in Missouri.
