## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Commerce and Insurance** and the **Office of the Secretary of State** each assume the proposal will have no fiscal impact on their organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

In response to a previous version, officials from the **Office of Administration** assumed the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for this agency.

Officials from **Jackson County** and the **Mississippi County Recorder of Deeds Office** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation from 2020, HB 2368, officials from the **Daviess County Recorder of Deeds Office** assumed no fiscal impact from this proposal. Daviess County's Recorder is already bonded for \$10,000.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other counties and county recorder offices were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
