This proposal will directly impact small business hair shampooists and cosmetology businesses that hire hair shampooists.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
