FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education**, **Department of Mental Health** and the **Department of Social Services** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Springfield Public Schools** estimates this proposal could cost \$5,000 if the district participates.

Officials from the **High Point R-III School District** assume the proposal will have no fiscal impact on their organization.

Oversight notes the Springfield Public Schools indicated there could be costs associated with implementing this proposal. Oversight will show a range of impact of \$0 (no schools participate or the additional requirements can be absorbed) to an unknown cost.

Oversight received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

FISCAL IMPACT – Small Business

FISCAL DESCRIPTION

This bill modifies the Trauma Informed School Initiative to require participating schools to keep a record of specific incidents and to inform parents within 48 hours of a child's removal from a classroom due to an outburst.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
