### ASSUMPTION

§194.119 – Next-of-kin to delegate control of the final disposition of remains of a deceased person

Officials from the **Department of Commerce and Insurance**, the **Department of Health and Senior Services**, the **Office of the State Courts Administrator**, the **Columbia/Boone County Department of Public Health and Human Services** and the **Newton County Health Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other local public health agencies were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

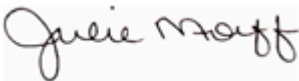
### FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.

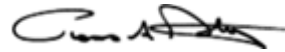
This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
