## **FISCAL ANALYSIS**

## **ASSUMPTION**

Officials from the **Office of the State Treasurer (STO)** assume no fiscal impact from this proposal. However, as of June 30, 2020, there was a balance of \$2,557.00 in the Missouri State Archives-St. Louis Trust Fund (0770). The STO assumes that the existing balance in the Missouri State Archives-St. Louis Trust Fund (0770) will be transferred into GR and will have a positive fiscal impact of \$2,557.

Officials from the **Office of Administration** and the **Office of the Secretary of State** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from **St. Louis City** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

**Oversight** notes the Missouri State Archives – St. Louis Fund (0770) had an ending balance of \$2,557 on June 30, 2020. In July 2020, there were receipts of \$.31 and a disbursement/transfer out of \$2,557.31 which made the account zero at the end of July. There has been no activity as of 12/31/20.
