Bill Summary: This proposal specifies that the chief executive of a county or city shall have his or her compensation reduced if the county or city issues an order that limits the operating hours of a private business.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

This bill requires a proportional reduction in salary for specified chief executive officials in municipalities or counties who authorize rules, ordinances, or policies that result in a significant interruption to the operating hours of private businesses in a particular county or municipality. There is an exception for cases of disaster involving the evacuation of residents from a region and for specified contractual agreements entered into before August 28, 2021.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
