FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Natural Resources** and **Department of Health and Senior Services** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Columbia/Boone County Department of Public Health and Human Services (PHHS)** assume there will be unknown costs as a result of this proposal. The proposal requires PHHS to provide information on the impact of public water fluoridation to any public water supply which intends to modify the fluoridation of its water supply. It is unknown how many public water supplies in Boone County will seek to change their fluoridation practices. It is also unknown how often they may seek to change fluoridation practices. The proposal will require PHHS to research fluoridation impacts and remain current on new such research.

Officials from the **Newton County Health Department** assume there would be a minimal negative impact, that being the cost of paper and toner to print materials or cost of producing informational pamphlets.

Oversight assumes local public health agencies (LPHAs) could incur some costs related to this proposal; however, Oversight notes these costs are unknown based on the information provided. Therefore, Oversight will reflect a potential "Unknown" cost to local public health agencies depending if this situation occurs.

Officials from the **Tri County Water Authority** and **Union Star Water/Wastewater** assume there will be a fiscal impact of this proposal but did not specify what that impact would be.

Officials from the St. Louis County Health Department, City of Springfield Water, St. Charles County PWSD #2 and Wayne County PWSD #2 each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other LPHA's and water companies were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill requires any public water system or public water supply district that intends to start or stop fluoridation of its water supply on a continuing basis to seek and receive information about the impact of public water fluoridation from the local health department.

The public water system or public water supply district shall inform the Department of Natural Resources and the Department of Health and Senior Services that the water system or water district has sought and received information on the impact of public water fluoridation prior to submitting notification of the water system's or water district's intention to start or stop public water fluoridation on a continuing basis.

In cases of an investor-owned water system, the entity calling for the modifications to fluoridation shall be responsible for all costs associated with compliance.
