# **FISCAL ANALYSIS**

#### ASSUMPTION

Officials from the **Office of the State Public Defender (SPD)** assume for the purpose of the proposed legislation, and as a result of excessive caseloads, the SPD cannot assume existing staff will be able to provide competent, effective representation for any new cases where indigent persons are charged with the proposed new crime(s) under Section 130.040, RSMo, concerning the release of personal information, which are classified as a class B misdemeanor. However, if this offense was classified as a class D misdemeanor, it would not qualify for public defender representation because it would be punishable by a fine only, and therefore there would be no impact on SPD. The Missouri State Public Defender System is currently providing legal representation in caseloads in excess of recognized standards. While the number of new cases may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide competent and effective representation in all cases where the right to counsel attaches.

**Oversight** assumes the SPD will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the SPD for fiscal note purposes.

Officials from **Missouri Office of Prosecution Services (MOPS)** assume no measurable fiscal impact to their organization. The enactment of a new crime [105.1500.5(3)] creates additional responsibilities for county prosecutors and the circuit attorney which may in turn result in additional costs which are difficult to determine.

Officials from the **Office of the State Courts Administrator** and **Missouri Ethics Commission** both assume the proposal will have no fiscal impact on their organization.

In response to a previous version, officials from the **Office of Administration** assumed the proposal will have no fiscal impact on their respective organization.

In response to similar legislation SB 409 from 2021, officials from the **Missouri Highway Patrol** assumed the proposal will have no fiscal impact on their organization.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.
