# **FISCAL ANALYSIS**

## ASSUMPTION

Officials from the **Department of Social Services**, the **Office of the Governor**, the **Office of the Lieutenant Governor**, the **Missouri House of Representatives**, and **Legislative Research** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Officials from the **Missouri Senate** state they anticipate a negative fiscal impact to reimburse 3 Senators for travel to task force meetings. In summary, it will cost approximately \$289.71 per meeting.

Officials from the **Office of Administration (OA)** state the new task force may need help from OA-ITSD for gathering information needed for quarterly meetings for the evaluations. Estimating that it would take one day of work per quarter for gathering this information. ITSD assumes a cost of approximately \$3,200 per year for this.

**Oversight** assumes these amounts are not material and could be absorbed within existing appropriation levels.
