#### **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Department of Mental Health (DMH)** state the provisions of this bill could create a conflict for the DMH. For example, if the Missouri Attorney General finds a federal executive order to be unconstitutional under the provisions of subsection three, and a federal agency such as Centers for Medicare and Medicaid Services (CMS) directs DMH to enact a policy consistent with that same executive order, DMH may be bound to comply with CMS in order to continue to receive Medicare/Medicaid funding, of which DMH receives up to \$1.5 billion annually. It is especially foreseeable that this situation could arise during a public health emergency. The potential impact for this legislation could be between \$0 and up to \$1.5 billion.

Officials from the **Department of Public Safety - Missouri National Guard** believe this would not have a fiscal impact, but could be in direct conflict with federal/state law since the Adjutant General must follow direction of the President of the United States and Governor. As stated in RSMo 41.120: Governor, commander in chief of militia. — The governor of the state, by virtue of his office, is the commander in chief of the militia of the state, except such portion thereof as may at times be in the service of the United States. And in RSMo 41.160.3 The Adjutant General shall perform all duties required of the Adjutant General by the laws of the United States and of the state, and the regulations issued pursuant to such laws, now or hereafter promulgated, and such duties as pertain to the function of the chief of staff.

Officials from the **Missouri Department of Agriculture** state they anticipate an unknown impact that is contingent on potential future actions of the federal government.

Officials from the **Missouri Senate** anticipate a negative fiscal impact to reimburse 5 Senators for travel to committee meetings for a total of \$561 per meeting.

**Oversight** assumes administrative costs of the Joint Committee on Federal Government Oversight would not reach a material amount; therefore, Oversight will not reflect a cost to the state for reimbursement of members' expenses.

Officials from the Department of Natural Resources, the Attorney General's Office, Department of Commerce and Insurance, Department of Health and Senior Services, Department of Labor and Industrial Relations, Office of Administration - Budget and Planning, Department of Elementary and Secondary Education, Department of Higher Education and Workforce Development, Office of Administration, Department of Corrections, the Department of Revenue, the Department of Public Safety - Missouri Highway Patrol, Department of Social Services, Missouri Department of Transportation, Department of Economic Development, Missouri Department of Conservation, and the Missouri House of Representatives each assume the proposal would not fiscally impact their respective agencies.

In response to a previous version, officials from the Department of Public Safety (Division of Alcohol and Tobacco Control, Capitol Police, Division of Fire Safety, Director's Office, Gaming Commission, Veterans Commission, State Emergency Management Agency), Missouri Ethics Commission, MoDOT & Patrol Employees' Retirement System, Office of the Secretary of State, Office of the State Public Defender, University of Missouri System, Missouri Lottery Commission, Missouri Consolidated Health Care Plan, Missouri Higher Education Loan Authority, Missouri Office of Prosecution Services, Missouri State Employee's Retirement System, Office of the State Courts Administrator, and the State Tax Commission each assumed the proposal would not fiscally impact their respective agencies.

In response to a previous version, officials from the City of Claycomo, City of Corder, City of Kansas City, City of O'Fallon, and the City of St. Louis each assumed the proposal would not fiscally impact their respective cities.

In response to a previous version, officials from the **City of Ash Grove** stated there would be a fiscal impact, but did not elaborate.

**Oversight** received a limited number of responses from local political subdivisions related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

**Oversight** assumes the Joint Committee on Federal Government Oversight, in the HCS, will play more of an advisory role, and recommend the Attorney General's Office (AGO) and the Office of the Governor (GOV) further examine certain federal executive orders. Therefore, Oversight assumes the HCS, as written, would not, by itself, create a fiscal impact to the state or local political subdivisions. Actions (if any) taken by the AGO and GOV may have an impact.

This bill establishes the "Joint Committee on Federal Government Oversight". The purpose of the Committee is to review any executive orders issued by the President of the United States and make recommendations to the Attorney General and the Governor whether further examination is needed to determine the constitutionality of the executive orders, or whether the state should seek an exemption from the application of the orders.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
