FISCAL ANALYSIS

ASSUMPTION

In response to a previous version, officials from the **Office of Administration** assumed the proposal will have no fiscal impact on their organization.

Officials from the **Office of the State Treasurer** assume the proposal will have no fiscal impact on their organization.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight notes the American Rescue Plan of 2021, described as a “\$1.9 trillion economic stimulus package proposed by President Joe Biden to speed up the United States’ recovery from the economic and health effects of the COVID-19 pandemic,” was signed into law by President Biden on March 11, 2021. Oversight assumes this proposal simply creates new funds and would not have a fiscal impact to the state; therefore, Oversight will simply reflect the creation of the new funds in FY 2021 in the fiscal note.


This bill has an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


