AN ACT

To repeal sections 115.013, 115.031, 115.045, 115.051, 115.081, 115.085, 115.107, 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.287, 115.291, 115.302, 115.349, 115.417, 115.427, 115.435, 115.447, 115.652, 115.960, and 116.220, RSMo, and to enact in lieu thereof thirty-four new sections relating to elections, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 115.013, 115.031, 115.045, 115.051, 115.081, 115.085, 115.107, 2 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 3 115.283, 115.285, 115.287, 115.291, 115.302, 115.349, 115.417, 115.427, 115.435, 115.447, 4 115.652, 115.960, and 116.220, RSMo, are repealed and thirty-four new sections enacted in lieu 5 thereof, to be known as sections 28.960, 115.004, 115.013, 115.031, 115.045, 115.051, 115.081, 115.085, 115.107, 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 6 7 115.277, 115.279, 115.283, 115.285, 115.286, 115.287, 115.291, 115.349, 115.417, 115.427, 115.435, 115.447, 115.652, 115.960, 116.225, 1, and 2, to read as follows: 8

28.960. 1. The secretary of state shall have the authority to, at his or her discretion, audit the list of registered voters for any election authority to ensure accuracy. 2

3

2. The secretary of state shall provide at least five business days' notice to the election authority that he or she intends to inspect the list of voter registration records. 4

5 Such notice may be sent electronically.

6 3. The audits conducted by the secretary of state shall, at a minimum, verify the 7 following:

8

(1) That a registered voter is alive;

EXPLANATION — Matter enclosed in **bold-faced** brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

9 (2) That a registered voter currently resides within the jurisdiction of election 10 authority; and

11

(3) That a registered voter is entitled to vote.

12 4. If names are found that do not meet the criteria in subsection 3 of this section, the secretary of state shall instruct the election authority to remove the names from the list 13 14 of registered voters. The secretary of state may conduct a second audit to ensure the names 15 were removed.

16 5. The election authority shall comply with the secretary of state's office in 17 conducting the audit and shall remove the names identified by the secretary of state. If an election authority does not cooperate with the audit, the secretary of state's office may 18 19 withhold funds from the election authority.

115.004. The sections of this chapter and all related rules and regulations shall not be amended or modified in any manner in the twenty-six weeks preceding a presidential 2 3 election.

115.013. As used in this chapter, unless the context clearly implies otherwise, the 2 following terms mean:

"Automatic tabulating equipment", the apparatus necessary to examine and 3 (1)4 automatically count votes, and the data processing machines which are used for counting votes 5 and tabulating results and is air gapped and not connected to a network;

(2) "Ballot", the [ballot card,] paper ballot, or ballot designed for use with an electronic voting system on which each voter may cast all votes to which he or she is entitled at an election; 7

8 9

(3) ["Ballot card", a ballot which is voted by making a mark which can be tabulated by automatic tabulating equipment;

10 (4) "Ballot label", the card, paper, booklet, page, or other material containing the names of all offices and candidates and statements of all questions to be voted on; 11

12 "Counting location", a location selected by the election authority for the [(5)] (4) automatic processing or counting, or both, of ballots; 13

14

[(6)] (5) "County", any county in this state or any city not within a county;

15 [(7)] (6) "Disgualified", a determination made by a court of competent jurisdiction, the Missouri ethics commission, an election authority or any other body authorized by law to make 16 17 such a determination that a candidate is ineligible to hold office or not entitled to be voted on for 18 office:

19 [(8)] (7) "District", an area within the state or within a political subdivision of the state 20 from which a person is elected to represent the area on a policy-making body with 21 representatives of other areas in the state or political subdivision;

22 [(9)] (8) "Electronic voting machine", any part of an electronic voting system on which 23 a voter is able to cast a ballot under this chapter;

[(10)] (9) "Electronic voting system", a system of casting votes by use of marking devices, and counting votes by use of automatic tabulating or data processing equipment, including computerized voting systems;

[(11)] (10) "Established political party" for the state, a political party which, at either of the last two general elections, polled for its candidate for any statewide office more than two percent of the entire vote cast for the office. "Established political party" for any district or political subdivision shall mean a political party which polled more than two percent of the entire vote cast at either of the last two elections in which the district or political subdivision voted as a unit for the election of officers or representatives to serve its area;

33 [(12)] (11) "Federal office", the office of presidential elector, United States senator, or
 34 representative in Congress;

35 [(13)] (12) "Independent", a candidate who is not a candidate of any political party and 36 who is running for an office for which political party candidates may run;

[(14)] (13) "Major political party", the political party whose candidates received the
 highest or second highest number of votes at the last general election;

39 [(15)] (14) "Marking device", any approved device which will enable the votes to be 40 counted by automatic tabulating equipment;

41 [(16)] (15) "Municipal" or "municipality", a city, village, or incorporated town of this 42 state;

43 [(17)] (16) "New party", any political group which has filed a valid petition and is 44 entitled to place its list of candidates on the ballot at the next general or special election;

45 [(18)] (17) "Nonpartisan", a candidate who is not a candidate of any political party and 46 who is running for an office for which party candidates may not run;

47

[(19)] (18) "Political party", any established political party and any new party;

48 [(20)] (19) "Political subdivision", a county, city, town, village, or township of a 49 township organization county;

50 [(21)] (20) "Polling place", the voting place designated for all voters residing in one or 51 more precincts for any election;

52 [(22)] (21) "Precincts", the geographical areas into which the election authority divides 53 its jurisdiction for the purpose of conducting elections;

54 [(23)] (22) "Public office", any office established by constitution, statute or charter and 55 any employment under the United States, the state of Missouri, or any political subdivision or 56 special district thereof, but does not include any office in the Missouri state defense force or the 57 National Guard or the office of notary public or city attorney in cities of the third classification 58 or cities of the fourth classification;

[(24)] (23) "Question", any measure on the ballot which can be voted "YES" or "NO";
[(25)] (24) "Relative within the second degree by consanguinity or affinity", a spouse,
parent, child, grandparent, brother, sister, grandchild, mother-in-law, father-in-law, daughter-inlaw, or son-in-law;

63 [(26)] (25) "Special district", any school district, water district, fire protection district, 64 hospital district, health center, nursing district, or other districts with taxing authority, or other 65 district formed pursuant to the laws of Missouri to provide limited, specific services;

66 [(27)] (26) "Special election", elections called by any school district, water district, fire 67 protection district, or other district formed pursuant to the laws of Missouri to provide limited, 68 specific services; and

69 [(28)] (27) "Voting district", the one or more precincts within which all voters vote at 70 a single polling place for any election.

115.031. Each election commissioner shall be a registered voter and a resident of the jurisdiction for which he is appointed [for at least one year preceding his appointment]. During his term of office, no commissioner shall hold any statutory position within a political party or on a political committee, be a candidate for political office or hold any other public office.

115.045. Each election authority shall have the authority to employ such attorneys and other employees as may be necessary to promptly and correctly perform the duties of the election 2 3 authority. Where an electronic voting system or voting machines are used, the election authority 4 shall designate competent employees to have custody of and supervise maintenance of the voting 5 equipment. Board of election commissioners' employees shall be subject to the same restrictions and subscribe the same oath as members of the board of election commissioners, except that no 6 7 employee of a board of election commissioners shall be required to post bond or reside and be a registered voter within the jurisdiction of the election authority unless directed to do so 8 9 by the board. Employee oaths and any bonds shall be filed and preserved in the office of the board. 10

115.051. 1. In each county which does not have a board of election commissioners, the county clerk shall have the right to employ such deputies and assistants as are necessary to promptly and correctly register voters and conduct elections. Where an electronic voting system or voting machines are used, the county clerk shall designate competent employees to have custody of and supervise maintenance of the voting equipment. Each deputy shall be subject to the same restrictions and subscribe the same oath as the county clerk, except that no employee shall be required to post bond **or reside and be a registered voter within the jurisdiction of**

8 the election authority unless directed to do so by the clerk. Employee oaths and any bonds shall
9 be filed and preserved in the office of the county clerk.

10 2. Within the total amount for deputies and assistants approved by the county 11 commission, the salary of each deputy and assistant shall be set by the county clerk.

115.081. 1. Each election authority shall appoint election judges for each polling placewithin its jurisdiction in accordance with the provisions of this section.

3 2. In all primary and general elections, the election authority shall appoint at least two 4 judges from each major political party to serve at each polling place. The committee of each major political party within the jurisdiction of an election authority is authorized to 5 6 provide the election authority with a list of election judge candidates who meet the 7 requirements under section 115.085. The candidates shall not be required to reside within 8 the jurisdiction of the election authority, as authorized under section 115.085. If a 9 committee of a major political party within the jurisdiction of an election authority fails 10 to provide the prescribed number of qualified names to fill all election judge positions 11 before the date established by the election authority, the election authority may select 12 judges to fill the positions as provided by law. If the election authority determines that a name submitted by a committee of a major political party is not qualified to serve as an 13 14 election judge, the election authority shall allow the party to submit another name before 15 filling the position as provided by law. No major political party shall have a majority of the 16 judges at any polling place. No established party shall have a greater number of judges at any 17 polling place than any major political party.

18 3. In any election that is not a primary or general election, the election authority shall 19 appoint at least one judge from each major political party to serve at each polling place. No 20 major political party shall have a majority of the judges at any polling place. No established 21 party shall have a greater number of judges at any polling place than any major political party. 22 4. The election authority shall designate two of the judges appointed for each polling 23 place, one from each major political party, as supervisory judges. Supervisory judges shall be 24 responsible for the return of election supplies from the polling place to the election authority and 25 shall have any additional duties prescribed by the election authority.

5. Election judges may be employed to serve for the first half or last half of any election day. Such judges shall be paid one-half the regular rate of pay. If part-time judges are employed, the election authority shall employ such judges and shall see that a sufficient number for each period are present at all times so as to have the proper total number of judges present at each polling place throughout each election day. The election authority shall require that at each polling place at least one election judge from each political party serve a full day and that at all times during the day there be an equal number of election judges from each political party. 6. An election authority may appoint additional election judges representing other established political parties and additional election judges who do not claim a political affiliation. Any question which requires a decision by the majority of judges shall only be made by the judges from the major political parties.

115.085. No person shall be appointed to serve as an election judge who is not a registered voter in this state[; provided that, before any election authority may appoint judges 2 who are registered voters of another election authority's jurisdiction, the election authority shall 3 4 obtain the written consent of the election authority for the jurisdiction where the prospective judges are registered to vote]. Each election judge shall be a person of good repute and character 5 who can speak, read, and write the English language. No person shall serve as an election judge 6 7 at any polling place in which his or her name or the name of a relative within the second degree, 8 by consanguinity or affinity, appears on the ballot. However, no relative of any unopposed 9 candidate shall be disqualified from serving as an election judge in any election jurisdiction of 10 the state. No election judge shall, during his or her term of office, hold any other elective public office, other than as a member of a political party committee or township office, except any 11 12 person who is elected to a board or commission of a political subdivision or special district may 13 serve as an election judge except at a polling place where such political subdivision or special 14 district has an issue or candidate on the ballot. In any county having a population of less than 15 two hundred fifty thousand inhabitants, any candidate for the county committee of a political 16 party who is not a candidate for any other office and who is unopposed for election as a member 17 of the committee shall not be disqualified from serving as an election judge.

115.107. 1. At every election, the chairman of the county committee of each political party named on the ballot shall have the right to designate a watcher for each place votes are counted. The candidates shall not be required to reside within the jurisdiction of the election authority. If the election authority determines that a name submitted by a committee of a major political party is not qualified to serve as poll watcher, the election authority shall allow the party to submit another name.

- 7 2. Watchers are to observe the counting of the votes and present any complaint of 8 irregularity or law violation to the election judges, or to the election authority if not satisfied with 9 the decision of the election judges. No watcher may be substituted for another on election day.
- 10

3. No watcher shall report to anyone the name of any person who has or has not voted.

4. A watcher may remain present until all closing certification forms are completed, all equipment is closed and taken down, the transportation case for the ballots is sealed, election materials are returned to the election authority or to the designated collection place for a polling place, and any other duties or procedures required under sections 115.447 to 115.491 are

15 completed. A watcher may also remain present at each location at which absentee ballots are 16 counted and may remain present while such ballots are being prepared for counting and counted.

17 5. All persons selected as watchers shall have the same qualifications required by section 18 115.085 for election judges, except that such watcher shall be a registered voter in the 19 jurisdiction of the election authority for which the watcher is designated as a watcher].

20

6. A candidate may select his or her own watchers at his or her own expense, 21 provided that the watchers meet the other requirements of this section.

115.151. 1. Each qualified applicant who appears before the election authority shall be deemed registered as of the time the applicant's completed, signed and sworn registration 2 3 application is witnessed by the election authority or deputy registration official.

4 2. Each applicant who registers by mail shall be deemed to be registered as of the date 5 the application is postmarked, if such application is accepted and not rejected by the election authority and the verification notice required pursuant to section 115.155 is not returned as 6 7 undeliverable by the postal service.

8 3. Each applicant who registers at a voter registration agency or the division of motor 9 vehicle and drivers licensing of the department of revenue shall be deemed to be registered as 10 of the date the application is signed by the applicant, if such application is accepted and not 11 rejected by the election authority and the verification notice required pursuant to section 115.155 12 is not returned as undeliverable by the postal service. Voter registration agencies [and the division of motor vehicle and drivers licensing of the department of revenue] shall transmit voter 13 14 registration application forms to the appropriate election authority not later than five business 15 days after the form is completed by the applicant. The division of motor vehicle and drivers 16 licensing of the department of revenue shall transmit voter registration application forms 17 to the appropriate election authority not later than three business days after the form is 18 completed by the applicant.

115.157. 1. The election authority may place all information on any registration cards in computerized form in accordance with section 115.158. No election authority or secretary of 2 3 state shall furnish to any member of the public electronic media or printout showing any 4 registration information, except as provided in this section. Except as provided in subsection 2 5 of this section, the election authority or secretary of state shall make available electronic media or printouts showing only unique voter identification numbers, voters' names, [dates of birth,] 6 7 addresses, townships or wards, and precincts. Electronic data shall be maintained in at least the 8 following separate fields:

- 9 (1) Voter identification number;
- 10 (2) First name;
- 11 (3) Middle initial;

28	2. All election authorities shall

2. All election authorities shall enter voter history in their computerized registration 29 systems and shall, not more than six months after the election, forward such data to the Missouri 30 voter registration system established in section 115.158. In addition, election authorities shall 31 forward registration and other data in a manner prescribed by the secretary of state to comply 32 with the Help America Vote Act of 2002.

33 3. Except as provided in subsection 6 of this section, the election authority shall furnish, 34 for a fee, electronic media or a printout showing **only** the names[, dates of birth] and addresses 35 of voters, or any part thereof, within the jurisdiction of the election authority who voted in any 36 specific election, including primary elections, by township, ward or precinct, provided that 37 nothing in this chapter shall require such voter information to be released to the public over the 38 internet **and shall not be used for commercial purposes**.

39 4. [Except as provided in subsection 6 of this section, upon a request by a candidate, a 40 duly authorized representative of a campaign committee, or a political party committee, the 41 secretary of state shall furnish, for a fee determined by the secretary of state and in compliance 42 with section 610.026, media in an electronic format or, if so requested, in a printed format, 43 showing the names, addresses, and voter identification numbers of voters within the jurisdiction 44 of a specific election authority who applied for an absentee ballot under section 115.279 for any specific election involving a ballot measure or an office for which the declaration of candidacy 45 is required to be filed with the secretary of state pursuant to section 115.353, including primary 46 elections, by township, ward, or precinct. Nothing in this section shall require such voter 47

48 information to be released to the public over the internet. For purposes of this section, the terms

49 "candidate", "campaign committee", and "political party committee" shall have the same 50 meaning given to such terms in section 130.011.

51 The amount of fees charged for information provided in this section shall be 52 established pursuant to chapter 610. All revenues collected by the secretary of state pursuant to 53 this section shall be deposited in the state treasury and credited to the secretary of state's 54 technology trust fund account established pursuant to section 28.160. [In even-numbered years, 55 each election authority shall, upon request, supply the voter registration list for its jurisdiction 56 to all candidates and party committees for a charge established pursuant to chapter 610. Except 57 as provided in subsection 6 of this section, all election authorities shall make the information 58 described in this section available pursuant to chapter 610. Any election authority who fails to 59 comply with the requirements of this section shall be subject to the provisions of chapter 610.]

60 [6-] 5. Any person working as an undercover officer of a local, state or federal law 61 enforcement agency, persons in witness protection programs, and victims of domestic violence 62 and abuse who have received orders of protection pursuant to chapter 455 shall be entitled to 63 apply to the circuit court having jurisdiction in his or her county of residence to have the 64 residential address on his or her voter registration records closed to the public if the release of 65 such information could endanger the safety of the person. Any person working as an undercover 66 agent or in a witness protection program shall also submit a statement from the chief executive officer of the agency under whose direction he or she is serving. The petition to close the 67 68 residential address shall be incorporated into any petition for protective order provided by circuit 69 clerks pursuant to chapter 455. If satisfied that the person filing the petition meets the 70 qualifications of this subsection, the circuit court shall issue an order to the election authority to 71 keep the residential address of the voter a closed record and the address may be used only for the 72 purposes of administering elections pursuant to this chapter. The election authority may require 73 the voter who has a closed residential address record to verify that his or her residential address 74 has not changed or to file a change of address and to affirm that the reasons contained in the 75 original petition are still accurate prior to receiving a ballot. A change of address within an 76 election authority's jurisdiction shall not require that the voter file a new petition. Any voter who 77 no longer qualifies pursuant to this subsection to have his or her residential address as a closed 78 record shall notify the circuit court. Upon such notification, the circuit court shall void the order 79 closing the residential address and so notify the election authority.

115.160. 1. All Missouri driver's license applicants shall receive a voter registration
application form as a simultaneous part of the application for a driver's license, renewal of
driver's license, change of address, duplicate request and a nondriver's license.

4 2. If a single application form is used, the voter registration application portion of any 5 application described in subsection 1 of this section may not require any information that duplicates information required in the driver's license portion of the form, except a second 6 7 signature or other information required by law.

8 After conferring with the secretary of state as the chief state election official 3. responsible for overseeing of the voter registration process, the director of revenue shall adopt 9 rules and regulations pertaining to the format of the voter registration application used by the 10 11 department. The director of revenue shall utilize electronic voter registration application 12 forms and provide for secure electronic transfer of voter registration information to election authorities. The secretary of state and the director of revenue shall ensure the 13 14 confidentiality and integrity of the voter registration data collected, maintained, received, 15 or transmitted under this section.

16 4. No information relating to the failure of an applicant for a driver's license or 17 nondriver's license to sign a voter registration application may be used for any purpose other than 18 voter registration.

19 5. Any voter registration application received pursuant to the provisions of this section 20 shall be forwarded, in a secure and electronic manner, to the election authority located within 21 that county or any city not within a county, or if there is more than one election authority within 22 the county, then to the election authority located nearest to the location where the driver's license 23 application was received. Voter registration information, including an electronic image of 24 the signature of the applicant, shall be transmitted in a format compatible with the 25 Missouri voter registration system established in section 115.158 which allows for review 26 by the election authority and does not require the election authority to manually reenter 27 The election authority receiving the application forms shall review the the information. 28 applications and forward, in a secure and electronic manner, any applications pertaining to a 29 different election authority to that election authority.

30 6. A completed voter registration application accepted in the driver's licensing process 31 shall be transmitted to the election authority described in subsection 5 of this section not later 32 than five business days after the form is completed by the applicant.

33 7. Any person registering to vote when applying for or renewing a Missouri driver's 34 license shall submit with the application form a copy of a birth certificate, a Native American 35 tribal document, or other proof of United States citizenship, a valid Missouri driver's license, or 36 other form of personal identification.

115.205. 1. [Any] No person [who is] shall be paid or otherwise compensated for 2 soliciting [more than ten] voter registration applications, other than a governmental entity or a 3 person who is paid or compensated by a governmental entity for such solicitation[, shall be

5 6 registered with the secretary of state as a voter registration solicitor. A voter registration

solicitor who solicits more than ten voter registration applications shall register for every

election cycle that begins on the day after the general election and ends on the day of the general

election two years later. A voter registration solicitor shall be at least eighteen years of age and 7 shall be a registered voter in the state of Missouri. 8 9 2. Each voter registration solicitor shall provide the following information in writing to 10 the secretary of state's office: 11 (1) The name of the voter registration solicitor; 12 (2) The residential address, including street number, city, state, and zip code; 13 (3) The mailing address, if different from the residential address; and 14 (4) [Whether the voter registration solicitor expects to be paid for soliciting voter 15 registrations; 16 (5) If the voter registration solicitor expects to be paid, the identity of the payor; or 17 (6) The signature of the voter registration solicitor. 18 3. The solicitor information required in subsection 2 of this section shall be submitted to the secretary of state's office with the following oath and affirmation: "I HEREBY SWEAR 19 20 OR AFFIRM UNDER PENALTY OF PERJURY THAT ALL STATEMENTS MADE BY ME 21 ARE TRUE AND CORRECT.". 22 4. Any voter registration solicitor who knowingly fails to register with the secretary of 23 state is guilty of a class three election offense. Voter registration applications shall be accepted 24 by the election authority if such applications are otherwise valid, even if the voter registration 25 solicitor who procured the applications fails to register with or submits false information to the 26 secretary of state. 115.225. 1. Before use by election authorities in this state, the secretary of state shall 2 approve the marking devices and the automatic tabulating equipment used in electronic voting 3 systems and may promulgate rules and regulations to implement the intent of sections 115.225 4 to 115.235. 5 2. No electronic voting system shall be approved unless it: 6 (1) Permits voting in absolute secrecy; 7 (2) Permits each voter to vote for as many candidates for each office as a voter is 8 lawfully entitled to vote for; 9 (3) Permits each voter to vote for or against as many questions as a voter is lawfully 10 entitled to vote on. and no more: 11 (4) Provides facilities for each voter to cast as many write-in votes for each office as a 12 voter is lawfully entitled to cast;

13 (5) Permits each voter in a primary election to vote for the candidates of only one party14 announced by the voter in advance;

15 (6) Permits each voter at a presidential election to vote by use of a single mark for the 16 candidates of one party or group of petitioners for president, vice president and their presidential 17 electors;

18 (7) Accurately counts all proper votes cast for each candidate and for and against each19 question;

20 (8) Is set to reject all votes, except write-in votes, for any office and on any question 21 when the number of votes exceeds the number a voter is lawfully entitled to cast;

22

(9) Permits each voter, while voting, to clearly see the ballot label;

(10) Has been tested and is certified by an independent authority that meets the voting
system standards developed by the Federal Election Commission or its successor agency. The
provisions of this subdivision shall not be required for any system purchased prior to August 28,
2002.

3. The secretary of state shall promulgate rules and regulations to allow the use of a computerized voting system. The procedures shall provide for the use of a computerized voting system with the ability to provide a paper audit trail. Notwithstanding any provisions of this chapter to the contrary, such a system may allow for the storage of processed ballot materials in an electronic form.

4. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2002, shall be invalid and void.

39 5. If any election authority uses any touchscreen, direct-recording, electronic 40 vote-counting machine, the election authority may continue to use such machine. Upon the removal of such voting machine from the election authority's inventory because of 41 42 mechanical malfunction, wear and tear, or any other reason, the machine shall not be 43 replaced and no additional direct-recording electronic voting machine shall be added to 44 the election authority's inventory. Such machines shall not be used beginning January 1, 45 2022, except that election authorities may allow the machines to be used by voters who are 46 disabled as long as the machines are functional. Replacement of equipment for use by 47 voters who are disabled shall be with paper ballot marking devices designed to assist 48 voters.

6. Election authorities shall be members of the Center for Internet Security (CIS) and shall allow cyber security review of their office by the secretary of state. If an election authority denies access for cyber security review, the secretary of state may publicize a notice of noncompliance in a newspaper within the jurisdiction of the election authority or in electronic format. The secretary of state is also authorized to withhold funds from an election authority in violation of this section unless such funding is a federal mandate or part of a federal and state agreement.

7. The secretary of state shall have authority to require cyber security testing, including penetration testing, of vendor machines, programs, and systems. Failure to participate in such testing shall result in a revocation of vendor certification. Upon notice from another jurisdiction of cyber security failures or certification withholds or revocation, the secretary of state shall have authority to revoke or withhold certification for vendors. The requirements of this section shall be subject to appropriation for the purpose of cyber security testing.

115.237. 1. Each ballot printed or designed for use with an electronic voting system for 2 any election pursuant to this chapter shall contain all questions and the names of all offices and 3 candidates certified or filed pursuant to this chapter and no other. Beginning January 1, 2022, the official ballot shall be a paper ballot that is hand-marked by the voter, or in the case 4 5 of voters with disabilities who need assistance, by a paper ballot marking device designed to assist voters, except as provided in subsection 5 of section 115.225. As far as practicable, 6 7 all questions and the names of all offices and candidates for which each voter is entitled to vote 8 shall be printed on one page except for the ballot for political party committee persons in polling 9 places not utilizing an electronic voting system which may be printed separately and in 10 conformity with the requirements contained in this section. As far as practicable, ballots containing only questions and the names of nonpartisan offices and candidates shall be printed 11 12 in accordance with the provisions of this section, except that the ballot information may be listed 13 in vertical or horizontal rows. The names of candidates for each office shall be listed in the order 14 in which they are filed.

15 2. In polling places using electronic voting systems, the ballot information may be 16 arranged in vertical or horizontal rows or on a number of separate pages or screens. In any event, 17 the name of each candidate, the candidate's party, the office for which he or she is a candidate, 18 and each question shall be indicated clearly on the ballot.

3. Nothing in this subchapter shall be construed as prohibiting the use of a separate paper
 ballot for questions or for the presidential preference primary in any polling place using an
 electronic voting system.

22 4. Where electronic voting systems are used and when write-in votes are authorized by 23 law, a write-in ballot, which may be in the form of a separate paper ballot, card, or envelope, may 24 be provided by the election authority to permit each voter to write in the names of persons whose 25 names do not appear on the ballot.

26 5. No ballot printed or designed for use with an electronic voting system for any partisan 27 election held under this chapter shall allow a person to vote a straight political party ticket. For 28 purposes of this subsection, a "straight political party ticket" means voting for all of the 29 candidates for elective office who are on the ballot representing a single political party by a 30 single selection on the ballot.

31 6. The secretary of state shall promulgate rules that specify uniform standards for ballot 32 layout for each electronic or computerized ballot counting system approved under the provisions 33 of section 115.225 so that the ballot used with any counting system is, where possible, consistent 34 with the intent of this section. Nothing in this section shall be construed to require the format 35 specified in this section if it does not meet the requirements of the ballot counting system used 36 by the election authority.

37 7. Any rule or portion of a rule, as that term is defined in section 536.010, that is created 38 under the authority delegated in this section shall become effective only if it complies with and 39 is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section 40 and chapter 536 are nonseverable and if any of the powers vested with the general assembly 41 pursuant to chapter 536 to review, to delay the effective date or to disapprove and annul a rule 42 are subsequently held unconstitutional, then the grant of rulemaking authority and any rule 43 proposed or adopted after August 28, 2002, shall be invalid and void.

115.257. 1. In jurisdictions where electronic voting machines are used, the election authority shall cause the voting machines to be put in order, set, adjusted and made ready for 2 3 voting before they are delivered to polling places.

4 2. At least five days before preparing electronic voting machines for any election, notice of the time and place of such preparation shall be mailed to each independent candidate and the 5 chairman of the county committee of each established political party named on the ballot. The 6 7 preparation shall be watched by two observers designated by the election authority, one from 8 each major political party, and shall be open to representatives of the political parties, candidates, 9 the news media and the public.

10 3. When an electronic voting machine has been examined by such observers and shown 11 to be in good working order, the machine shall be locked against voting. The observers shall 12 certify the vote count on each machine is set at zero.

13 4. After an electronic voting machine has been properly prepared and locked, its keys 14 shall be retained by the election authority and delivered to the election judges along with the 15 other election supplies.

16 5. For the purpose of processing absentee ballots, cast by voters in person in the office 17 of the election authority that is deemed a designated polling place, the election authority [may] shall cause voting machines, if used, to be put in order, set, adjusted, tested, and made ready for 18 19 voting within one business day of the printing of absentee ballots as provided in section 115.281. 20 The election authority shall have the recording counter except for the protective counter on the 21 voting machine set to zero (000). After the voting machines have been made ready for voting, 22 the election authority shall not permit any person to handle any voting machine, except voters 23 while they are voting and others expressly authorized by the election authority. The election 24 authority shall neither be nor permit any other person to be in any position or near any position 25 that enables the authority or person to see how any absentee voter votes or has voted.

26 6. Nothing in this section shall prohibit the on-site storage of electronic voting machines 27 and the preparation of the electronic machines for voting, provided the electronic voting 28 machines are put in order, set, adjusted and made ready for voting as provided in subsections 1, 29 2, 3, 4, and 5 of this section.

115.275. As used in sections 115.275 to 115.304, unless the context clearly indicates 2 otherwise, the following terms shall mean:

Beginning on the third Tuesday before the date of the election, except as provided in subsections 2, 3, 4, and 5 of this section, any registered voter of this state may cast an absentee ballot in person at a location designated by the election authority for all candidates and issues for which such voter is eligible to vote at the polling place without

providing a reason for the need to vote absentee. Any registered voter casting a ballot
under the provisions of this subdivision shall provide photo identification.

7 2. A 37 federal postcard application submitted by a covered voter pursuant to this subsection shall also 38 serve as a voter registration application under section 115.908 and the election authority shall, 39 if satisfied that the applicant is entitled to register, place the voter's name on the voter registration 40 file. Each covered voter may vote by absentee ballot or, upon submitting an affidavit that the 41 person is qualified to vote in the election, may vote at the person's polling place.

Any intrastate new resident may vote by absentee ballot at the election for 45 presidential and vice presidential electors, United States senator, representative in Congress, 46 statewide elected officials and statewide questions, propositions and amendments from such 47 resident's new jurisdiction of residence after registering to vote in such resident's new jurisdiction 48 of residence.

49 [5.] 6. Any new resident may vote by absentee ballot for presidential and vice 50 presidential electors after registering to vote in such resident's new jurisdiction of residence.

51 7. The provisions of this section authorizing the casting of absentee ballots without 52 stating a reason and requiring the use photographic identification are essentially connected 53 and if any of the photographic identification requirements under this section, or other 54 general law requiring the use of photographic identification in order to cast an absentee 55 ballot, are held unconstitutional, or otherwise made ineffective, then subsection 1 of this 56 section and all other general laws or rules enabling the casting of absentee ballots without 57 stating a reason shall be null and void.

The election authority shall accept applications by facsimile transmission and by electronic mail within the limits of its telecommunications capacity.

5 2. Each application shall be made to the election authority of the jurisdiction in which 6 the person is or would be registered. Each application shall be in writing and shall state the 7 applicant's name, address at which he or she is or would be registered, his or her reason for 8 voting an absentee ballot, **if casting an absentee ballot under subsection 2 of section 115.277**,

Any rule or portion of a rule, as that term is defined in section 536.010, that is 192 created under the authority delegated in this section shall become effective only if it complies 193 with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. 194 This section and chapter 536 are nonseverable and if any of the powers vested with the general 195 assembly pursuant to chapter 536 to review, to delay the effective date or to disapprove and 196 annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and 197 any rule proposed or adopted after August 28, 2002, shall be invalid and void.

198 [11.] 10. If any voter is unable to sign his name at the appropriate place on the certificate 199 or computer printout, an election judge shall print the name and address of the voter in the 200 appropriate place on the precinct register, the voter shall make his mark in lieu of signature, and 201 the voter's mark shall be witnessed by the signature of an election judge.

This section shall become effective only upon the passage and approval by the voters 203 of a constitutional amendment submitted to them by the general assembly regarding the 204 authorization of photo identification requirements for elections by general law.
