AN ACT

To repeal section 115.306, RSMo, and to enact in lieu thereof one new section relating to qualifications for elective public office.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 115.306, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 115.306, to read as follows:

115.306. 1. No person shall qualify as a candidate for elective public office in the state of Missouri who has been found guilty of or pled guilty to a felony under the federal laws of the United States of America or to a felony under the laws of this state or an offense committed in another state that would be considered a felony in this state **unless ten years have passed from the date of plea or conviction.**

2. (1) Any person who files as a candidate for election to a public office shall be disqualified from participation in the election for which the candidate has filed if such person is delinquent in the payment of any state income taxes, personal property taxes, municipal taxes, real property taxes on the place of residence, as stated on the declaration of candidacy, or if the person is a past or present corporate officer of any fee office that owes any taxes to the state.

(2) Each potential candidate for election to a public office, except candidates for a county or city committee of a political party, shall file an affidavit with the department of revenue and include a copy of the affidavit with the declaration of candidacy required under section 115.349. Such affidavit shall be in substantially the following form:

16 AFFIRMATION OF TAX PAYMENTS AND BONDING REQUIREMENTS:

17 I hereby declare under penalties of perjury that I am not currently aware of any
18 delinquency in the filing or payment of any state income taxes, personal property taxes,
19 municipal taxes, real property taxes on the place of residence, as stated on the declaration of
20 candidacy, or that I am a past or present corporate officer of any fee office that owes any taxes
21 to the state, other than those taxes which may be in dispute. I declare under penalties of perjury
22 that I am not aware of any information that would prohibit me from fulfilling any bonding
23 requirements for the office for which I am filing.

27 (3) Upon receipt of a complaint alleging a delinquency of the candidate in the filing or
28 payment of any state income taxes, personal property taxes, municipal taxes, real property taxes
29 on the place of residence, as stated on the declaration of candidacy, or if the person is a past or
30 present corporate officer of any fee office that owes any taxes to the state, the department of
31 revenue shall investigate such potential candidate to verify the claim contained in the complaint.
32 If the department of revenue finds a positive affirmation to be false, the department shall contact
33 the secretary of state, or the election official who accepted such candidate's declaration of
34 candidacy, and the potential candidate. The department shall notify the candidate of the
35 outstanding tax owed and give the candidate thirty days to remit any such outstanding taxes owed
36 which are not the subject of dispute between the department and the candidate. If the candidate
37 fails to remit such amounts in full within thirty days, the candidate shall be disqualified from
38 participating in the current election and barred from refiling for an entire election cycle even if
39 the individual pays all of the outstanding taxes that were the subject of the complaint.
