## AN ACT

To repeal sections 37.850, 67.2800, 67.2810, 67.2815, 361.097, 361.110, 361.727, 362.023, 362.044, 362.165, 362.247, 362.250, 362.340, 362.550, 362.570, 365.100, 365.140, 367.150, 369.049, 400.3-309, 408.035, 408.100, 408.140, 408.178, 408.233, 408.234, 408.250, 408.553, and 408.554, RSMo, and to enact in lieu thereof forty-eight new sections relating to financial institutions.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 37.850, 67.2800, 67.2810, 67.2815, 361.097, 361.110, 361.727, 362.023, 362.044, 362.165, 362.247, 362.250, 362.340, 362.550, 362.570, 365.100, 365.140, 367.150, 369.049, 400.3-309, 408.035, 408.100, 408.140, 408.178, 408.233, 408.234, 408.250, 408.553, and 408.554, RSMo, are repealed and forty-eight new sections enacted in lieu thereof, to be known as sections 29.420, 37.850, 67.2800, 67.2810, 67.2815, 67.2816, 67.2817, 67.2818, 67.2819, 67.2840, 285.1000, 285.1005, 285.1010, 285.1015, 285.1020, 285.1025, 285.1030, 285.1035, 285.1040, 285.1045, 285.1050, 285.1055, 361.097, 361.110, 361.727, 362.023, 362.044, 362.165, 362.247, 362.250, 362.340, 362.550, 362.570, 362.765, 365.100, 365.140, 369.049, 369.705, 400.3-309, 408.035, 408.100, 408.140, 408.178, 408.233, 408.234, 408.250, 408.553, and 408.554, to read as follows:

**29.420. 1. This section shall be known as the "Government Lending Transparency Act".**

**2. As used in this section, the following terms shall mean:**

**(1) "Administering agency", a department, office, board, commission, bureau, institution, or any other agency of the state charged by statute, regulation, or order with administering a credit support or lending program;**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

7           **(2) "Credit support program", any state program that guarantees or provides**  
8 **credit enhancements, such as state support for interest or principal payments, to the debt**  
9 **of parties or to other branches of government or municipalities, under which the state**  
10 **would be required to provide moneys if the borrower failed to pay;**

11           **(3) "Lending program", any state program that offers moneys to private parties**  
12 **or municipalities that come with the expectation of repayment.**

13           **3. Each administering agency shall report annually to the state auditor before**  
14 **August thirty-first the following information:**

15           **(1) The name and statutory authority for each lending program and credit support**  
16 **program administered by the agency;**

17           **(2) For the immediately preceding fiscal year, the total dollar amount of all lending**  
18 **for each lending program administered by the agency and the total amount of debt**  
19 **supported by each credit support program administered by the agency; and**

20           **(3) For the immediately preceding fiscal year, the reasonable estimates of the costs**  
21 **of likely defaults for each lending program and credit support program administered by**  
22 **the agency, using private sector accounting standards to evaluate the likelihood and costs**  
23 **of defaults.**

24           **4. The state auditor shall make an annual report compiling the data received from**  
25 **the administering agencies under this section and shall submit the report to the general**  
26 **assembly annually before December sixteenth.**

27           **5. Intentional or knowing failure to comply with any reporting requirement**  
28 **contained in this section shall be punishable by a fine of up to two thousand dollars.**

37.850. 1. The commissioner of administration shall maintain the Missouri  
2 accountability portal established in executive order 07-24 as a free, internet-based tool allowing  
3 citizens to demand fiscal discipline and responsibility.

4           2. The Missouri accountability portal shall consist of an easy-to-search database of  
5 financial transactions related to the purchase of goods and services and the distribution of funds  
6 for state programs; all bonds issued by any public institution of higher education or political  
7 subdivision of this state or its designated authority after August 28, 2013; all obligations issued  
8 or incurred pursuant to section 99.820 by any political subdivision of this state or its designated  
9 authority; and the revenue stream pledged to repay such bonds or obligations; and all debt  
10 incurred by any public charter school.

11           3. The Missouri accountability portal shall be updated each state business day and  
12 maintained as the primary source of information about the activity of Missouri's government.

13           4. Upon the conducting of a withholding or a release of funds, the governor shall submit  
14 a report stating all amounts withheld from the state's operating budget for the current fiscal year,  
15 as authorized by Article IV, Section 27 of the Missouri Constitution which shall be:

- 16           (1) Conspicuously posted on the accountability portal website;  
17           (2) Searchable by the amounts withheld or released from each individual fund; and  
18           (3) Searchable by the total amount withheld or released from the operating budget.

19           5. Every political subdivision of the state, including public institutions of higher  
20 education but excluding school districts, shall supply all information described in subsection 2  
21 of this section to the office of administration within seven days of issuing or incurring such  
22 corresponding bond or obligation. For all such bonds or obligations issued or incurred prior to  
23 August 28, 2013, every such political subdivision and public institution of higher education shall  
24 have ninety days to supply such information to the office of administration.

25           6. Every school district and public charter school shall supply all information described  
26 in subsection 2 of this section to the department of elementary and secondary education within  
27 seven days of issuing such bond, or incurring such debt. The department of elementary and  
28 secondary education shall have forty-eight hours to deliver such information to the office of  
29 administration. For all such bonds issued or debt incurred prior to August 28, 2013, every school  
30 district and public charter school shall have ninety days to supply such information to the  
31 department of elementary and secondary education. The department of elementary and  
32 secondary education shall have forty-eight hours to deliver such information to the office of  
33 administration.

34           **7. The following entities shall report the name, salary data, and incentive pay for**  
35 **all employees of the entity in the same manner as all state departments and agencies under**  
36 **this section:**

37           **(1) The county employees' retirement system established in sections 50.1000 to**  
38 **50.1300;**

39           **(2) The sheriffs' retirement system established in sections 57.949 to 57.997;**

40           **(3) The Missouri local government employees' retirement system established in**  
41 **sections 70.600 to 70.755;**

42           **(4) The Missouri state employees' retirement system established in section 104.320;**

43           **(5) The Missouri department of transportation and highway patrol employees'**  
44 **retirement system established in section 104.020;**

45           **(6) The prosecuting attorneys' and circuit attorneys' retirement system established**  
46 **in sections 56.800 to 56.840;**

47           **(7) The college and university retirement plan established in sections 104.1200 to**  
48 **104.1215;**

49           **(8) The Kansas City public school retirement system established in sections 169.270**  
50 **to 169.400;**

51           **(9) The Kansas City civilian police retirement system established in sections 86.1310**  
52 **to 86.1640;**

53           **(10) The Kansas City police retirement system established in sections 86.900 to**  
54 **86.1280;**

55           **(11) The public education employees' retirement system established in sections**  
56 **169.600 to 169.710;**

57           **(12) The public school retirement system established in sections 169.010 to 169.130;**

58           **(13) The St. Louis public school retirement system established in sections 169.410**  
59 **to 169.540;**

60           **(14) The St. Louis firemen's retirement system established in sections 87.125 to**  
61 **87.370;**

62           **(15) The St. Louis police retirement system established in sections 86.200 to 86.366;**  
63 **and**

64           **(16) The judicial retirement system established in sections 476.450 to 476.690.**

65

66 **The entities identified in this subsection shall not report the retirement annuity, retirement**  
67 **allowance, or retirement benefit amount of any employee or member to the Missouri**  
68 **accountability portal. The commissioner of administration shall prohibit the display of the**  
69 **retirement annuity, retirement allowance, or retirement benefit of any employee or**  
70 **member on the Missouri accountability portal.**

67.2800. 1. Sections 67.2800 to ~~[67.2835]~~ **67.2840** shall be known and may be cited as  
2 the "Property Assessment Clean Energy Act".

3           2. As used in sections 67.2800 to ~~[67.2835]~~ **67.2840**, the following words and terms  
4 shall mean:

5           (1) "Assessment contract", a contract entered into between a clean energy development  
6 board and a property owner under which the property owner agrees to pay an annual assessment  
7 for a period of up to twenty years **not to exceed the weighted average useful life of the**  
8 **qualified improvements** in exchange for financing of an energy efficiency improvement or a  
9 renewable energy improvement;

10           (2) "Authority", the state environmental improvement and energy resources authority  
11 established under section 260.010;

12           (3) "Bond", any bond, note, or similar instrument issued by or on behalf of a clean  
13 energy development board;

14 (4) "Clean energy conduit financing", the financing of energy efficiency improvements  
15 or renewable energy improvements for a single parcel of property or a unified development  
16 consisting of multiple adjoining parcels of property under section 67.2825;

17 (5) "Clean energy development board", a board formed by one or more municipalities  
18 under section 67.2810;

19 (6) **"Director", the director of the division of finance within the department of**  
20 **commerce and insurance;**

21 (7) **"Division", the division of finance within the department of commerce and**  
22 **insurance;**

23 (8) "Energy efficiency improvement", any acquisition, installation, or modification on  
24 or of publicly or privately owned property designed to reduce the energy consumption of such  
25 property, including but not limited to:

26 (a) Insulation in walls, roofs, attics, floors, foundations, and heating and cooling  
27 distribution systems;

28 (b) Storm windows and doors, multiglazed windows and doors, heat-absorbing or heat-  
29 reflective windows and doors, and other window and door improvements designed to reduce  
30 energy consumption;

31 (c) Automatic energy control systems;

32 (d) Heating, ventilating, or air conditioning distribution system modifications and  
33 replacements;

34 (e) Caulking and weatherstripping;

35 (f) Replacement or modification of lighting fixtures to increase energy efficiency of the  
36 lighting system without increasing the overall illumination of the building unless the increase in  
37 illumination is necessary to conform to applicable state or local building codes;

38 (g) Energy recovery systems; and

39 (h) Daylighting systems;

40 ~~[(7)]~~ (9) "Municipality", any county, city, or incorporated town or village of this state;

41 ~~[(8)]~~ (10) **"Program administrator", an individual or entity selected by the clean**  
42 **energy development board to administer the PACE program, but this term does not**  
43 **include an employee of a county or municipal government assigned to a clean energy**  
44 **development board or a public employee employed by a clean energy development board**  
45 **who is paid from appropriated general tax revenues;**

46 (11) "Project", any energy efficiency improvement or renewable energy improvement;

47 ~~[(9)]~~ (12) "Property assessed clean energy local finance fund", a fund that may be  
48 established by the authority for the purpose of making loans to clean energy development boards  
49 to establish and maintain property assessed clean energy programs;

50           ~~[(10)]~~ **(13)** "Property assessed clean energy program" or "**PACE program**", a program  
51 established by a clean energy development board to finance energy efficiency improvements or  
52 renewable energy improvements under section 67.2820;

53           ~~[(11)]~~ **(14)** "Renewable energy improvement", any acquisition and installation of a  
54 fixture, product, system, device, or combination thereof on publicly or privately owned property  
55 that produces energy from renewable resources, including, but not limited to photovoltaic  
56 systems, solar thermal systems, wind systems, biomass systems, or geothermal systems.

57           3. All projects undertaken under sections 67.2800 to ~~[67.2835]~~ **67.2840** are subject to  
58 the applicable municipality's ordinances and regulations, including but not limited to those  
59 ordinances and regulations concerning zoning, subdivision, building, fire safety, and historic or  
60 architectural review.

67.2810. 1. One or more municipalities may form clean energy development boards for  
2 the purpose of exercising the powers described in sections 67.2800 to ~~[67.2835]~~ **67.2840**. Each  
3 clean energy development board shall consist of not less than three members, as set forth in the  
4 ordinance or order establishing the clean energy development board. Members shall serve terms  
5 as set forth in the ordinance or order establishing the clean energy development board and shall  
6 be appointed:

7           (1) If only one municipality is participating in the clean energy development board, by  
8 the chief elected officer of the municipality with the consent of the governing body of the  
9 municipality; or

10           (2) If more than one municipality is participating, in a manner agreed to by all  
11 participating municipalities.

12           2. A clean energy development board shall be a political subdivision of the state and  
13 shall have all powers necessary and convenient to carry out and effectuate the provisions of  
14 sections 67.2800 to ~~[67.2835]~~ **67.2840**, including but not limited to the following:

15           (1) To adopt, amend, and repeal bylaws, which are not inconsistent with sections  
16 67.2800 to ~~[67.2835]~~ **67.2840**;

17           (2) To adopt an official seal;

18           (3) To sue and be sued;

19           (4) To make and enter into contracts and other instruments with public and private  
20 entities;

21           (5) To accept grants, guarantees, and donations of property, labor, services, and other  
22 things of value from any public or private source;

23           (6) To employ or contract for such managerial, legal, technical, clerical, accounting, or  
24 other assistance it deems advisable;

25 (7) To levy and collect special assessments under an assessment contract with a property  
26 owner and to record such special assessments as a lien on the property;

27 (8) To borrow money from any public or private source and issue bonds and provide  
28 security for the repayment of the same;

29 (9) To finance a project under an assessment contract;

30 (10) To collect reasonable fees and charges in connection with making and servicing  
31 assessment contracts and in connection with any technical, consultative, or project assistance  
32 services offered;

33 (11) To invest any funds not required for immediate disbursement in obligations of the  
34 state of Missouri or of the United States or any agency or instrumentality thereof, or in bank  
35 certificates of deposit; provided, however, the limitations on investments provided in this  
36 subdivision shall not apply to proceeds acquired from the sale of bonds which are held by a  
37 corporate trustee; and

38 (12) To take whatever actions necessary to participate in and administer a clean energy  
39 conduit financing or a property assessed clean energy program.

40 3. No later than July first of each year, the clean energy development board shall file  
41 with each municipality that participated in the formation of the clean energy development board  
42 and with the director of the department of natural resources an annual report for the preceding  
43 calendar year that includes:

44 (1) A brief description of each project financed by the clean energy development board  
45 during the preceding calendar year, which shall include the physical address of the property, the  
46 name or names of the property owner, an itemized list of the costs of the project, and the name  
47 of any contractors used to complete the project;

48 (2) The amount of assessments due and the amount collected during the preceding  
49 calendar year;

50 (3) The amount of clean energy development board administrative costs incurred during  
51 the preceding calendar year;

52 (4) The estimated cumulative energy savings resulting from all energy efficiency  
53 improvements financed during the preceding calendar year; and

54 (5) The estimated cumulative energy produced by all renewable energy improvements  
55 financed during the preceding calendar year.

56 4. No lawsuit to set aside the formation of a clean energy development board or to  
57 otherwise question the proceedings related thereto shall be brought after the expiration of sixty  
58 days from the effective date of the ordinance or order creating the clean energy development  
59 board. No lawsuit to set aside the approval of a project, an assessment contract, or a special  
60 assessment levied by a clean energy development board, or to otherwise question the proceedings

61 related thereto shall be brought after the expiration of sixty days from the date that the  
62 assessment contract is executed.

67.2815. 1. A clean energy development board shall not enter into an assessment  
2 contract or levy or collect a special assessment for a project without making a finding that there  
3 are sufficient resources to complete the project and that the estimated economic benefit expected  
4 from the project during the financing period is equal to or greater than the cost of the project.

5 2. An assessment contract shall be executed by the clean energy development board and  
6 the benefitted property owner or property owners and shall provide:

7 (1) A description of the project, including the estimated cost of the project and details  
8 on how the project will either reduce energy consumption or create energy from renewable  
9 sources;

10 (2) A mechanism for:

11 (a) Verifying the final costs of the project upon its completion; and

12 (b) Ensuring that any amounts advanced or otherwise paid by the clean energy  
13 development board toward costs of the project will not exceed the final cost of the project;

14 (3) An acknowledgment by the property owner that the property owner has received or  
15 will receive a special benefit by financing a project through the clean energy development board  
16 that equals or exceeds the total assessments due under the assessment contract;

17 (4) An agreement by the property owner to pay annual special assessments for a period  
18 not to exceed twenty years, as specified in the assessment contract;

19 (5) A statement that the obligations set forth in the assessment contract, including the  
20 obligation to pay annual special assessments, are a covenant that shall run with the land and be  
21 obligations upon future owners of such property; and

22 (6) An acknowledgment that no subdivision of property subject to the assessment  
23 contract shall be valid unless the assessment contract or an amendment thereof divides the total  
24 annual special assessment due between the newly subdivided parcels pro rata to the special  
25 benefit realized by each subdivided parcel.

26 3. The total special assessments levied against a property under an assessment contract  
27 shall not exceed the sum of the cost of the project, including any required energy audits and  
28 inspections, or portion thereof financed through the participation in a property assessed clean  
29 energy program or clean energy conduit financing, including the costs of any audits or  
30 inspections required by the clean energy development board, plus such administration fees,  
31 interest, and other financing costs reasonably required by the clean energy development board.

32 4. The clean energy development board shall provide a copy of each signed assessment  
33 contract to the local [county] assessor and [county] collector **for the county, or city not within**



34 **a county**, and shall cause a copy of such assessment contract to be recorded in the real estate  
35 records of the [county] recorder of deeds **for the county, or city not within a county.**

36 5. Special assessments agreed to under an assessment contract shall be a lien on the  
37 property against which it is assessed on behalf of the applicable clean energy development board  
38 from the date that each annual assessment under the assessment contract becomes due. Such  
39 special assessments shall be collected by the [county] collector **for the county, or city not**  
40 **within a county**, in the same manner and with the same priority as ad valorem real property  
41 taxes, **subject to the provisions of subsection 8 of this section.** Once collected, the [county]  
42 collector **for the county, or city not within a county**, shall pay over such special assessment  
43 revenues to the clean energy development board in the same manner in which revenues from ad  
44 valorem real property taxes are paid to other taxing districts. Such special assessments shall be  
45 collected as provided in this subsection from all subsequent property owners, including the state  
46 and all political subdivisions thereof, for the term of the assessment contract.

47 6. Any clean energy development board that contracts for outside administrative services  
48 to provide financing origination for a project shall offer the right of first refusal to enter into such  
49 a contract to a federally insured depository institution with a physical presence in Missouri upon  
50 the same terms and conditions as would otherwise be approved by the clean energy development  
51 board. Such right of first refusal shall not be applicable to the origination of any transaction that  
52 involves the issuance of bonds by the clean energy development board.

53 7. **Sections 67.2816, 67.2817, 67.2818, and 67.2819 shall apply only to PACE**  
54 **programs for projects to improve residential properties of four or fewer units.**  
55 **Notwithstanding any provision of law to the contrary, any clean energy development board**  
56 **formed to improve commercial properties, properties owned by non-profit or not-for-profit**  
57 **entities, governmental properties, or non-residential properties in excess of four residential**  
58 **units shall be exempt from the provisions of sections 67.2816, 67.2817, 67.2818, and**  
59 **67.2819, nor shall such sections apply to the commercial PACE programs and commercial**  
60 **PACE assessment contracts of any clean energy development board engaged in both**  
61 **commercial and residential property programs. Notwithstanding any provision of law to**  
62 **the contrary, any clean energy development board that ceases to finance new projects to**  
63 **improve residential properties of four or fewer units before January 1, 2022, shall be**  
64 **exempt from the provisions of sections 67.2816, 67.2817, 67.2818, and 67.2819.**

65 8. **After January 1, 2022, a residential property assessment contract shall not be**  
66 **approved by the clean energy development board, or otherwise presented for recordation,**  
67 **unless the clean energy development board verifies that written consent to the residential**  
68 **property assessment contract has been obtained from every existing lien holder on the**  
69 **property if the amount of the contract is more than ten percent of the market value of the**

70 property. No lien holder shall be required or compelled to compromise their security  
71 interest by providing consent and may refuse to consent to the residential property  
72 assessment contract becoming effective. Such consent shall be attached to the assessment  
73 contract that is filed with the recorder of deeds office. A residential property assessment  
74 contract that is only for heating, ventilating, or air conditioning distribution system  
75 modifications and replacements shall not require consent.

67.2816. 1. Municipalities that have created or joined a residential PACE program  
2 or district shall inform the director by submitting a copy of the enabling ordinance to the  
3 division. Any municipality that withdraws from a residential PACE program or district  
4 shall inform the director by submitting a copy of the enabling ordinance for the  
5 withdrawal to the division.

6 2. Clean energy development boards offering residential property programs in the  
7 state of Missouri and their program administrator shall be subject to examination by the  
8 division for compliance with the provisions of sections 67.2800 to 67.2840 related to the  
9 administration of programs for residential properties.

10 3. The division shall conduct an examination of each clean energy development  
11 board at least once every twenty-four months. The functions, powers, and duties of the  
12 director shall include the authority to adopt, promulgate, amend, and repeal rules  
13 necessary and proper for the administration of the director's duties under sections 67.2800  
14 to 67.2840, subject to the requirements of sections 361.105 and 536.024.

15 4. The division shall provide each completed examination of a clean energy  
16 development board to the municipality that has joined a residential PACE program  
17 operated by such board or district in which such board operates.

18 5. The clean energy development board and its program administrator or other  
19 agents shall be jointly and severally responsible for paying the actual costs of examinations,  
20 not to exceed five thousand dollars, which the director shall assess upon the completion of  
21 an examination and be credited to the division of finance fund established under section  
22 361.170 and subject to the provisions thereof.

67.2817. 1. Notwithstanding any other contractual agreement to the contrary, each  
2 assessment contract shall be reviewed, approved, and executed by the clean energy  
3 development board and these duties shall not be delegated. Any attempted delegations of  
4 these duties shall be void.

5 2. An assessment contract shall not be approved, executed, submitted, or otherwise  
6 presented for recordation unless a clean energy development board verifies that the  
7 following criteria are satisfied:

8 (1) The PACE assessments are assessed in equal annual installments;

9           (2) The PACE assessment may be paid in full at any time without prepayment  
10 penalty. The pay-off letter shall specify the amount of any fee or charge by a lender or  
11 loan service agent to obtain the total balance due. The release of the assessment shall be  
12 recorded within thirty days of the receipt of the amounts identified in the pay-off letter;

13           (3) The assessment contract shall disclose applicable penalties, interest penalties,  
14 or late fees under the contract and describe generally the interest and penalties imposed  
15 under chapter 140 relating to the collection of delinquent property taxes;

16           (4) The clean energy development board shall provide a separate statement to the  
17 owner of the residential property of the penalties or late fees authorized under the  
18 assessment contract and of the penalties and interest penalties under chapter 140 for the  
19 applicable tax collector as of the date of the assessment contract;

20           (5) The clean energy development board has confirmed that the property owner is  
21 current on property taxes for the project property;

22           (6) The property that shall be subject to the assessment contract has no recorded  
23 and outstanding involuntary liens in excess of one thousand dollars;

24           (7) The property owner shall not currently be a party to any bankruptcy  
25 proceeding where any existing lien holder of the property is named as a creditor;

26           (8) The term of the assessment contract shall not exceed the weighted average  
27 useful life of the qualified improvements to which the greatest portion of funds disbursed  
28 under the assessment contract is attributable, not to exceed twenty years. The clean energy  
29 development board shall determine useful life for purposes of this subdivision based upon  
30 credible third-party standards or certification criteria that have been established by  
31 appropriate government agencies or nationally recognized standards and testing  
32 organizations;

33           (9) The property owner is current on all mortgage debt on the subject property and  
34 has no more than one late payment during the twelve months immediately preceding the  
35 application date on any mortgage debt; and

36           (10) The clean energy development board shall not enter into an assessment  
37 contract or levy or collect a special assessment for a project without making a finding that  
38 there are sufficient resources to complete the project and that the estimated economic  
39 benefit expected from the project during the financing period is equal to or greater than  
40 the cost of the project.

41           3. Any assessment contract for a project that costs between eighty percent and  
42 ninety-seven percent of the fair market value of the benefitted property prior to the project  
43 shall include provision of an insurance policy providing coverage for any remaining cost  
44 of fulfilling the assessment contract, including any accumulated interest, in the event the

45 property is foreclosed upon. Such insurance policy shall run with the land in the same  
46 manner as the other obligations set forth in the assessment contract.

47 4. The property owner executing the PACE assessment contract shall have a three-  
48 day right to cancel the qualifying improvements proposed for financing under the PACE  
49 assessment contract. The three-day right to cancel shall expire at midnight of the third  
50 business day after a property owner signs the assessment contract. The clean energy  
51 development board shall be required to provide a printed form that is presented to the  
52 property owner no later than the time of signing of the assessment contract detailing the  
53 property owner's right to cancel. An electronic form may be provided if the owner  
54 consents electronically to receiving an electronic form.

55 5. Prior to the execution of an assessment contract, the clean energy development  
56 board shall advise the property owner in writing that any delinquent assessment shall be  
57 a lien on the property subject to the assessment contract and that the obligations under the  
58 PACE assessment contract continue as an obligation against the improved property if the  
59 property owner sells or refinances the property and that a purchaser or lender may require  
60 that before the owner may sell or refinance the property that the owner may be required  
61 to pay the assessment contract in full.

62 6. Prior to the execution of an assessment contract, the clean energy development  
63 board shall advise the property owner in writing that if the property owner pays his or her  
64 property taxes and special assessments via a lender or loan servicer's escrow program, the  
65 special assessment will cause the owner's monthly escrow requirements to increase and  
66 increase the owner's total monthly payment to the lender or the loan servicer. The clean  
67 energy development board shall further advise the property owner that if the special  
68 assessment results in an escrow shortage that the owner will be required to pay the  
69 shortage in a lump-sum payment or catch-up the shortage over twelve months.

70 7. The clean energy development board, within three days of entering an  
71 assessment contract, shall provide any holder of a first mortgage loan a copy of the  
72 assessment contract and a statement that includes a brief description of the project, the  
73 cost of the project, the annual assessment that will be levied, and the number of annual  
74 assessments. Transmittal shall be by United States mail to the holder of the first mortgage  
75 loan of record.

76 8. The clean energy development board shall maintain a public website with  
77 current information about the PACE program as the board deems appropriate to inform  
78 consumers regarding the PACE program. The website shall list approved contractors for  
79 the PACE program. The website shall disclose the process for property owners or their  
80 successors to request information about the assessment contract, the status of the

81 assessment contract, and for all questions including contract information to obtain a payoff  
82 amount for the release of an assessment contract.

83 9. The clean energy development board, its agents, contractor, or other third party  
84 shall not make any representation as to the income tax deductibility of an assessment.

85 10. The primary existing lien holder for a property shall have three business days  
86 to deny an assessment contract.

67.2818. 1. Any requirements and consumer protections established by federal law  
2 and regulations, and any amendments thereto, applicable to property assessed clean energy  
3 financing, shall apply to residential assessment contracts made pursuant to sections  
4 67.2800 to 67.2840. Additionally, the clean energy development board shall consider the  
5 financial ability of the property owner to repay the assessment contract.

6 2. The clean energy development board shall not enter into an assessment contract  
7 or levy or collect a special assessment for a project if the cash price of the residential  
8 project is more than twenty percent of the market value in money of the property as  
9 determined by reference to the county assessment records for tax purposes for the most  
10 recent completed assessment by the county assessor.

11 3. The clean energy development board shall not enter into an assessment contract  
12 or levy or collect a special assessment for a project if the PACE assessment contract  
13 combined with any existing and outstanding indebtedness secured by the property exceeds  
14 ninety-seven percent of the current market value of the property as determined by  
15 reference to the county assessment records for tax purposes for the most recent completed  
16 assessment by the county assessor.

17 4. The clean energy development board shall provide a disclosure form to  
18 homeowners that shows the financing terms of the assessment contract including, but not  
19 limited to:

20 (1) The total amount funded and borrowed, including the cost of the installed  
21 improvements, the program fees, and capitalized interest, if any;

22 (2) The annual tax assessment, billing process, and payment due date;

23 (3) The annual payment amounts;

24 (4) The term of the assessment;

25 (5) The fixed rate of interest charged;

26 (6) The annual percentage rate;

27 (7) A payment schedule that fully amortizes the amount financed;

28 (8) The improvements to be installed;

29           **(9) A statement that if the property owner sells or refinances the property that the**  
30 **owner may be required by a mortgage lender or a purchaser to pay off the assessment as**  
31 **a condition of refinancing or sale;**

32           **(10) A statement that no penalty shall be assessed or collected for prepayment of**  
33 **the assessment and the specific amount of any fee or charge by a lender or loan servicing**  
34 **agent to obtain the total balance due in a pay-off letter and the recording of a release of the**  
35 **assessment which shall be recorded within thirty days of the receipt of the amount**  
36 **identified in the pay-off letter;**

37           **(11) That the PACE annual assessment shall be collected along with property taxes**  
38 **and that any taxes and annual assessment not paid on or before December thirty-first shall**  
39 **result in a lien on the improved property for the unpaid taxes, unpaid annual assessment,**  
40 **interest, and penalties as provided by law;**

41           **(12) That if the owner pays property taxes and insurance through his or her**  
42 **mortgage payment and an escrow account, that the special assessment will cause the**  
43 **owner's monthly escrow requirements to increase and increase the owner's monthly**  
44 **payment to the lender or the loan servicer and that if the special assessment results in an**  
45 **escrow shortage that the owner shall be required to pay the shortage in a lump-sum**  
46 **payment or catch-up the shortage over twelve months;**

47           **(13) That failure to timely pay the annual assessment and taxes will result in a tax**  
48 **lien and penalties and fees being assessed and added to the annual assessment and taxes,**  
49 **and that if the delinquency is not paid, the property could be sold at a tax sale resulting in**  
50 **issuance of a tax certificate or collector's deed to a purchaser that could result in the**  
51 **property owner losing his or her home; and**

52           **(14) That the property owner should seek professional tax advice if he or she has**  
53 **questions regarding tax credits related to a PACE project or the tax matters presented by**  
54 **the assessment contract or financing agreement and payments thereunder.**

55           **5. The clean energy development board shall be required to present the disclosure**  
56 **form to a property owner for acknowledgment prior to the execution of an assessment**  
57 **contract.**

58           **6. Before a property owner executes an assessment contract, the clean energy**  
59 **development board shall do the following:**

60           **(1) Make a verbal confirmation that at least one owner of the property has a copy**  
61 **of the assessment contract documents with all the key terms completed, the financing**  
62 **estimate and disclosure form, and the right-to-cancel form with a written copy available**  
63 **upon request; and**

64           **(2) Make a verbal confirmation of the key terms of the assessment contract, in plain**  
65 **language, with the property owner, or to the verified authorized representative of the**  
66 **owner, and shall obtain acknowledgment from the property owner or representative to**  
67 **whom the verbal confirmation is given.**

68           **7. The verbal confirmation shall include, but is not limited to, all the following**  
69 **information:**

70           **(1) The property owner has the right to have other persons present, and an inquiry**  
71 **as to whether the property owner would like to exercise the right to include other**  
72 **individuals. This inquiry shall occur immediately after the determination of the preferred**  
73 **language of communication;**

74           **(2) The property owner is informed that he or she should review the assessment**  
75 **contract and financing estimate and disclosure form with all other owners of the property;**

76           **(3) The qualified improvement being installed is being financed by an assessment**  
77 **contract;**

78           **(4) The total estimated annual costs the property owner will have to pay under the**  
79 **assessment contract, including applicable fees;**

80           **(5) The total estimated average monthly amount of funds the property owner would**  
81 **have to save in order to pay the annual costs under the assessment contract, including**  
82 **applicable fees;**

83           **(6) The term of the assessment contract;**

84           **(7) That payments on the assessment contract shall be made through an additional**  
85 **annual assessment on the property and paid either directly to the county tax collector's**  
86 **office as part of the total annual secured property tax bill or through the property owner's**  
87 **mortgage escrow account, and that if the property owner pays his or her taxes through an**  
88 **escrow account, he or she should notify his or her mortgage lender to discuss adjusting his**  
89 **or her monthly mortgage payment or otherwise providing additional funds to avoid a**  
90 **shortage in the owner's mortgage escrow account;**

91           **(8) That the property shall be subject to a lien during the term of the assessment**  
92 **contract for any delinquent assessments;**

93           **(9) That before the owner may sell or refinance the property, a purchaser or lender**  
94 **may require the obligation under the assessment contract to be paid in full;**

95           **(10) That the clean energy development board, its agents contractor, or other third**  
96 **party does not provide tax advice, and that the property owner should seek professional**  
97 **tax advice if he or she has questions regarding tax credits related to the project or the tax**  
98 **matters presented by the PACE assessment or assessment contract; and**

99           **(11) The date the first payment shall be due.**

67.2819. 1. The clean energy development board or its agents shall not permit contractors or other third parties to advertise the availability of residential assessment contracts that are administered by the board, or to solicit property owners on behalf of the board, unless both of the following requirements are met:

(1) The contractor maintains any permits, licenses, or registrations required for engaging in its business in the jurisdiction where it operates and maintains bond and insurance coverage in minimum amounts determined by the clean energy development board or higher amounts as required in the jurisdiction where the contractor is licensed or registered; and

(2) The clean energy development board or its agents obtain the contractor's written agreement that the contractor or third party shall act in accordance with chapter 407 and other applicable advertising and marketing laws and regulations.

2. The clean energy development board or its agents shall not provide any direct or indirect cash payment or other thing of material value to a contractor or third party in excess of the actual price charged by that contractor or third party to the property owner for one or more qualified improvements financed by an assessment contract.

3. The clean energy development board or its agents shall not provide to a contractor engaged in soliciting financing agreements on behalf of the clean energy development board or its agents any information that discloses the maximum amount of funds for which a property owner may be eligible for qualifying improvements or the amount of equity in a property.

4. The clean energy development board or its agents shall not reimburse a contractor or third party for expenses for advertising and marketing campaigns that solely benefit the contractor.

5. The clean energy development board or its agents may reimburse a contractor's bona fide and reasonable training expenses related to PACE financing, provided that:

(1) The training expenses are actually incurred by the contractor; and

(2) The reimbursement is paid directly to the contractor, and is not paid to its salespersons or agents.

6. The clean energy development board or its agents shall not provide any direct cash payment or other thing of value to a property owner explicitly conditioned upon the property owner entering into an assessment contract. Notwithstanding the provisions of this subsection to the contrary, programs or promotions that offer reduced fees or interest rates to property owners are not a direct cash payment or other thing of value, provided that the reduced fee or interest rate is reflected in the assessment contract and in no circumstance provided to the property owner as cash consideration. A contractor shall not



37 provide a different price for a project financed under this section than the contractor  
38 would provide if paid in cash by the property owner.

67.2840. 1. Sections 67.2816, 67.2817, 67.2818, and 67.2819 shall be effective and  
2 apply to the residential PACE programs of clean energy development boards and  
3 participating municipalities after January 1, 2022.

4 2. Sections 67.2816, 67.2817, 67.2818, and 67.2819 shall be effective and apply to  
5 residential PACE assessment contracts entered into after January 1, 2022.

285.1000. For purposes of sections 285.1000 to 285.1055, the following terms shall  
2 mean:

3 (1) "Administrative fund" or "Missouri workplace retirement savings  
4 administrative fund", the Missouri workplace retirement savings administrative fund  
5 described in section 285.1045;

6 (2) "Board", the Missouri workplace retirement savings board established under  
7 section 285.1005;

8 (3) "Eligible employee", an individual who is employed by a participating  
9 employer, who has wages or other compensation that is allocable to the state, and who is  
10 eighteen years of age or older. "Eligible employee" shall not include any of the following:

11 (a) Any employee covered under the federal Railway Labor Act, 45 U.S.C. Section  
12 151;

13 (b) Any employee on whose behalf an employer makes contributions to a  
14 multiemployer pension trust fund under 29 U.S.C. Section 186; or

15 (c) Any individual who is an employee of:

16 a. The federal government;

17 b. Any state government in the United States; or

18 c. Any county, municipal corporation, or political subdivision of any state in the  
19 United States;

20 (4) "Eligible employer", a person or entity engaged in a business, industry,  
21 profession, trade, or other enterprise in the state of Missouri, whether for profit or not for  
22 profit; provided that, such a person or entity employs no more than fifty employees. A  
23 person or entity who qualifies as an eligible employer but who later employs more than  
24 fifty employees shall be permitted to remain an eligible employer for a period of five years  
25 beginning on the date on which the person or entity first employs more than fifty  
26 employees. After such five-year period has ended, the person or entity shall immediately

62 (12) "Total fees and expenses", all fees, costs, and expenses including, but not  
63 limited to, administrative expenses, investment expenses, investment advice expenses,  
64 accounting costs, actuarial costs, legal costs, marketing expenses, education expenses,  
65 trading costs, insurance annuitization costs, and other miscellaneous costs;

66 (13) "Trust", the trust in which the assets of the plan are held.

285.1005. 1. The "Missouri Workplace Retirement Savings Board" is hereby  
2 established in the office of the state treasurer.

3 2. The board shall consist of the following members, with the state treasurer, or his  
4 or her designee, serving as chair:

5 (1) The state treasurer, or his or her designee;

6 (2) An individual who has a favorable reputation for skill, knowledge, and  
7 experience in the field of retirement savings and investments, to be appointed by the  
8 governor with the advice and consent of the senate;

9 (3) An individual who has a favorable reputation for skill, knowledge, and  
10 experience relating to small business, to be appointed by the governor with the advice and  
11 consent of the senate;

12 (4) An individual who is a representative of an association representing employees  
13 or who has a favorable reputation for skill, knowledge, and experience in the interests of  
14 employees in retirement savings, to be appointed by the speaker of the house of  
15 representatives;

16 (5) An individual who has a favorable reputation for skill, knowledge, and  
17 experience in the interests of employers in retirement savings, to be appointed by the  
18 president pro tempore of the senate;

19 (6) A retired individual to be a representative of the interests of retirees, to be  
20 appointed by the speaker of the house of representatives;

21 (7) An individual who has a favorable reputation for skill, knowledge, and  
22 experience in retirement investment products or retirement plan designs, to be appointed  
23 by the president pro tempore of the senate;

24 (8) A member of the house of representatives appointed by the speaker of the house  
25 of representatives; and

26 (9) A member of the senate appointed by the president pro tempore of the senate.

27 3. The governor, the president pro tempore of the senate, and the speaker of the  
28 house of representatives shall make the respective initial appointments to the board for  
29 terms of office beginning on January 1, 2022.

30 4. Members of the board appointed by the governor, the president pro tempore of  
31 the senate, and the speaker of the house of representatives shall serve at the pleasure of the  
32 appointing authority.

33 5. The term of office of each member of the board shall be four years. Any member  
34 is eligible to be reappointed. If there is a vacancy for any reason, the appropriate

35 appointing authority shall make an appointment, to become immediately effective, for the  
36 unexpired term.

37 6. All members of the board shall serve without compensation and shall be  
38 reimbursed from the administrative fund for necessary travel expenses incurred in  
39 carrying out the duties of the board.

40 7. A majority of the voting members of the board shall constitute a quorum for the

285.1010. 1. The board, subject to the authority granted under sections 285.1000  
2 to 285.1055, shall design, develop, and implement the plan, and, to that end, may conduct  
3 market, legal, and feasibility analyses.

4 2. The members of the board shall be fiduciaries of the plan under ERISA, and the  
5 board shall have the following powers, authorities, and duties:

6 (1) To establish, implement, and maintain the plan, in each case acting on behalf  
7 of the state of Missouri, including, in its discretion, more than one plan;

8 (2) To cause the plan, trust, and arrangements and accounts established under the  
9 plan to be designed, established, and operated:

10 (a) In accordance with best practices for retirement savings vehicles;

11 (b) To encourage participation, saving, sound investment practices, and  
12 appropriate selection of default investments;

13 (c) To maximize simplicity and ease of administration for eligible employers;

14 (d) To minimize costs, including by collective investment and economies of scale;  
15 and

16 (e) To promote portability of benefits;

17 (3) To arrange for collective, common, and pooled investment of assets of the plan  
18 and trust, including investments in conjunction with other funds with which assets are  
19 permitted to be collectively invested, with a view to saving costs through efficiencies and  
20 economies of scale;

21 (4) To develop and disseminate educational information designed to educate  
22 participants and citizens about the benefits of planning and saving for retirement and to  
23 help participants and citizens decide the level of participation and savings strategies that  
24 may be appropriate, including information in furtherance of financial capability and  
25 financial literacy;

26 (5) To adopt rules and regulations necessary or advisable for the implementation  
27 of sections 285.1000 to 285.1055 and the administration and operation of the plan  
28 consistent with the Internal Revenue Code and regulations thereunder, including to ensure  
29 that the plan satisfies all criteria for favorable federal tax-qualified treatment and

30 complies, to the extent necessary, with ERISA and any other applicable federal or Missouri  
31 law. Any rule or portion of a rule, as that term is defined in section 536.010, that is created  
32 under the authority delegated in this section shall become effective only if it complies with  
33 and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028.  
34 This section and chapter 536 are nonseverable, and if any of the powers vested with the  
35 general assembly pursuant to chapter 536 to review, to delay the effective date, or to  
36 disapprove and annul a rule are subsequently held unconstitutional, then the grant of  
37 rulemaking authority and any rule proposed or adopted after August 28, 2021, shall be

39 (6) To arrange for and facilitate compliance by the plan or arrangements  
40 established thereunder with all applicable requirements for the plan under the Internal  
41 Revenue Code, ERISA, and any other applicable federal or Missouri law and accounting  
42 requirements, and to provide or arrange for assistance to eligible employers, eligible  
43 employees, and self-employed individuals in complying with applicable law and tax-related  
44 requirements in a cost-effective manner. The board may establish any processes deemed  
45 reasonably necessary or advisable to verify whether a person or entity is an eligible  
46 employer, including reference to online data and possible use of questions in employer tax  
47 filings;

48 (7) To employ or retain a plan administrator, executive director, staff, trustee,  
49 record-keeper, investment managers, investment advisors, and other administrative,  
50 professional, and expert advisors and service providers, none of whom shall be members  
51 of the board and all of whom shall serve at the pleasure of the board, which shall  
52 determine their duties and compensation. The board may authorize the executive director  
53 and other officials to oversee requests for proposals or other public competitions and enter  
54 into contracts on behalf of the board or conduct any business necessary for the efficient  
55 operation of the plan or the board;

56 (8) To establish procedures for the timely and fair resolution of participant and  
57 other disputes related to accounts or program operation and, if necessary, determine the  
58 eligibility of an employer, employee, or other individual to participate in the plan;

59 (9) To develop and implement an investment policy that defines the plan's  
60 investment objectives, consistent with the objectives of the plan, and that provides for  
61 policies and procedures consistent with those investment objectives;

62 (10) (a) To designate appropriate default investments that include a mix of asset  
63 classes, such as target date and balanced funds;

64 (b) To seek to minimize participant fees and expenses of investment and  
65 administration;

66 (c) To strive to design and implement investment options available to holders of  
67 accounts established as part of the plan and other plan features that are intended to  
68 achieve maximum possible income replacement balanced with an appropriate level of risk  
69 consistent with the investment objectives under the investment policy. The investment  
70 options may encompass a range of risk and return opportunities and allow for a rate of  
71 return commensurate with an appropriate level of risk in view of the investment objectives  
72 under the policy. The menu of investment options shall be determined taking into account  
73 the nature and objectives of the plan, the desirability of limiting investment choices under  
74 the plan to a reasonable number, based on behavioral research findings, and the extensive  
75 investment choices available to participants in the event that funds roll over to an  
76 individual retirement account (IRA) outside the program; and

77 (d) In accordance with subdivision (7) of this subsection, the board, to the extent  
78 it deems it necessary or advisable, in carrying out its responsibilities and exercising its  
79 powers under sections 285.1000 to 285.1055, shall employ or retain appropriate entities or  
80 personnel to assist or advise it or to whom to delegate the carrying out of such  
81 responsibilities and exercising of such powers;

82 (11) To discharge its duties and see to it that the members of the board discharge  
83 their duties with respect to the plan solely in the interest of the participants as follows:

84 (a) For the exclusive purpose of providing benefits to participants and defraying

86 (b) With the care, skill, prudence, and diligence under the circumstances then

89 (12) To cause expenses incurred to initiate, implement, maintain, and administer  
90 the plan to be paid from contributions to, or investment returns or assets of, the plan or  
91 other moneys collected by or for the plan or pursuant to arrangements established under  
92 the plan to the extent permitted under federal and Missouri law;

93 (13) To collect application, account, or administrative fees and to accept any grants,  
94 gifts, legislative appropriations, loans, and other moneys from the state of Missouri, any  
95 unit of federal, state, or local government, or any other person, firm, or entity to defray the  
96 costs of administering and operating the plan;

97 (14) To make and enter into competitively procured contracts, agreements, or  
98 arrangements with; to collaborate and cooperate with; and to retain, employ, and contract  
99 with or for any of the following to the extent necessary or desirable for the effective and  
100 efficient design, implementation, and administration of the plan consistent with the

101 purposes set forth in sections 285.1000 to 285.1055 and to maximize outreach to eligible  
102 employers and eligible employees:

103 (a) Services of private and public financial institutions, depositories, consultants,  
104 actuaries, counsel, auditors, investment advisors, investment administrators, investment

107 (b) Research, technical, financial, administrative, and other services; and

108 (c) Services of other state agencies to assist the board in the exercise of its powers

110 (15) To develop and implement an outreach plan to gain input and disseminate  
111 information regarding the plan and retirement savings in general;

112 (16) To cause moneys to be held and invested and reinvested under the plan;

113 (17) To ensure that all contributions under the plan may be used only to:

114 (a) Pay benefits to participants under the plan;

115 (b) Pay the costs of administering the plan; and

116 (c) Make investments for the benefit of the plan, and ensure that no assets of the  
117 plan or trust are transferred to the general revenue fund or to any other fund of the state  
118 or are otherwise encumbered or used for any purpose other than those specified in this  
119 paragraph or section 285.1045;

120 (18) To make provisions for the payment of costs of administration and operation  
121 of the program and trust;

122 (19) To evaluate the need for, and procure as needed, insurance against any and  
123 all loss in connection with the property, assets, or activities of the program, including  
124 fiduciary liability coverage;

125 (20) To evaluate the need for, and procure as needed, pooled private insurance;

126 (21) To indemnify, including procurement of insurance as needed for this purpose,  
127 each member of the board from personal loss or liability resulting from a member's action  
128 or inaction as a member of the board and as a fiduciary;

129 (22) To collaborate with, and evaluate the role of, financial advisors or other  
130 financial professionals, including in assisting and providing guidance for covered  
131 employees; and

140 (3) Become an endorser, surety, or obligor on investments made under the

142 4. Each board member shall be subject to the provisions of sections 105.452 and  
143 105.454.

285.1015. 1. The board shall, consistent with federal law and regulation, adopt and  
2 implement the plan, which shall remain in compliance with federal law and regulations  
3 once implemented and shall be called the "Missouri Workplace Retirement Savings Plan".

4 2. In accordance with terms and conditions specified and regulations promulgated  
5 by the board, the plan shall:

6 (1) Be set forth in documents prescribing the terms and conditions of the plan;

49 infrastructure to facilitate contributions, record keeping, and outreach and use pooled or  
50 collective investment arrangements;

51 (16) Provide that each account holder owns the contributions to or earnings on  
52 amounts contributed to his or her account under the plan and that the state and employers  
53 have no proprietary interest in those contributions or earnings;

54 (17) Be designed and implemented in a manner consistent with federal law to the
