AN ACT

To repeal sections 327.312 and 327.314, RSMo, and to enact in lieu thereof two new sections relating to land surveyors.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 327.312 and 327.314, RSMo, are repealed and two new sections enacted in lieu thereof, to be known as sections 327.312 and 327.314, to read as follows:

327.312. 1. Any person may apply to the board for enrollment as a land surveyor-in-training who is a high school graduate, or who holds a Missouri certificate of high school equivalence (GED), and either:

(1) Has graduated and received a baccalaureate degree in an approved curriculum as defined by board regulation which shall include at least ~~[twelve]~~ **fifteen** semester hours of approved surveying course work as defined by board regulation of which at least ~~[two]~~ **three** semester hours shall be in the legal aspects of boundary surveying; or

(2) Has passed at least sixty hours of college credit which shall include credit for at least ~~[twenty]~~ **fifteen** semester hours of approved surveying course work as defined by board regulation of which at least ~~[two]~~ **three** semester hours shall be in legal aspects of boundary surveying and present evidence satisfactory to the board that in addition thereto such person has at least one year of combined professional office and field experience in land surveying projects under the immediate personal supervision of a professional land surveyor; or

(3) Has passed at least ~~[twelve]~~ **fifteen** semester hours of approved surveying course work as defined by board regulation of which at least ~~[two]~~ **three** semester hours shall be in legal aspects of land surveying and in addition thereto has at least two years of combined professional office and field experience in land surveying projects under the immediate personal supervision

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

21 2. The board shall issue a certificate of completion to each applicant who satisfies the
22 requirements of the aforementioned land surveyor-in-training program and passes such
23 examination or examinations as shall be required by the board.

327.314. 1. Any person may apply to the board for licensure as a professional land
2 surveyor who has been enrolled as a land surveyor-in-training and has presented evidence to the
3 satisfaction of the board that ~~[said person]~~ **he or she** has:

4 (1) Acquired at least four years of satisfactory professional field and office experience
5 in land surveying ~~[from the date of enrollment as a land surveyor-in-training. This experience~~
6 ~~shall have been]~~ under the immediate personal supervision of a professional land surveyor,
7 **which may occur prior to the person's enrollment as a land surveyor-in-training; and**

8 (2) **Satisfied the examination requirements under section 327.331.**

9 2. Any applicable experience earned prior to a person's enrollment as a land
10 surveyor-in-training shall count toward the professional and field experience requirements
11 of subsection 1 of this section.
