AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to electric vehicle road use fees.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be 2 known as section 301.105, to read as follows:

301.105. 1. Beginning January 1, 2022, in addition to all other registration fees 2 required under state law, the department of revenue may charge and collect an electric 3 vehicle road use fee and a plug-in electric hybrid vehicle road use fee upon initial 4 registration for each electric vehicle and plug-in electric hybrid vehicle registered in this state. For purposes of this section, "electric vehicle" means any motor vehicle that is 5 6 powered solely by a battery that can be recharged wirelessly or plugged into an external source of electricity and meets the applicable federal and state safety standards for on-road 7 vehicles. "Plug-in electric hybrid vehicle" means any hybrid vehicle with an internal 8 combustion engine and a battery that can be recharged wirelessly or plugged into an 9 10 external source of electricity and meets the applicable federal and state safety standards 11 for on-road vehicles.

2. Concurrent with submitting an initial vehicle registration application and fee to the department under this chapter, owners of a electric vehicles and owners of plug-in electric hybrid vehicles shall submit a one-time electric vehicle road use fee or plug-in electric hybrid vehicle road use fee. The road use fees shall be as follows:

(1) For electric vehicles purchased new, the fee shall be four percent of the electric
vehicle's list price, as defined in section 301.567;

18 (2) For electric vehicles purchased in used condition, the fee shall be four percent 19 of the vehicle's value as determined by the Kelly Blue Book;

20 (3) For plug-in electric hybrid vehicles purchased new, the fee shall be two percent 21 of the hybrid vehicle's list price, as defined in section 301.567;

(4) For plug-in electric hybrid vehicles purchased used, the fee shall be two percent 23 of the vehicle's value as determined by the Kelly Blue Book.

24 3. Revenue from the road use fees collected under this section shall be deposited 25 into the state road fund to be used and expended as provided by Article IV, Section 30(b) 26 of the Constitution of Missouri.

27 4. The director of the department of revenue may promulgate all necessary rules and regulations for the administration of this section. Any rule or portion of a rule, as that 28 29 term is defined in section 536.010, that is created under the authority delegated in this 30 section shall become effective only if it complies with and is subject to all of the provisions 31 of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are 32 nonseverable, and if any of the powers vested with the general assembly pursuant to 33 chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are 34 subsequently held unconstitutional, then the grant of rulemaking authority and any rule 35 proposed or adopted after August 28, 2021, shall be invalid and void.
