Beginning on January 1, 2022, for purposes of calculating Missouri taxable income, 100% of the income of any taxpayer who is employed by an employer with a NAICS code for "restaurants and other eating places" may be deducted from their Missouri adjusted gross income to determine their Missouri taxable income.
