HCS HB 1358 -- CONTAGIOUS DISEASES

SPONSOR: Baker

COMMITTEE ACTION: Voted "Do Pass with HCS" by the Special Committee on Litigation Reform by a vote of 8 to 0. Voted "Do Pass" by the Standing Committee on Rules- Legislative Oversight by a vote of 10 to 1.

The following is a summary of the House Committee Substitute for HB 1358.

The bill creates the "True COVID Liability Act" and contains declarative statements regarding epidemiology, public policy relating to contagious diseases including COVID-19, susceptibility to contagious diseases, personal accountability, legal liability and government-mandated responses as outlined.

The bill prohibits the state or any political subdivision thereof from, as a response to a contagious disease, quarantining an individual in any way; limiting the use of otherwise lawful activities in any private property or premises in which extraordinary prevalence of a contagious disease has not been proven; revoking any business license based on an individual's or entity's decision regarding recommendations from a government or scientific entity.

No individual, owner, or entity shall be subject to criminal or civil liability in any action alleging exposure to a contagious disease on premises controlled by such person unless they knowingly and purposely with malice, exposed an individual to a contagious disease where such exposure caused the exposed individual to suffer from a clinical disease.

The bill contains an emergency clause.

PROPONENTS: Supporters say that the bill establishes a sensible standard as the current protocol is unacceptable. The bill will turn the clock back to where we thought the law in America was before the COVID pandemic.

OPPONENTS: Those who oppose the bill say that the language in the bill restricts local government powers and makes declarative statements about diseases that are false.

Testifying against the bill were Blake Gearin; Peter Corretjer; Virginia C Weigum; and Missouri State Medical Association.

OTHERS: Others testifying on the bill say while we should reign in the power of local government, the language in the bill may be deemed vague or too broad. The procedure for quarantine in the bill deviates from how quarantine has been used in the past. The bill also may have unintended consequences that may discourage people from getting tested. The Missouri Constitution protects an individual's right to sue on any injury, including negligence, not just malice.
