COMMITTEE ACTION: Voted "Do Pass with HCS" by the Standing Committee on Emerging Issues by a vote of 7 to 4. Voted "Do Pass" by the Standing Committee on Rules- Administrative Oversight by a vote 8 to 4.

The following is a summary of the public testimony from the committee hearing. The testimony was based on the perfected version of the bill.

PROPONENTS: Supporters say that this bill would provide transparency for regulated entities when the Department of Natural Resources issues fines and penalties. The Department would have to provide a explanation of how it reached the penalty or fine assessed on the entity. The bill would also give the General Assembly greater involvement in the setting of the Department's fees, rather than the Department setting its own fees.

Testifying for the bill were Senator Burlison; and Associated Industries of Missouri.

OPPONENTS: Those who oppose the bill say that the current stakeholder process for setting fees is a fair process and gives regulated entities and interested parties a say in the fee. This bill would remove opportunity for stakeholder input in the fees that they must pay.
