HB 1068, a priority piece of legislation for the members of the National Rifle Association, makes clear that each level of the firearm and ammunition supply chain is an essential business and that they may not be prohibited or restricted from operating during a declared emergency or disaster. During the COVID-19 pandemic, many anti-gun officials around the country, at both state and local levels of government, took the opportunity to unilaterally suspend Second Amendment rights by shutting down gun stores and ranges. Unfortunately, this coincided with many Americans trying to exercise their Second Amendment rights for the first time during that period of uncertainty, and resulted in them being unable to access arms, ammunition, or proper training. HB 1068 protects the exercise of a constitutional right from such politically motivated attacks and ensures that citizens have those rights when they need them most. Law-abiding citizens need firearms during uncertain times. During this pandemic, Americans have voted with their wallets and their decision is clear: firearms and ammunition are essential during emergencies. During such uncertain times, whether a pandemic or natural disaster, it is vital that law-abiding citizens of this state have access to firearms and ammunition in order to defend themselves and their families. Mr. Chairman and members of the committee, I ask that you please vote yes on HB 1068.
