I abstained from medical marijuana through the entire pregnancy, but continued to take my full spectrum CBD to help with depression, chronic pain, and to help regulate my blood sugars and blood pressure. At my last visit, my Dr asked if CBD can produce a positive test, and I assured her that it may in a number of people, with a number of varying reasons. I was hotlined and a social worker had to not only visit me before I could leave the hospital, but also come do a home visit and interview my older children. The case was closed after assessing our situation but it was very traumatic and I felt I was being punished for being honest about my CBD use (which was never discouraged through any visit prior to delivering) and at a time when I was vulnerable already (Covid at peak #s) I don't want anyone else to ever feel at jeopardy about the way the safely treat their own body by choosing a natural plant versus prescription drugs.

My name is Jamie Kacz, and I am the Executive Director of NORML Kansas City, a chapter of the National Organization for the Reform of Marijuana Laws (NORML). I am also a resident of Kansas City, Missouri. As both a parent and a registered medical cannabis patient, I am here to support House Bill 1325. When I founded NORML KC in 2015, I knew I wanted to help patients gain safe and legal access to cannabis. When Amendment 2 was passed, we knew we had more work to do to ensure patients were protected. We understood that passing this new law would create inconsistencies in other areas of Missouri law. This bill is our effort to help address these inconsistencies and help prevent legal medical marijuana patients from losing their children. I believe no patients should have to choose between their legal medicine and their family. Can children really be removed from a home because a parent is a legal marijuana patient? Can someone's status as a legal marijuana patient be held against them in family court? The answer is yes. We have watched it happen in other states. This is what happened in California and they wrote protections in their adult use initiative to ensure patients were protected. We want to ensure patients are protected now. Being here today and speaking candidly about my story terrifies me. I have been in family court and I have had my status of being a cannabis advocate used against me by my ex spouse. I had to carry the stigma with me through court proceedings and had to participate in drug testing, just for exercising my 1st Amendment rights to reform cannabis laws. I had never had legal issues or committed any crime, but that did not matter. Was my cannabis advocacy held against me? Yes. Did my children suffer as a result of this? Yes. My number one priority in life has been to be the best mom I can be for my kids. My kids mean the world to me. Living in constant fear of my abuser taking me back to court over my status as a patient terrifies me, and almost prevented me from speaking today. But my fear is the exact reason I am speaking out today. Legal medical marijuana patients should not live in fear of losing their children. No patient deserves to have their family torn apart due to their status as a legal medical marijuana patient. It is important to support these protections to prevent the cruel and unnecessary removal of children from a loving home simply due to a parent's status as a legal medical cannabis patient. As a mother, I ask you to help us and "do pass" HB 1325 for Missouri families and patients.

Jessica Kelly5855 N London AyeKansas City, MO 64151I am a registered Missouri medical cannabis patient. I do not currently medicate with cannabis. One of the reasons I have not begun to medicate is due to the lack of protections in place for Missouri patients. I have severe chronic pain due to a condition called Interstitial Cystitis, Quality of life for this condition has been compared to someone living with cancer pain, or on dialysis. I moved from Kansas to Missouri after Article XIV passed so that I could utilize the medical marijuana program here and transition off of harmful opioids, muscle relaxers, and sleeping pills to a safer and more natural medicine: cannabis. I have had Interstitial Cystitis for over a decade, and during this time I have tried every known medication that could possibly help me, and I also have had many, many medical procedures and surgeries. Nothing has helped as much as medical cannabis. However, I am not currently medicating even though it is my legal right to do so as a registered Missouri patient. Since there are currently no protections in place here for parents of children who medicate with legal cannabis medicine, I have felt uncomfortable in fully participating in the program. I am a mother to a wonderful child, and I would never, ever do anything that could put my child or myself in harm's way. My child means the world to me. I simply won't feel completely safe and comfortable in exercising my rights as a Missouri citizen to participate in the medical cannabis program here until there are more protections in place. It would be devastating to have my legal patient status held against me. My health conditions are not something I asked for, and how my doctor and I think is best for me to medicate should never impact a court's decision on if I am a fit mother, so long as there are no other risks involved outside of my legal patient status. In my volunteer work with NORML KC as their Communications Director, I have come across too many stories of parents and guardians who have had this held against them in Family Court proceedings, and it has absolutely terrified me. There are almost 80,000 MMJ patients registered in Missouri, many of whom are parents and quardians. We are not criminals. We are loving, caring parents. We deserve support and to be protected. We deserve to feel safe. Please help us keep families together by voting "do pass" on SB 357. Thank you for your consideration on this important issue.

WHY HOUSE BILL 1325 (Section 487,205 RSMo) IS NEEDED IN MO. By LAURIE V. SNELL. Attorney at Law (Mo Bar #41978)As an attorney that represents parents and families in Jackson County Family Court and have for more than 25 years, I can attest first-hand to the fact that this legislation is needed to get the courts to just follow-the-law and recognize/remember that medical marijuana IS legal ANDparent patients cannot be discriminated against! As you may know, the history of marijuana vilification is long, ugly and complex. Constitutional Amendment 2, Article 14 in Missouri does not by itself fully confront nor remedy the discriminatory impact that marijuana use causes for our poor and minority citizens - and never more so than in Family Court.As you may not realize, Missouri is a really tough place to try to parent freely or to try to parent in this social-media-frenzy society without scrutiny and judgment over every action/inaction as parents. The long-standing presumption with Children's Division and at Family Court is that marijuana negatively impacts parental fitness -- period. However, the scrutiny and judgment around marijuana disparately impacts the poor and minority patients who end-up at Family Court. Even after enactment of Constitutional Amendment 2, Article 14, great parents who have been prescribed/certified for marijuana treatment are losing custody of their children or not getting them back simply for taking their medication, as prescribed and even though the law should protect them. This discriminatory treatment occurs even though Article 14 of Amendment 2 establishes the state of the law. Because right now the Judges and Commissioners believe their interpretation of how the law will be applied to patient families in front of them is still up to them. Some recent statements of Commissioners and Judges in Jackson County Family Court TO certified patients -- even since the Medical Marijuana law was enacted show clear bias, much confusion and real discrimination:

"Not sure how courts in Missouri will resolve the issue of marijuana in the state, but use doesn't help convince me that parent can take care of a child." (we know how legislature resolved the issue, by passing Amendment 2, Art. 14!) "I don't believe the suggestion that marijuana calms people down. Might even make them aggressive. . . For sure can demotivate people and parents don't need to be demotivated – there are risks there. . . " (this judge's misinformation/lack of education is exactly the reason for Amendment 2, yet he controls his court. .) "With all these so-called marijuana reforms, in my opinion parents should just stay away from these so-called-marijuana-doctors in dirty lab coats." (the judge is so mis-informed, he doesn't even know the doctors don't dispense!) House Bill 1325 -- like Section 487.200 RSMo (est Aug. 2017) – will be the thing that families and their advocates can use to help eliminate the bias' AND remind Missouri's judicial officers that their predispositions against medical marijuana are unlawful and won't be tolerated. Simply put, House Bill 1325 provides for marijuana patients what section 487.200 RSMo did for methadone patients – a statute to point to which provides them a direction of fairness to give their Judge/Commissioner.Please pass House Bill 1325 – what will be Section 487.205 RSMo -- it is needed so that family courts actually follow the law regarding

the state's patient parents!Thank you!

Our organization is NORML Kansas City, a chapter of the National Organization for the Reform of Marijuana Laws (NORML). We reaching out today on behalf of patients, parents, quardians and the members of our organization. Since establishing NORML KC in 2015, we have been outspoken advocates for safe and legal access to medical cannabis. With the passage of Article XIV, we have refocused our energy to ensure that registered Missouri patients are protected under all areas of the law. Like two out of three Missourians, we believe that patients suffering from chronic pain and other serious health issues should have the freedom to choose, along with their doctor, the treatment best suited for their specific health needs. Our Board is made up of parents, grandparents, caregivers, patients, and veterans that understand the therapeutic benefits of medical cannabis, and we want patients that are parents and guardians to be protected under Missouri law in family court proceedings. It is important to create protections to prevent the cruel and unnecessary removal of children from a loving home simply due to a parent's status as a legal medical cannabis patient. It is our understanding that the use of cannabis by parents is often a determining factor in family court proceedings and when state authorities consider removing a child from a home. This is not consistent with how the courts view other medications. This is a topic that deeply concerns many Missouri patients and their loved ones. To address this issue, we crafted H.B. 1325 to protect patients and their families. We worked closely with several attorneys and modeled our language from a previous bill (S.B. 501) that passed in 2017 which created protections in family court for parents that receive medication-assisted treatment. H.B. 1325 would extend those same protections to registered Missouri medical cannabis patients. We respectfully ask the members of the Emerging Issues Committee to support H.B. 1325 with a recommendation of "do pass".
