The facility (following County, State, and Federal guidelines) has quarantined all the residents regardless of their virus status. This prohibits residents from leaving the facility or visits by friends or family - resulting in isolation from loved ones. Assuming that most skilled nursing residents are there for memory care, this isolation has resulted in a further deterioration of their mental capacity. The isolation/quarantine has left residents without any advocate. Recently my dad was declared at the end of his life - NOW I am allowed to visit him but only under restricted guidelines. To see with my own eyes how he has lived is heart breaking. His dental pieces were lost months ago, his glasses and magnifier are now missing so he can no longer read, he was moved to another room but his TV wasn't and now it is missing. My dad has dementia and yet they put the call button next to him when he does not have the capacity to use it - meaning if he wants a drink of water he is not able to mentally process the thought to push the call button for help. The healthy should not be quarantined it is the people who have been diagnosed sick with an accurate test (not a PCR test with an increased amplification rate) who should be encouraged to quarantine. Stop the insanity of wrong being right and right being wrong.

I strongly disagree with the following statement from the bill: "Because of the prevalence of contagious diseases, exposure is practically unavoidable for most people and likely to occur from multiple sources." The best way to avoid contagious diseases is by quaranteening. Doing so when you have no symptoms lowers the percentage of the population that is able get sick at a given time. Other countries with aggressive, mandatory guaranteening are now without COVID-19 and can exercise personal freedoms again, unlike the United States, where people wish they could go out again without worrying. Without mandatory quaranteening, young people can easily get and overcome COVID-19, without much personal consequence, and pass it along to others, leading to more deaths of our elders. Another quote I strongly disagree with is, "The principal office of government is to secure the individual liberty of the people, including the freedom to make choices about how to personally deal with contagious diseases."Ask yourself this: Should a school principal have the authority to send a child home when they appear sick and could infect others? If yes, the government can and should do the same with citizens, as it is their authority to protect all citizens it represents. Letting each person decide for themselves is not an appropriate response to a disease that, by definition, spreads when people are close to one another.Regarding criminal or civil liability, contagious diseases should absolutely not be conditional on such strict criteria. If a restaurant served me dinner with a dead mouse in it, I should be able to take legal action against them even if its inclusion was not "knowingly or purposefully, and with malice" and even if it didn't cause me "to suffer from a clinical disease." Contagious diseases are no different. In fact, a contagious disease can be much more deadly than dead mice, making legal action that much more appropriate.
