I would like to give a brief description of an incident that took place a few years ago while I was officiating a baseball game. At the conclusion of the evening, my partner and I had a verbal encounter with a spectator in the parking lot. We had just concluded the junior varsity contest early due to lightning in the area. Both coaches agreed and we left the field without incident. Without a separate area to dress, and threatening weather moving in, my partner and I were changing at my vehicle in the parking lot. We were backed in behind the visiting schools bus, and had some privacy from other vehicles except on the passenger side. As a spectator was walking to his car parked nearby, he looked at my partner and said "Have a nice evening, dumbass." My partner responded with "Have a good evening." The gentlemen then decided to come to the passenger side of his vehicle and further engage us with more verbal banter. He mentioned that we better have a good nights sleep and possibly something about seeing us later. He also took photos with his smartphone of the front of my personal vehicle, including my license plate. I advised the gentlemen that we were staying at our vehicle and that he needed to get into his vehicle and leave the park. He did eventually get into his vehicle and waited a few minutes before leaving. We finished putting our gear into my vehicle and left the park without further incident. The spectator was approximately 5'10", middle aged, dark hair and mustache. He drove a dark navy blue Chrysler SUV. His wife and daughter got into the vehicle without incident. This is just one example of an incident that should not ever happen. Although I have been officiating for many years, my partner was a young man, just getting started in the business. This incident could have very easily turned him away from a worthy profession. Thankfully no physical harm resulted from this incident, and calling law enforcement was not necessary, but the situation could have turned very easily. I would very much like to see this legislation enacted. Thank you for your time.

In my 25+ years career as a high school sports official there are four incidents that stand out in my mind where I considered that I was harassed. Two of the four, involved a parent/fan. During one incident, the individual made a "slahing" gesture across his throat directed at me as I exited the basketball floor at half-time. Local security personnel escorted the offender from the facility and took me to my vehicle following the game. The school which he was following took action to bar him from attending future games. The other fan incident occurred when a fan/parent who disagreed with a call began to enter the court but had second thoughts. He was removed from the premises by school administrators. The other two incidents occurred when coaches entered the officiating crew dressing facility after their team lost to complain about the officiating. While these interactions were not harassment per se, they were inappropriate given the circumstances. In one instance the coach came to the dressing room with his father. In the other the coach was accompanied by a school administrator. I recall that both instances were reported to the individual who made official's game assignments. I do not recall being told what, if any actions were handed out to the offending coaches. At the time, I felt these interactions were part of being an official. With incidents between officials and parents, fans coaches etc. escalating, I wanted to share my experiences in order to give the legislature a clearer picture of what is going on in the state regarding these interactions.
