Circuit Clerks in the 32nd Judicial Circuit and in circuits across the State have been performing the duties outlined in HB 807 for many years, primarily due to court consolidation which was designed to relieve the judges of those same duties - hiring and firing deputy clerks, assigning job tasks, approving time off, managing the clerks' budget, settling employee disputes, etc., so judges could concentrate on their cases instead of on mundane employee issues. Please approve HB 807.
