HB836 Testimony3/22/21Good evening, Chairman Trent, Representatives. My name is Brett Sterley, I am a resident of the 135th House District and volunteer as Missouri State Director for the Convention of States Project, testifying in support of HB836. Thank you for the opportunity to appear before you today. The 99th Assembly passed the Convention of States Project's model resolution to apply for an Article V convention of states meeting to propose amendments to the US Constitution that: limit the size, scope and jurisdiction of the federal government, discuss term limits for federal officials and restore fiscal restraints, in 2017. The next step is for you to determine how Missouri will select commissioners to represent Missouri at an Article V convention of states meeting. This is what HB836 does.HB836 involves the entire state and the entire legislature. The Senate President Pro Tem and Speaker of the House will select 5 members of their chamber, 3 from the majority party and 2 from the minority party to a committee tasked with identifying potential commissioners. The 10-person Committee will select at least 3 possible commissioners and 3 possible alternates from each Federal Congressional District in Missouri. These candidates will be presented to the full body for an individual vote. The legislature will select 1 commissioner and 1 alternate from each Federal Congressional District to represent Missouri at any Article V meeting. Selecting commissioners from across the state This insures the entire state is involved in the process and accomplishes several things:1) participates in this discussion. 2) Ideas from across the state will be represented as well as the interests of the state. 3) Citizens throughout the state will be involved and that is critical when it comes time for ratification. The Joint Legislative Committee will have the authority to recall commissioners who violate their commissions or their instructions for a specific Article V convention of states meeting. No more than 1/3 of the commissioners or alternates will be sitting members of the Missouri Legislature.HB231 is a thoughtful and fair process for Missouri to select its commissioners. Opponents of The Framers' convention of states process have claimed that we do not know how the commissioners will be selected, who controls their actions and if they can even be controlled at a Convention of States meeting. Even though those claims are historically false, this resolution takes the uncertainty out of the process. With this question being definitively answered, we should expect The Framers' opponents to embrace this resolution. Sadly, I imagine they will not and raise other objections to this Constitutional process. We should have a thoughtful and meaningful discussion about solutions to unconstitutional governance. At some point however, it is reasonable to ask if they are so satisfied with the status quo that they will oppose your Constitutional obligation to use this remedy no matter what. The Framers were very deliberate in the words they used and processes they included in the Constitution. The Framers supported and adopted the state-led solution to propose Constitutional

amendments unanimously and without debate. I ask you to support this process as they did. Thank you for your service and the opportunity to testify in support of HB836. My name is Vivian Gontarz from Saint Charles, Mo. I'm asking you to support House Bill 836 (HB836) relating to the appointment and duties of commissioners to attend an Article V Convention of States. Although one-third of the commissioners and alternates could be sitting members of the general assembly, the other two-thirds will be comprised of well-informed citizens from across Missouri. Please give us the tools and the time to identify and recruit our commissioners, to define rules for running the Convention, and to start conceptualizing proposed amendments. We are not asking for money or personal benefit - only the opportunity to make our Federal government work better. Please vote HB836 out of committee with a favorable recommendation and allow the "Show-Me State" to continue to lead at the Convention. Thank you for your support!

It is the position of the Sierra Club to oppose any attempt to call an Article V Constitutional Convention in the United States. We therefore oppose House Bill 836. Throughout the 230-year history of the U.S. Constitution, an Article V convention has never been called. The unknowns surrounding a constitutional convention pose an unacceptable risk, particularly in the current polarized political climate. The risks are as follows: THREAT OF A RUNAWAY CONVENTION: There is nothing in the Constitution to prevent a constitutional convention from being expanded in scope to issues not raised in convention calls passed by the state legislatures, and therefore could lead to a runaway convention.INFLUENCE OF SPECIAL INTERESTS: An Article V convention would open the Constitution to revisions at a time of extreme gerrymandering and polarization amid unlimited political spending. It could allow special interests and the wealthiest to re-write the rules governing our system of government.LACK OF CONVENTION RULES: There are no rules governing constitutional conventions. A convention would be an unpredictable Pandora's Box: the last one, in 1787, resulted in a brand-new Constitution. We risk possibility that the process would be used to undo hard-won civil rights, civil liberties advances and environmental protections and undermine basic rights extended throughout history.THREAT OF LEGAL DISPUTES: No judicial, legislative, or executive body would have clear authority to settle disputes about a convention, opening the process to chaos and protracted legal battles that would threaten the functioning of our democracy and economy.APPLICATION PROCESS UNCERTAINTY: There is no clear process on how Congress or any other governmental body would count and add up Article V applications, or if Congress and the states could restrain the convention's mandate based on those applications. UNCERTAIN RATIFICATION PROCESS: A convention could try to re-define the ratification process (which currently requires 38 states to approve any new amendments) to make it easier to pass new amendments, including those considered at the convention. This happened in 1787, when the convention changed the threshold necessary for ratification.
