We have expressed our concerns to the sponsor, and while we appreciate the sponsor's intentions, we must oppose the language as currently written and will continue discussions with the sponsor.1. Changing the last day or first day in office for a Collector is clearly unconstitutional. X Section 3. Limitation of taxation to public purposes — uniformity — general laws — time for payment of taxes — valuation. — Taxes may be levied and collected for public purposes only, and shall be uniform upon the same class or subclass of subjects within the territorial limits of the authority levying the tax. All taxes shall be levied and collected by general laws and shall be payable during the fiscal or calendar year in which the property is assessed. Except as otherwise provided in this constitution, the methods of determining the value of property for taxation shall be fixed by law.2. For those leaving office it would make their last week and last day in office their busiest. For the new Collector it would be their second busiest. Must balance and distribute the bulk of taxes, create a delinquent tax book and an annual settlement, among a few.3. Collectors have a huge amount of mail marked December 31st that keeps arriving for several days in January and books aren't closed until it is IRS rules state that if you retire you can't return to the office for thirty days accounted for. 4. thereafter so a collector would not be able to complete all of the tasks required before they were to leave office.
