The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse and social justice in St. Louis and beyond. To that end, we stand in strong opposition to Senate Bill 26, which is being considered by the House Crime Prevention Committee. Our Jewish community believes in the power of dialogue and debate. From our earliest Biblical stories in which Abraham argues with God against destroying the people of Sodom and Gomorroh, we have a model of leadership that recognizes the importance of speaking out and demanding justice. Sometimes, like in that story, those objections are ultimately overruled. Other times, like later when Moses advocates on behalf of the Israelites in the desert. God relents. Regardless of the answer, though, what remains consistent is the process. Indeed, it is the very liberties of the First Amendment afforded by this country that has enabled our Jewish community to find a home in America when our co-religionists were attacked and even killed in other places. Freedom of speech is the cornerstone of American democracy for all who reside in her midst. And even when history has shown the answer to be no, the speech nevertheless remains essential. Further, Jews believe in the concept of B'tzelem Elohim, we are all created in the image of God. This includes police officers, community members, those involved in protest, and those quilty of a crime. The events across the country this past year, along with challenges in Missouri, have shown us the need to establish standards for law enforcement to treat all communities with dignity and limited use of force against minority communities. SB 26 does just the opposite. It effectively undermines the freedoms of the First Amendment and silences the very discourse that makes our country and our region strong. It creates new crimes and enhances existing penalties in a direct attempt to limit speechillegal to obstruct traffic. By increasing obstructing of highways to a felony with lengthy prison sentence - it will lead to the targeting of protestors for arrest and lengthy prison terms for non-violent free-speech offenses. • It eliminates probation or parole for individuals who are convicted of assaulting law enforcement during a protest. • This bill included provisions that would make it exceedingly difficult to hold to account police officers who have acted abusively during protests. It puts onerous requirements on individuals who wish to bring a complaint against and officer and changes that way that investigations against officer conduct can be investigated. It further shields officers against civil claims made against them in their official and individual capacities, which reduces officer accountability. Protecting the due process rights of all is important; however, equality before the law is paramount. We must not afford law enforcement officers particular privilege simply by nature of their employment, especially when they are being investigated for failures in the course of their duty. SB 26 sanctions violence against protestors while misusing the criminal justice system to jail those who dissent. Moreover, this law, and others like it, will disproportionately prosecute already

marginalized voices who use protest as a mechanism to be heard in institutions where they are voiceless—indeed, the very intention of our founding fathers who protested their own oppressors. SB 26 is an overreach of the state's power. It is bad for Missouri. The JCRC of St. Louis urges you to oppose SB 26.

This bill is only an attack on first amendment freedoms, as well as a grab for the voting rights of those who would stand against the current injustices found in every level of our governing systems. The fears are imagined, the safety risk is made up, the threats it addresses are not reality. I have lived in Missouri my whole life, I earned the rank of Eagle Scout in Fenton, graduated high school in Cedar Hill, got my Criminal Justice degree in St. Charles (where the concerns prompting this bill come from): I have lived with police officers, been best friends with them for years, and I have police in my family. I have never seen such a complete moral breakdown as I have in the support of this bill. I have been blocked by protests long before ever being involved in them, and I have blocked roads and interstates as a part of protests. When blocked I felt no fear, and when other Missouri residents were blocked by protests on the interstate, they left their vehicles and joined the protest eagerly. Never has a protest in Missouri blocked emergency vehicles, nor any vehicle who voices an emergency need. Protesting is not for fun, it is not an attempt to cause harm, it is simply to get a message heard. A bill like this will not result in less blocking of the roads, but will create an even larger need to. Injustice is the cause for protest. This bill is a great injustice. There are already laws to make blocking traffic illegal, there is no need for this bill. The bill is a targeted effort to not only get protestors hurt, but to criminalize protest ultimately resulting in the revocation of voting rights. I am so ashamed of our Missouri lawmakers who might support such disgusting and devolved ideas. These days I spend my time at the protests as a trained street medic; the people who organize and train the street medics for protests are paramedics and trauma surgeons, and those people organize and train for those efforts because it is well known that the people who need the most support in the streets, and deserve the most support, are the ones fighting for justice and fairness and progress. This bill is a transparent attempt to get a specific group of Missouri residents hurt, criminalized, and unable to vote. The Missouri residents will forever see the laws their state has made, they will know who is responsible for the destruction of democracy in Missouri, and this bill will be high on the list of dangerous and radicalizing policy. What a shameful thing to support, and what a disappointing thing to make a life's work which instead could be used to actually create a legacy of progress and betterment for all of Missouri.

I'm writing today to urge you to vote no on Senate Bill 26. I have taken time to do so because this is a bad piece of legislation that should not become law, and I want to make sure that this committee realizes that it faces strong opposition in all corners of the state. Missouri faces a host of problems that deserve your attention, and despite the fact that in its current form it would provide greater resources to address one real problem, it would create more problems than it would solve. The provisions in this bill providing greater support for public servants facing mental health crises as a result of their service are admirable, but they are coupled with poison pills that make the bill unacceptable. I oppose this bill because it will do three things that will be bad for Missouri. In order of appearance in the bill these are: pre-empting the ability of local jurisdictions to manage their own budgets based on local needs and priorities; creating a new, unnecessary felony charge for citizens who engage in protest activity that historically has proven highly effective in advancing the struggle of Americans to gain full civil rights and participation in our democracy, especially those of Black people; and hindering the ability of law enforcement professionals to investigate and hold accountable officers who engage in unethical, unprofessional, or unlawful behavior that harms our people.l am writing because I love the people of Missouri and the people of my community and I love democracy, and I wake up each day on a mission to make this state a better place to live for all of us. I live a life of service to others, and I have served my community as a social worker, and one of the focuses of my work in that area has been the issue of homelessness. I have researched the issue in my community and became very familiar with it in my service as the chair of the Homeless Count Taskforce of the Ozarks Alliance to End Homelessness, I addressed the Governor's Committee to End Homelessness about how better to understand the problem in our communities, and I have directly served adults and youth living on our streets in a professional capacity and as a volunteer. Most recently, I worked as a volunteer overnight one night a week last winter, supervising a crisis cold weather shelter and I volunteered with a local church's street outreach team two nights a week, to help ensure that none of my unhoused neighbors lost life or limb during this winter's crisis. In Springfield where I live, we have an unprecedented number of our neighbors living on our streets, and poverty levels above the state average. One reason that many live in poverty and cannot secure housing for themselves is previous felony convictions. Many employers and landlords throw job applications and rental applications in the trash if the applicant was previously convicted of a felony. These convictions create barriers that prevent people who have gone wrong but who have paid the costs of their mistakes from gaining employment and accessing basic housing to survive. When people have no money and nowhere to go, they end up trespassing to try to survive. They end up doing what they must to get food to eat and shelter. They end up in crisis in our emergency rooms. They end up medicating themselves with drugs and alcohol to try to escape the pain of freezing temperatures and the loneliness of being cast out and unwanted. Our police officers often end up in contact with our unhoused neighbors, and they spend a

lot of time assisting and sometimes arresting them. This is a burden that they are not properly trained or equipped to bear, and it's not their job. But this bill would preempt my community's ability to shift funding away from policing problems like homelessness, mental health crises, and nuisance crimes stemming from addiction, which is the most expensive way to deal with these issues, and prohibit us by law from putting it into solutions where funds are used inefficiently that could actually get people through crises and into achieve stability, helping to reduce the need to allocate taxpayer funds at all over time. That doesn't make any sense, and it's not what we sent you here to do. Your job is to solve problems, not to create them by tying the hands of local leaders, so that they can't set their own budgetary priorities. Pre-empting local control over our own budgets won't help us make the job of law enforcement more manageable, and its provision creating a new felony charge for walking in the street will actually make it harder. When I have seen people out in the streets in protest in this state, it has been a strategic choice to bring about accountability from public servants in government. The first amendment to our constitution explicitly enumerates the rights of the people to do so, and it does not specify where or when the people are allowed to peacefully assemble and seek redress of their grievances. The rights of Black people and women and workers, rights which we consider cornerstones of the American way of life were won in part by strategically taking to the streets en masse to demand that the government listen. You were not sent here to limit those rights and make criminals of us for exercising them. Two years ago, the General Assembly passed a deeply unpopular law limiting women's access to healthcare, and as a result of that action, a protest happened in my community. During that protest, police stood by and watched as a violent street preacher engaged in counter-protesting verbally abused and assaulted protestors. This preacher was recently arrested and charged with domestic violence against his partner, which surprised none of us who have followed his years of anti-social behavior on our streets. One example of what I mean is that on the day of the protest I described, witnesses claimed to observe him shoving protestors, spitting on them, and striking them in the face with a block of wood, which he had disguised to look like a Bible. One victim of these assaults was a local minister, a white person, who was arrested without violence by police after he pushed back in self-defense. However, another protester who claimed she was assaulted that day by the street preacher was a slender young Black woman, who also acted in self defense. Police stepped in when she did so and violently arrested her, throwing her down with great force onto the street, which led to several onlookers jumping to her defense. The street preacher was led to safety by police during the melee that ensued when they attacked the young woman, and he was not arrested or charged with any crime. Many people in the community were appalled at the apparent disparity in treatment by the police of the protestors and the street preacher who was counter-protesting them. This was only one of many high-profile, racially-charged incidents in our community that spring, and many believed that too many local leaders were turning a blind eye to racism in our schools, on our streets, and in our governmentThe following weekend, a march and rally took place, calling on local leaders, including local law enforcement to hold themselves accountable to address systemic racism and to remember that they are there to serve all of us. Hundred turned out to march, including several of the same local clergy and community servants who this winter have been lauded publicly for their work sheltering our unhoursed neighbors. That march took place in the street and went directly past our local police station, and this bill would make each participant, including those treasured community servants into felons. Last summer, another march in support of the uprising across the country seeking justice for Black people took that same street. It drew over 3,000 Springfieldians. This bill would turn those 3,000 Springfieldians into felons. That is a misuse of the power vested in you by the people of Missouri, and is a law that if passed would be deeply unpopular, even in Springfield, which is not known as a hotbed of liberal discontent in Missouri. Voting yes would be a serious mistake. Finally, I want to turn my attention to the final provision of this bill that makes it unworthy of your support. When I began my comments, I pointed out admirable provisions that on their face would support law enforcement, so I am puzzled by the provisions later in the bill that seek to make more difficult the job of officers assigned to investigate wrongdoing among their colleagues. I've been told many times that good officers don't like the bad ones and they want them disciplined or fired, because they make everyone else's jobs harder to do. That's why I am concerned that this bill appears to side with the bad apples against the good ones, limiting the power of investigators to effectively question colleagues accused of misconduct and forcing them by law to provide bad apples with time to cover their tracks when they find out that they're under investigation. To be clear, the protests that this bill seeks to criminalize are demanding police accountability, so if that happened the protests would be unnecessary. Criminalizing them won't create accountability, so it seems doubtful that this bill would stop them from happening. What seems like it would stop them is empowering and supporting investigators who are charged with uncovering bad behavior and making accountability possible. This says it wants to support law enforcement, but when you really look into it, the bill seems not only to want to make it illegal for protestors to call attention to what gets swept under the rug, but also to make it harder for law enforcement officers to clean their own house, and officers themselves tell us

that bad colleagues make their jobs harder. Given that, despite its good points, this bill seems to do relatively little to support good, hard-working law enforcement officers, and a lot to tie the hands of local government, of citizens, and of law enforcement officers themselves who are working together to make the system better. For all these reasons, I urge you to vote no.

I suggest striking the changes to 557.045, as those correspond to SB74 and should have been considered with that bill instead. I would also suggest striking all of 574.045, as I believe this violates the Bill of Rights laid out in the Constitution, and will be unenforceable if it's brought to the Supreme Court. I have participated in peaceful demonstrations with or without governmental permissions, and both were safe. The more police officers involved, the less safe the event felt; they brought drones, firearms, and the threat of lethal force. Protections of public structures and monuments- see 574.085 (7)- are being employed to apply stricter punishments for people defacing monuments to leaders of the Confederate States of America. There is already a provision -see 574.085 (2)- which punishes those who deface anything which "memorializes the dead."Either strike or revise 590.192 "988 Public Safety Fund." Sen. Eigel neglected to do what Sen. Bean's SB74 did, which was to consider additional aspects of public safety, so without including fire fighters and first responders in this portion of the bill. It's clear he cares about punishing he public, not public safety. Strike 590.502. These provisions hardly mention the claimant. Denying confidentiality to the claimant when they are a fellow officer will decrease the already low rate of complaints against officers who don't do their job correctly. My name is Elad Gross, I am an attorney in Missouri, Over the last several years, I have worked with both law enforcement officers and those protesting for change in Missouri's justice system, especially when it comes to accountability. Accountability is important for both civilians and first responders. Accountability allows our state's residents to trust their public servants, and it allows officers to trust one another. That trust is crucial for a functioning justice system that encourages cooperation, leads to convictions of dangerous criminals, and improves public safety. One of the most important parts of accountability is transparency. This bill significantly reduces that transparency by exempting specific public records from Missouri's Sunshine Law. As this body knows, some of these records are already subject to Sunshine Law exemptions. The exceptions currently in the Sunshine Law already permit departments to keep sensitive information of ongoing investigations confidential. Keeping those records hidden from the public forever helps no one, especially not the officers this bill appears to be designed to protect. Hiding records of investigations into misconduct can only engender less trust in our police system. Additionally, clamping down on protests instead of providing additional funding to oversight organizations like POST or increasing transparency will lead to more, not less disappointment, disagreement, and unrest. Reasonable Missourians agree that our state needs additional accountability, that local government should be controlled locally, and that no one should be above the law, including those sworn to uphold it. I highly encourage this body to accept accountability and local civilian oversight into our justice system and shift its priorities to those measures we know work. Thank you for your service.

House Bill 1265 will allow workers' compensation insurers to circumvent payment to the health insurer. Absent direct payments to health insurance plans, there leaves a potential of the health insurer to resort to collection efforts against the employee out of the often paltry financial recovery in a workers' compensation claim. This would in turn shift the cost of what should be incurred by the workers' compensation coverage, instead becoming an added burden to the health insurer. This will create a shortfall in the amount of dollars per hour from which to bargain for wages, pensions, and fringe benefits. Also, this bill would parse out a current injury without considering the need to treat the problems arising from a combined effect of prior injuries. Not all injured workers are eighteen years-old with a history of being in perfect physical condition. Currently, those who have prior injuries from any cause including work, and conditions such as arthritis in joints, presently are entitled to treat the result of the compensable or accepted work-related injury. This bill could create a scenario that allows the employee to get an incorrect form of treatment due to only considering the last injury and not the combination effect of the work injury and the previous injury. A local grassroots organization that strives to build political power for Black people in St.Louis. I am writing to express my strong opposition to SB 26. This bill will silence our voices and criminalize Black Missourians who stand up for our communities. Our right to assembly, free speech, and protest are foundational to a democracy for the people. SB 26 will damage first amendment rights. Senate Bill 26 is trying to silence us and keep us from coming together for justice and our communities. It is a direct attack on past movements like the civil rights movement and present outcries for change like the Ferguson Uprising. Missouri has a long history of protesting to increase minimum wage, fight segregation, protect workers rights, and end police violence. This bill is trying to make it so people stay complacent to oppressive structures and institutions. Under Senate Bill 26, taking part in direct action will result in server penalties. This is a direct attempt to criminalize democracy. Protestors could be fined and potentially imprisoned for democratically showing up and speaking out. Under Missouri law it is already a misdemeanor to obstruct traffic without a permit. People have and continue to face arrest for highway shutdowns. SB 26 will make obstructing the highway a felony charge with higher fines and a prison sentence of up to 7 years. The bill also provides protections for law enforcement under investigation for misconduct or excessive force. (Be clear - I am NOT referring to riots, which do threaten harm.)Lawyers.com states..."As is true for limits on free speech, courts have held that government may set rules on where, when, and how public protests and other gatherings can take place, as long as those rules are:- reasonable-"content neutral," meaning they to aren't an attempt to squelch demonstrations or other gatherings based on their political message, and- are "narrowly tailored," meaning they're designed to serve legitimate concerns (like health and safety) with as few restrictions as possible on constitutional rights."Lets look at these one at a time.REASONABLEThe size limitation is unreasonable. 2 or more people assembling is unlawful? Will I be arrested if I talk to 4 of my neighbors standing on the sidewalk on the Plaza in Kansas City. In theory, as I read the law, we could be. The same website states..."A federal court struck down an ordinance that limited the size of most gatherings in front of New York City Hall and the adjacent plaza, except for city-sponsored public events. As the court pointed out, the ordinance wasn't narrowly tailored to serve the city's legitimate safety concerns, and it could allow city officials to stop people from gathering based on their point of view. (Housing Works, Inc. v. Safir, 101 F.Supp.2d 163 (S.D. N.Y. 2000).) There are no legitimate safety concerns addressed by defining an assembly as 2 or more people. CONTENT NEUTRALWhy now? While I will agree that the wording doesn't not specifically call out specific political views or beliefs, I do believe that the introduction of this bill is reactionary pushback to the outpouring of citizens, across this country, to let their representatives know where they stand on important issues such as policing concerns and systemic racism. I didn't see any such bill introduced when protestors have been gathering to advocate their anti -abortion positions - and there are WAY more than 2 people gathered. This discrepancy indicates to me that this bill is implicitly NOT content neutral. This is intended to silence citizens. Will our only course of action be to send emails to Jefferson City, only to get a canned response back? To leave voicemail messages to which we get no reply? In case you've forgotten, we have a representational democracy which means all opinions need to be heard and discussed.NARROWLY TAILORED, DESIGNED TO ADDRESS PUBLIC CONCERNS (LIKE HEALTH AND SAFETY)SB26 states ""A person commits the offense of unlawful traffic interference if, with the intention to impede vehicular traffic, the person walks, stands, sits, kneels, lays, or places an object in such a manner as to block passage by a vehicle on any public street, highway, or interstate highway." That doesn't sound to me to be narrowly tailored nor does it address public concerns of health and safety. We've seen demonstrations in which assembled persons, PEACEFULLY, walked the streets of Kansas City in protest. To completely outlaw all slowing or blocking of traffic does not meet the established bar. And, when permits are granted, the police have a responsibility for re-routing traffic to ensure safety of demonstrators and drivers. I do

notice that you didn't say run so I guess all those marathons that are run on public streets are OK - despite the impeding of traffic, which they certainly intend to do so they don't get hit by a car while running (health and safety concerns). And there are certainly more than 2 people assembling. As a final point, I also believe that this bill will disproportionately impact persons of color, who have been assembling to make their voices heard regarding the deaths of black persons as the hands of police, evictions (who tend to be evicted?), etc. If this is true, it is another law that promotes and supports a racist legislative infrastructure. As part of our work, we organize a statewide coalition called the Smart Sentencing Coalition. This coalition is made up of individuals and organizations who are working for a smarter criminal justice system that works to decrease recidivism, decrease the prison population, decrease Missouri's criminal justice costs all while ensuring our community is safe. A 2019 study published by the National Academy of Sciences shows that police violence is a leading cause of death for young men in the United States. Over the life course, about 1 in every 1,000 Black men can expect to be killed by police. Black women and men are significantly more likely than white women and men to be killed by police. Studies suggest that implicit bias contributes to "shooter bias"—the tendency for police to shoot unarmed Black suspects more often than unarmed white suspects. And yet, we've been slow to address this issue with law enforcement, and every year, outrage in the community grows as we watch innocent Black men suffer at the hands of police officers with little to accountability. As we speak, there is a trial going on in St. Louis City of three white St. Louis police officers who assaulted a Black undercover colleague during the protests surrounding the acquittal of Jason Stockley in 2017. It is right and just for citizens to stand up and protest these and other injustices in our communities. The First Amendment quarantees our rights to the freedom of assembly and the freedom of speech. Blocking traffic is an effective tool utilized by protestors to draw attention to critical issues related to racism, policing, and criminal justice reform. Criminalizing this activity, which may cause an inconvenience (as intended) but little risk of harm to others, is an assault on our fundamental rights. An overzealous bad actor might be tempted to stir up something that would look like trouble, easily targeting those who may be perceived as "the enemy." This is no so far-fetched, as history has shown us. This bill is over-reach and meant to target those who speak out rather help solve the underlying issues that led to the protests in the first place. Protests are the voice of unheard, people have to have a right to voice their opposition or support of things that matter. Violence should not be accepted, but peaceful protests are our right. Prayer is our right, too, so kneeling during protests should not be prohibited. This proposal is against freedom of speech and therefore should not be passed.

This bill is a direct attack on the tradition that has been a part of the fabric of America, the right to assemble publicly and engage in direct action from the Boston Tea Party to the March on Washington and other acts during the historic Civil Rights Movement this tradition has been a tool of working toward democracy. We oppose this bill and we hope that you will too. As faith leaders it has been important to us to be in solidarity with those in our pews, our communities and any who are vulnerable. We hold dear not just the memory of great religious leaders like Reverend Dr. Martin Luther King and Rabbi Abraham Heschel and lay people of faith like Rosa Parks but the model of the work they engaged in whether marching in Selma, the streets of Birmingham, DC, St. Louis or Jefferson City. As faith leaders we have engaged in sacred acts of protests from the Boot Hill to Kansas City. This bill not only jeopardizes our right to do so but it also seeks to criminalize those of us who follow the advice of the great abolitionist Fredrick Douglas and pray with our feet. We urge you to consider the costs to religious leaders, innocent, hard working and courageous Missourians like those who fought for tenants rights in the early 1900's and those of us who fight for equity, fair wages and justice now to ensure that all of GOD's children have what they need. The front page of the Springfield News-Leader 3/19/21 reports a lawsuit against the Aya, MO Police Department, claiming a wrongful death caused by Officer Kaleb Berkshire who knelt on the back of his detainee for several minutes, perhaps causing positional asphyxia death. I was struck, not only by the gruesome details of the incident, but by this statement about Officer Berkshire: "Ava Police Chief Reggie Johnson said Berkshire is no longer employed by Ava Police. He said Berkshire resigned and took a job with another department." Regardless of Berkshire's "fault" or lack thereof in this case, the fact that he could resign and then go elsewhere for law enforcement employment is a concern.SB 26 seems to reinforce due process protections for law enforcement officers without addressing accountability and transparency issues that seem paramount in restoring the public's trust in this vital profession. There are some good proposed bills that would increase licensure standards, provide for databases to track excessive use of force and officer malfeasance, and give law enforcement administrators better tools for maintaining departments that demonstrate the highest integrity and accountability. SB 26 does not seem to be one of those proposals. I encourage your thoughtful consideration that SB 26 does not contain the elements of training, licensure, accountability, and transparency that could help restore public confidence in Missouri's law enforcement. This lack of state funding could have ramifications of public health issues such as COVID.- A protest is a public event and there are members of the public who are also at that location. People are standing or passing through on streets that could include members of the press who are trying to get a vantage point for the event. There are also bystanders or people passing through who are not involved in the protest. Blocking or hindering traffic could be an unintentional act. You could be potentially criminalizing bystanders and people doing their jobs.-Furthermore, the bill specifically states one of the actions that is considered unlawful is kneeling, which clergy people often do in a posture of prayer. Members of the clergy also have First Amendment Rights.- It defines an unlawful assemblage as 2 or more people. This definition is a slippery slope and could potentially criminalize a long list of everyday activities. -Who is charged for a felony if there is significant property damage? Again, a protest is a public event. Organizers may have one intent, a peaceful demonstration, yet there are opportunists not associated with the protests who use the event for cover for nefarious activities. Should the organizers be charged because there was a co-occurrence of two events? Additionally, what happens if police officers or the National Guard causes property damage while trying to perform crowd control. Sometimes military tanks are used. Tanks are rough on streets and other infrastructure. Do LEOs and the National Guard get charged with a felony?to echo the concerns of St. Louis Police Commissioner, Colonel James Hayden - "Senate Bill No. 26 significantly interferes with our ability to meet the expectations of Missouri residents with respect to holding officers accountable for sustained allegations of employee misconduct."Granted, the intent should be to allow for individuals to exercise their First Amendment rights while maintaining public safety and minimizing property damages. Unfortunately, this bill creates larger problems than the issues the bill is attempting to resolve.

My name is Stephen Eisele, the Executive Director of PROMO, Missouri's statewide (LGBT) lesbian, gay, bisexual, and transgender advocacy organization. On behalf of our organization, I am expressing our opposition to Senate Substitute for Senate Bill 26 being heard in committee this morning. The fact that I am able to present my voice to you today, an out-gay executive, is not without a deep history in our country of gay and transgender people exercising their first amendment rights to be viewed as equal among fellow Americans. It has often been through marches, protests, and raising their voices, that our community has been able to stand up against violence, persecution, and discrimination while making progress towards being viewed as equal under the law. Our work for safety and protecting our communities continues into the present. As noted by ACLU of Missouri and others, regulations already exist that restrict certain aspects of protest and create a distinction between protest and unlawful assembly. Senate Bill 26 would unnecessarily create new crimes and enhance existing penalties to directly limit speech while endangering the lives of those exercising their first amendment rights to speech. Designed to protect lives, this bill would likely have the opposite effect. The right to define an 'unlawful assembly' should be left to those trained in the law and not private citizens. We have seen the misuse of 'unlawful assembly' orders at demonstrations throughout Missouri in recent years and broadening its interpretation fails to create safer communities. I highly encourage the committee to vote against SB 26, this legislation is a threat to constitutional values. We know that too often in our state, and in our nation, legislation heightening penalties are used to prosecute marginalized voices, like LGBT Americans, including Black and Brown Americans, who rise up time and again to reject discrimination and have continued to be silenced. Senate Bill 26 would not only prevent transparency and accountability by protecting bad actors in law enforcement, it would further undermine the reliability of convictions, putting the freedom of innocent defendants and the safety of the general public at risk. I urge you to oppose SB 26. To date, 50 Missourians have been exonerated according to data from the National Registry of Exonerations. In those individual's cases, nearly half (24 of 50) involved police officer misconduct as a contributing factor to the wrongful conviction. This misconduct took many forms, including tampering with witnesses, fabricating evidence, concealing exculpatory evidence, engaging in misconduct during interrogations, and lying on the stand at trial. Indeed, Missouri's rate of misconduct in innocence cases surpasses even the national average, where police officers committed misconduct in 35% of the over 2,600 exonerations that have been revealed in the United States. Yet, rather than reducing or addressing these known unjust actions, SB 26 will protect officers who engage in misconduct, potentially contributing to or enabling future wrongful convictions. Wrongful convictions hurt not just the innocent individual who is incarcerated for a crime they did not commit, but also presents further harm to victims and society as the real perpetrator is allowed to go free. Of the nation's 375 DNA exonerations, for example, the real perpetrators have been identified in 165 cases. Those actual perpetrators went on to commit 154 additional violent crimes after the wrong person was convicted for their earlier offense, including 83 sexual assaults, 36 murders, and 35 other violent crimes. When the system gets it wrong, victims and public safety suffer. Public confidence in the criminal legal system is diminished. Missouri should learn from the 50 wrongful convictions to date and take measures to prevent further miscarriages of justice and reaffirm its commitment to justice for all Missourians. Yet, SB 26 does the opposite of this—shielding misconduct and protecting bad actors. Wrongful Convictions and Police Misconduct The credibility of law enforcement impacts every phase of a criminal case. From investigation to trial testimony, law enforcement is a critical part of the criminal legal system. And as such, greater transparency into law enforcement, not less, is needed to protect the integrity of the system. How can prosecutors, defense attorneys, and judges ensure that the jury is provided with accurate information if they are denied critical information about a police witness's prior misconduct or dishonesty? They cannot. Yet, that is the impossible system that SB 26, which renders police misconduct records confidential, would create. There is no public interest reason to protect state actors who have histories of lying, coercion and other misconduct. Instead, public safety demands we ensure that we get the evidence and subsequent convictions right. Indeed, states with

public access to police misconduct records shed light on the way that some officers involved in wrongful convictions have long histories of misconduct. One of the primary detectives in the Central Park Jogger case in New York, for example, had more than 40 civilian complaints lodged against him before the now Exonerated Five were wrongfully convicted. Similarly, Minneapolis officer Derek Chauvin had at least 17 misconduct complaints on his record before he took the life of George Floyd. SB 26 would ensure that any officer with a record of misconduct, such as these two examples, would have that record kept confidential unless subpoenaed or granted by court order, allowing the misconduct to continue unless extremely steep thresholds are met. Subpoena rights are a legal discovery tool not available absent a lawsuit and are an inappropriate threshold for making police misconduct records transparent. Many states make such records public via open records requests, a far cry from the level of secrecy outlined in SB 26. Ultimately, SB 26 is a step back from the court in Chasnoff v. Mokwa, which held that the records of substantiated misconduct in the performance of police officer's official duties is public under the public records laws. SB 26 would add an additional hurdle to obtaining important public records and would prevent evidence of misconduct from coming to light even though Missouri courts have previously held there is no privacy interest in withholding substantiated records. And such misconduct has occurred right here in Missouri. Take for example, the case of Missourian George Allen, Jr., who lost over 30 years of his life in prison for a crime he did not commit, in large part due to police misconduct. Mr. Allen was wrongfully convicted of murder and sentenced to 95 years in prison in 1982, after police mistakenly mistook Mr. Allen for an initial suspect who was known to have a history of sexual offenses. Although police realized that Mr. Allen was not the suspect, they questioned him anyway, ultimately physically and mentally coercing a false confession out of Mr. Allen, who had an extensive history of severe mental illness.In 2003, twenty years after Mr. Allen was wrongfully convicted, the Innocence Project re-opened Mr. Allen's case in hopes of turning up evidence that could be tested. Although the Innocence Project had previously been told that there was no evidence to test, the evidence was finally located and DNA testing proved that Mr. Allen was not the perpetrator. Lawyers also found previously undisclosed documents that showed that police had actually known Mr. Allen was excluded as the perpetrator by forensic evidence at the time and had never told prosecutors or defense. In 2012, a Cole County Circuit judge vacated Mr. Allen's conviction and ruled that the police had withheld critical evidence. "Most critically, the undisclosed evidence, considered together, points unavoidably to the conclusion that the police—and Detective Riley in particular—ignored and hid evidence pointing to someone else as the perpetrator in their zealous pursuit of Allen's conviction," the judge wrote. Tragically Mr. Allen died four short years after being exonerated. In 2018, two years after his death, the State of Missouri and city of St. Louis settled a civil lawsuit regarding this misconduct with Mr. Allen's family for \$14 million. It should not require the revelation of a wrongful conviction, after someone has lost decades of their life, to uncover egregious misconduct. Police officer disciplinary records should be transparent and available to the public, prosecutors, and defense and used to prevent further misconduct in the first place. Yet, SB 26 does the opposite of this, protecting misconduct from coming to light. Police Transparency in MissouriMissouri already significantly lags behind other states in police transparency. Nationally, thirteen (13) states—including Georgia, Florida, New York, Ohio and Illinois—provide complete public access to police disciplinary records. SB 26 would not only perpetuate this problem, but would add additional layers of secrecy, further sowing distrust with the public and protecting bad actors. Transparency benefits everyone, including the police, as it builds trust with the public and ensures only those who deserve to wear the badge may keep it. Secrecy around misconduct and discipline denies victims, judges, juries, and the public the opportunity to evaluate the fairness of the internal affairs investigation and understand whether an abusive officer ever faced any consequences. Even when a claim is not substantiated, there is benefit to transparency showing how that decision was made in supporting trust—internal and external—in the disciplinary process. Some investigations might show false allegations. Others may show that police can be disciplined for trivial things—like multiple violations for uniform violations. Still others can help minority law enforcement officers, particularly people of color and women in law enforcement, demonstrate if they are treated more harshly by Internal Affairs than their male and white counterparts. The ability to see how policing works and the integrity of the process builds trust. Conversely, hiding the entire disciplinary process perpetuates the public's fear that officers are not held accountable for causing harm and SB 26 goes even a step further in harming trust with the public by making it difficult to make a complaint. Protections not offered to innocent citizens. The system, as it currently stands, has built more protections for quilty police officers than it has for its innocent citizens. SB 26 adds several layers of privilege on top of the normal presumption of innocence that a normal citizen accused of a crime might enjoy. An officer accused of misconduct, for example, would be provided at least 24-hours notice before being questioned with access to the complaint and consideration for the time and location of questioning, as well as the promise to not be threatened, harassed, or promised rewards. Compare these rights under SB 26 to what an innocent person accused of a crime would receive. How would the investigation of a

crime look under these circumstances? Would police want a murder or robbery suspect to access the complaintbefore being questioned? Would they want the accused to be able to at least 24-hours before they could begin questioning? Would police themselves consider this a robust and adequate investigation? On the contrary, innocent citizens, like Mr. Allen, are not provided these protections even when their constitutional rights are on the line. Missouri should stay in-step with lawmakers around the country, who are considering how to increase, not decrease, authentic police accountability. This includes the state of Maryland, which passed the first Law Enforcement Officer Bill of Rights in the nation and which this year considered a bill to eliminate the harmful measure. SB 26 is a step in the wrong direction and will allow police misconduct to continue in darkness and lead to wrongful convictions. I urge you to oppose SB 26. In the summer of 2020, I attended a protest, As a disabled person, I had planned to attend, and if I became too exhausted or in too much pain I would call my husband to come and pick me up and drive me back to my car parked almost a mile away. During the protest, I watched my fellow protesters peacefully and lawfully assembling while police in riot gear stood in the streets, ready for confrontation. We continued to follow the law and protest peacefully, but as I predicted my disability caused me to become exhausted and my legs were in too much pain to continue. However, by the time I called my husband to come and get me, the police had created a perimeter so wide that it would have been impossible for him to come and help me. So I walked. I fell several times along the way because my disability made it difficult for me to leave the protest. By the time I reached the edge of the perimeter where I could wait for my husband, I had become so crippled with pain that it took more than a week for me to recover.I have been to many protests in my 25 years in Kansas City, and never before had I had such a difficult time with the simple act of leaving the protest. Had I not been able to leave, I, a disabled person, would have been tear-gassed along with the other peaceful protestors. I would have been crippled in a way that would have required medical intervention. How many other disabled protesters were not able to leave? How many were further injured? At what point did we decide that only able-bodied people could use their voice? Our First Amendment to the Constitution already grants us the right to assemble. In the protest I attended, it was the police, not the protesters, who blocked traffic with their bodies, cars, and perimeters. If protests spill out into the streets, should they be allowed to be punished by private citizens with bodily harm? Because that's what this bill will allow. How does a human being stand up against a vehicle in this case, even an able-bodied one? In passing this bill, you are furthering the damage to life and livelihood. Though my experience was a difficult one, I still plan to attend as many protests as I physically am able. I assure you, neither will this bill will be a deterrent to future protesters, so filled with the desire for change, to attend protests. Protesters will still spill out into the street. What this bill will do instead is invite retribution from counterprotesters and increase the violence that you pretend to want to end. It is a license to maim, and an attempt to silence voices. We will not be silenced.

The proposed 67,030(2) will only invite supporters of other departments to seek similar legislative protection for their budgets. The 12% figure is totally arbitrary and unrelated to the discretion that may be required in a particular budget situation. Proposed 574.045 1 (2), requires that the assembly be "knowing", but does not specifically require that the violation of law be "knowing." Obviously, an unlawful assembly statute can't rest just on the assembly being "knowing". That would be unconstitutional. Knowing assembly to carry out a known criminal act would seem a necessary criminal intent. Proposed 590.502 21 erroneously triggers the listed requirements for an investigation on what the OFFICER reasonably believes. How will investigators ever determine what the officer reasonably believes before or during an investigation? The proposal should just use as a trigger the existence of a reasonable basis that an investigation could lead to disciplinary action, etc. This would put the burden on the investigator to follow the listed requirements or risk a blown investigation. Proposed 590.502 4 (6) is an unwarranted chill on investigative action. No one can ever know for certain whether an investigation/allegation of misconduct will be upheld in the final analysis (uncertainties of testimony and deciders of fact/law, appeals, etc.). In our legal system, people normally are expected to defend themselves, which may have economic consequences. The exception is a "bad faith" claim. If retained, the economic loss provision should be limited to instances Proposed 590.502 10 is vastly over broad. As drafted, this provision would void any action for violation of ANY provision. Clearly, some violations would have no significant bearing on the outcome. It is one-sided and way out of proportion to invoke the sanction of voiding any action when there may be no cause and effect between the violation and the action.
