Dear Mr. Chairman and members of the committee, My name is Angie James, I am here to speak out in opposition of SB 91. I'm doing so because it would impose more restrictions on my husband. My husband and I have three children ages 4, 10, and 13. They are very involved in activities in our community. If this bill passes, it would restrict their dad from attending the majority of their travel soccer games and several other extra curricular activities they would participate in throughout the year. My husband made a bad decision almost 10 years ago. He regrets this decision every day of his life. It affected our marriage, as well as his participation in the activities of our family's life. He can't serve in our church for outreach activities held at the local park, he can't attend picnics and play dates at the park or water park, he's unable to go on camping trips for an inexpensive getaway weekend, and the list goes on. People. Make. mistakes. Many people are able to move on with their lives after paying the consequences. My husband has paid his consequences for a misdemeanor offense. We long to move on with our lives, but this continues to follow us. Enough additional restrictions. We need to return to a somewhat normal life. At the least, this bill could contain an exception for parents attending these facilities for their children's activities. This bill also does not specify a time limit. This is another forever restriction for him. What about adding a time limit of 10 years without incident? How about including verbiage stating the new restrictions wouldn't apply retroactively to past offenses? My husband is not the only person that feels these restrictions. Our whole family lives these restrictions day in and day out. Please consider these changes to the bill.

Remove misdemeanor or low risk offenses from this bill entirely or create a timeline such as 5 years for misdemeanor offenses/10 years for felonies because it just doesn't make sense to have a permanent ban when people have already paid for their crimes. 3 Include verbage stating the new restrictions will only apply to those whose offenses occur after this bill passes. There is no mention of the statute being applied retroactively. I would like to see something about this since it violates the ex post facto clause of the constitution if applied to people's offenses that occurred before it was written.

Dear Mr. Chairman and members of this committee. My name is Briana Downing. I am testifying in opposition of SB 91 on behalf of my friend Josh James, who has a nonviolent misdemeanor offense. I am asking this committee to consider the unjustified ramifications that these proposed additional restrictions would have on those who have fallen through the cracks of a seemingly broken judicial system. We are family friends as well as fellow church members with the James's. Our children are of similar ages in many of the same activities. It is heartbreaking to watch Josh time and time again be denied the opportunity to be with his family and support his children in the activities they participate in, as well as being limited in the outreach programs our church supports. This hurts the family unit. Josh's offense is a nonviolent misdemeanor, not even registerable in the state of Missouri, but has defaulted to the most oppressive and restricted tier reserved for the most violent felony offenders, which is tier 3, because of a broken system. This has to be corrected. I appeal to the hearts of this committee and to the duty you each have to our justice system to help reform these oversights. Please consider, at the least, amending this bill to allow for such individuals, who have grievously been overlooked, to have an exception to attend these facilities for their children's activities. The bill also does not specify a time limit, which is another added restriction. Please help bring about change to support and strengthen the family unit and stop putting more restrictions on those that have fallen through the cracks. Thank you for your time today.
