The Missouri Catholic Conference (MCC) supports adoption of Senate Concurrent Resolution 3, condemning the Missouri Supreme Court decision that denied U.S. citizenship and freedom to Dred and Harriet Scott based upon their race and status as slaves. The 1852 court decision, along with the U.S. Supreme Court decision that followed, is a legacy of the shameful institution of slavery and the Missouri Compromise, by which Missouri's statehood was granted on the condition that slavery be lawful in Missouri, but unlawful in unincorporated territories west and north of Missouri's southern border. Since 2021 is the 200th anniversary of Missouri's statehood, it would be fitting for the Missouri General Assembly to issue this resolution to acknowledge the reality that slavery denied persons of African descent equal dignity as fellow human beings made in the image and likeness of God. The MCC hopes that passage of SCR 3 will help begin to heal the wounds of racial division that continue to plague this state and nation. The MCC encourages this committee to vote SCR 3 "Do Pass".
