1 AMEND House Committee Substitute for Senate Substitute for Senate Bill No. 690, Page 59,
2 Section 198.648, Line 9, by inserting after all of said section and line the following:

4 "208.030. 1. The family support division shall make monthly payments to each person who
5 was a recipient of old age assistance, aid to the permanently and totally disabled, and aid to the blind
6 and who:

7 (1) Received such assistance payments from the state of Missouri for the month of
8 December, 1973, to which they were legally entitled; and

9 (2) Is a resident of Missouri.

10 2. The amount of supplemental payment made to persons who meet the eligibility
11 requirements for and receive federal supplemental security income payments shall be in an amount,
12 as established by rule and regulation of the family support division, sufficient to, when added to all
13 other income, equal the amount of cash income received in December, 1973; except, in establishing
14 the amount of the supplemental payments, there shall be disregarded cost-of-living increases
15 provided for in Titles II and XVI of the federal Social Security Act and any benefits or income
16 required to be disregarded by an act of Congress of the United States or any regulation duly
17 promulgated thereunder. As long as the recipient continues to receive a supplemental security
18 income payment, the supplemental payment shall not be reduced. The minimum supplemental
19 payment for those persons who continue to meet the December, 1973, eligibility standards for aid to
20 the blind shall be in an amount which, when added to the federal supplemental security income
21 payment, equals the amount of the blind pension grant as provided for in chapter 209.

22 3. The amount of supplemental payment made to persons who do not meet the eligibility
23 requirements for federal supplemental security income benefits, but who do meet the December,
24 1973, eligibility standards for old age assistance, permanent and total disability and aid to the blind
25 or less restrictive requirements as established by rule or regulation of the family support division,
26 shall be in an amount established by rule and regulation of the family support division sufficient to,
27 when added to all other income, equal the amount of cash income received in December, 1973;
28 except, in establishing the amount of the supplemental payment, there shall be disregarded cost-of-
29 living increases provided for in Titles II and XVI of the federal Social Security Act and any other
30 benefits or income required to be disregarded by an act of Congress of the United States or any

1 regulation duly promulgated thereunder. The minimum supplemental payments for those persons
 2 who continue to meet the December, 1973, eligibility standards for aid to the blind shall be a blind
 3 pension payment as prescribed in chapter 209.

4 4. The family support division shall make monthly payments to persons meeting the
 5 eligibility standards for the aid to the blind program in effect December 31, 1973, who are bona fide
 6 residents of the state of Missouri. The payment shall be in the amount prescribed in subsection 1 of
 7 section 209.040, less any federal supplemental security income payment.

8 5. The family support division shall make monthly payments to persons age twenty-one or
 9 over who meet the eligibility requirements in effect on December 31, 1973, or less restrictive
 10 requirements as established by rule or regulation of the family support division, who were receiving
 11 old age assistance, permanent and total disability assistance, general relief assistance, or aid to the
 12 blind assistance lawfully, who are not eligible for nursing home care under the Title XIX program,
 13 and who reside in a licensed residential care facility, a licensed assisted living facility, a licensed
 14 intermediate care facility or a licensed skilled nursing facility in Missouri and whose total cash
 15 income is not sufficient to pay the amount charged by the facility; and to all applicants age twenty-
 16 one or over who are not eligible for nursing home care under the Title XIX program who are
 17 residing in a licensed residential care facility, a licensed assisted living facility, a licensed
 18 intermediate care facility or a licensed skilled nursing facility in Missouri, who make application
 19 after December 31, 1973, provided they meet the eligibility standards for old age assistance,
 20 permanent and total disability assistance, general relief assistance, or aid to the blind assistance in
 21 effect on December 31, 1973, or less restrictive requirements as established by rule or regulation of
 22 the family support division, who are bona fide residents of the state of Missouri, and whose total
 23 cash income is not sufficient to pay the amount charged by the facility. ~~[Until July 1, 1983, the~~
 24 ~~amount of the total state payment for home care in licensed residential care facilities shall not~~
 25 ~~exceed one hundred twenty dollars monthly, for care in licensed intermediate care facilities or~~
 26 ~~licensed skilled nursing facilities shall not exceed three hundred dollars monthly, and for care in~~
 27 ~~licensed assisted living facilities shall not exceed two hundred twenty-five dollars monthly.~~
 28 ~~Beginning July 1, 1983, for fiscal year 1983-1984 and each year thereafter,]~~ The amount of the total
 29 state payment for home care in licensed residential care facilities and for care in licensed assisted
 30 living facilities shall ~~[not exceed one hundred fifty-six dollars monthly,]~~ be subject to appropriation.
 31 The amount of total state payment for care in licensed intermediate care facilities or licensed skilled
 32 nursing facilities shall not exceed three hundred ninety dollars monthly~~], and for care in licensed~~
 33 ~~assisted living facilities shall not exceed two hundred ninety-two dollars and fifty cents monthly].~~
 34 No intermediate care or skilled nursing payment shall be made to a person residing in a licensed
 35 intermediate care facility or in a licensed skilled nursing facility unless such person has been
 36 determined, by his or her own physician or doctor, to medically need such services subject to review
 37 and approval by the department. Residential care payments may be made to persons residing in
 38 licensed intermediate care facilities or licensed skilled nursing facilities. Any person eligible to
 39 receive a monthly payment pursuant to this subsection shall receive an additional monthly payment

1 equal to the Medicaid vendor nursing facility personal needs allowance. The exact amount of the
2 additional payment shall be determined by rule of the department. This additional payment shall not
3 be used to pay for any supplies or services, or for any other items that would have been paid for by
4 the family support division if that person would have been receiving medical assistance benefits
5 under Title XIX of the federal Social Security Act for nursing home services pursuant to the
6 provisions of section 208.159. Notwithstanding the previous part of this subsection, the person
7 eligible shall not receive this additional payment if such eligible person is receiving funds for
8 personal expenses from some other state or federal program."; and
