Every such petition shall be filed with the secretary of state 8 not less than six months before the election and shall contain an enacting clause and the full text of 9 the measure. Petitions for constitutional amendments shall not contain more than one amended and 10 revised article of this constitution, or one new article which shall not contain more than one subject 11 and matters properly connected therewith, and the enacting clause thereof shall be "Be it resolved by 12 the people of the state of Missouri that the Constitution be amended:". Petitions for laws shall 13 contain not more than one subject which shall be expressed clearly in the title, and the enacting 14 clause thereof shall be "Be it enacted by the people of the state of Missouri:". For purposes of this 15 article, only citizens of the United States of America who are residents of the State of Missouri and 16 who are properly registered to vote in the State of Missouri shall be considered legal voters. 17 2. Notwithstanding Section 2(b) of Article XII of this Constitution, or any other provisions 18 of this Constitution or laws to the contrary, if two-thirds of the votes cast thereon are in favor of any 19 amendment, whether proposed by the general assembly or by initiative, the same shall take effect at 20 the end of thirty days after the election. 21 Section 50 (a) Beginning January 1, 2023, initiative petitions proposing amendments to the 22 constitution shall be signed by ten percent of the legal voters, registered to vote in Missouri and
