9	of the fund and may approve disbursements from the fund in accordance with sections 30.170 and
10	30.180. Upon appropriation, money in the fund shall be used solely for the purpose of providing
11	automated systems, and the payment of associated costs, to improve the administration of the state's
12	unemployment insurance program. Notwithstanding the provisions of section 33.080 to the
13	contrary, all moneys remaining in the fund at the end of the biennium shall not revert to the credit of
14	the general revenue fund. The state treasurer shall invest moneys in the fund in the same manner as
15	other funds are invested. Any interest and money earned on such investments shall be credited to
16	the fund.
17	2. The unemployment automation fund shall not be used in whole or in part for any purpose
18	or in any manner that would permit its substitution for, or a corresponding reduction in, federal
19	funds that would be available in its absence to finance expenditures for the administration of this
20	chapter, or cause the appropriate agency of the United States government to withhold any part of an
21	administrative grant which would otherwise be made.
22	288.133. 1. Each employer liable for contributions pursuant to this chapter, except
23	employers with a contribution rate equal to zero, shall pay an annual unemployment automation
24	adjustment in an amount equal to two-hundredths of one percent of such employer's total taxable
25	wages for the twelve-month period ending the preceding June thirtieth.
26	2. Notwithstanding subsection 1 of this section to the contrary, the division may reduce the
27	automation adjustment percentage to ensure that the total amount of adjustment due from all
28	employers under this section shall not exceed five million dollars annually.
29	3. Each employer liable to pay an automation adjustment shall be notified of the amount due

1	under this section by March thirty-first of each year and such amount shall be considered delinquent
2	thirty days thereafter. Delinquent unemployment automation adjustment amounts may be collected
3	in the manner provided under sections 288.160 and 288.170. All moneys collected under this
4	section shall be deposited in the unemployment automation fund established in section 288.132.
5	4. For the first quarter of each calendar year, the total amount of contribution otherwise due
6	from each employer liable to pay contributions under this chapter shall be reduced by the dollar
7	amount of unemployment automation adjustment due from such employer under subsection 1 of this
8	section. However, the amount of contributions due from such employer for the first quarter of the
9	calendar year in question shall not be reduced below zero."; and
