1 AMEND House Committee Substitute for Senate Substitute for Senate Committee Substitute for
2 Senate Bill Nos. 681 & 662, Page 3, Section 160.067, Line 12, by inserting in lieu thereof the
3 following:

5 "160.082. 1. As used in this section, the following terms mean:

6 (1) "Educational institution", any public or private prekindergarten program, public or
7 private elementary or secondary school, or public or private school board or other school
8 administrative body;

9 (2) "Protective hairstyles" includes, but is not limited to, such hairstyles as braids, locks, and
10 twists;

11 (3) "Race" includes, but is not limited to, traits historically associated with race including,
12 but not limited to, hair texture and protective hairstyles. "Race" includes a perception that a person
13 is associated with another person who has, or is perceived to have, any qualities relating to race;

14 (4) "State financial assistance", any funds or other form of financial aid appropriated or
15 authorized under the laws of this state, or under any federal law administered by any state agency,
16 for the purpose of providing assistance to any educational institution for its own benefit or for the
17 benefit of any pupils admitted to the educational institution. "State financial assistance" shall
18 include, but not be limited to, all of the following:

19 (a) Grants of state property, or any interest therein;

20 (b) Provision of the services of state personnel; and

21 (c) Funds provided by contract, tax rebate, appropriation, allocation, or formula;

22 (5) "State student financial aid", any funds or other form of financial aid appropriated or
23 authorized under the laws of this state, or under any federal law administered by any state agency,
24 for the purpose of providing assistance directly to any student admitted to an educational institution.
25 "State student financial aid" shall include, but not be limited to, scholarships, loans, grants, or
26 wages.

27 2. No person shall be subjected to discrimination on the basis of race in any program or
28 activity conducted by an educational institution that receives or benefits from state financial
29 assistance or enrolls pupils who receive state student financial aid.

30 3. The provisions of subsection 2 of this section shall not apply to an educational institution

4 Further amend said bill, Page 91, Section 186.080, Line 54, by inserting after all of said section and
5 line the following:

7 "213.012. As used in this chapter, the term "race" shall include traits historically associated
8 with race including, but not limited to, hair texture and protective hairstyles. The term "protective
9 hairstyles" shall include, but is not limited to, such hairstyles as braids, locks, and twists."; and

11 Further amend said bill by amending the title, enacting clause, and intersectional references
12 accordingly.
