This 5 subdivision shall expire on December 31, 2020 [Employment as a first responder, health care 6 worker, or member of law enforcement. 7 [2.] 3. Any covered voter who is eligible to register and vote in this state may vote in any 8 election for federal office, statewide office, state legislative office, or statewide ballot initiatives by 9 submitting a federal postcard application to apply to vote by absentee ballot or by submitting a 10 federal postcard application at the polling place even though the person is not registered. - 39 115.279. 1. Application for an absentee ballot may be made by the applicant in person, or

1 by mail, or for the applicant, in person, by his or her guardian or a relative within the second degree 2 by consanguinity or affinity. The election authority shall accept applications by facsimile 3 transmission and by electronic mail within the limits of its telecommunications capacity. 4 2. No individual, group, or party shall solicit a voter into obtaining an absentee ballot 5 application. Absentee ballot applications shall not have the information pre-filled prior to it being 6 provided to a voter. 7 3. Each application shall be made to the election authority of the jurisdiction in which the 8 person is or would be registered. Each application shall be in writing and shall state the applicant's 9 name, address at which he or she is or would be registered, his or her reason for voting an absentee 10 ballot if casting an absentee ballot under subsection 2 of section 115.277, the address to which the ballot is to be mailed, if mailing is requested, and for absent uniformed services and overseas 11 applicants, the applicant's email address if electronic transmission is requested. If the reason for the 12 13 applicant voting absentee is due to the reasons established under subdivision (6) of subsection [4] 2 14 of section 115.277, the applicant shall state the voter's identification information provided by the

15 address confidentiality program in lieu of the applicant's name, address at which he or she is or would be registered, and address to which the ballot is to be mailed, if mailing is requested. Each 16 17 application to vote in a primary election shall also state which ballot the applicant wishes to receive. 18 If any application fails to designate a ballot, the election authority shall, within three working days 19 after receiving the application, notify the applicant by mail that it will be unable to deliver an 20 absentee ballot until the applicant designates which political party ballot he or she wishes to receive. 21 If the applicant does not respond to the request for political party designation, the election authority 22 is authorized to provide the voter with that part of the ballot for which no political party designation 23 is required.

24 3. [Except as provided in subsection 3 of section 115.281,] All applications for absentee 25 ballots received prior to the sixth Tuesday before an election shall be stored at the office of the 26 election authority until such time as the applications are processed in accordance with section 115.281. No application for an absentee ballot received in the office of the election authority by 27 28 mail, by facsimile transmission, by electronic mail, or by a guardian or relative after 5:00 p.m. on 29 the second Wednesday immediately prior to the election shall be accepted by any election authority. No application for an absentee ballot submitted by the applicant in person after 5:00 p.m. on the day 30 31 before the election shall be accepted by any election authority, except as provided in subsections 6, 8 32 and 9 of this section.

4. Each application for an absentee ballot shall be signed by the applicant or, if the
application is made by a guardian or relative pursuant to this section, the application shall be signed
by the guardian or relative, who shall note on the application his or her relationship to the applicant.
If an applicant, guardian or relative is blind, unable to read or write the English language or
physically incapable of signing the application, he or she shall sign by mark, witnessed by the
signature of an election official or person of his or her own choosing. Any person who knowingly
makes, delivers or mails a fraudulent absentee ballot application shall be guilty of a class one

1 election offense.

5. (1) Notwithstanding any law to the contrary, any resident of the state of Missouri who resides outside the boundaries of the United States or who is on active duty with the Armed Forces of the United States or members of their immediate family living with them may request an absentee ballot for both the primary and subsequent general election with one application.

6 (2) The election authority shall provide each absent uniformed services voter and each 7 overseas voter who submits a voter registration application or an absentee ballot request, if the 8 election authority rejects the application or request, with the reasons for the rejection.

9 (3) Notwithstanding any other law to the contrary, if a standard oath regarding material 10 misstatements of fact is adopted for uniformed and overseas voters pursuant to the Help America 11 Vote Act of 2002, the election authority shall accept such oath for voter registration, absentee ballot, 12 or other election-related materials.

13 (4) Not later than sixty days after the date of each regularly scheduled general election for 14 federal office, each election authority which administered the election shall submit to the secretary 15 of state in a format prescribed by the secretary a report on the combined number of absentee ballots 16 transmitted to, and returned by, absent uniformed services voters and overseas voters for the 17 election. The secretary shall submit to the Election Assistance Commission a combined report of 18 such information not later than ninety days after the date of each regularly scheduled general 19 election for federal office and in a standardized format developed by the commission pursuant to the Help America Vote Act of 2002. The secretary shall make the report available to the general public. 20

(5) As used in this section, the terms "absent uniformed services voter" and "overseas voter"
shall have the meaning prescribed in 52 U.S.C. Section 20310.

6. An application for an absentee ballot by a new resident shall be submitted in person by the applicant in the office of the election authority in the election jurisdiction in which such applicant resides. The application shall be received by the election authority no later than 7:00 p.m. on the day of the election. Such application shall be in the form of an affidavit, executed in duplicate in the presence of the election authority or any authorized officer of the election authority, and in substantially the following form:
