AMEND House Amendment No. \_\_\_\_ to House Committee Substitute for House Bill No. 2140,  
Page 1, Lines 4-19, by deleting all of said lines and inserting in lieu thereof the following:

"115.133. 1. This section shall be known and may be cited as "The Missouri Restoration of Voting Rights Act".

2. Except as provided in subsection ~~[2]~~ 3 of this section, any citizen of the United States who is a resident of the state of Missouri and seventeen years and six months of age or older shall be entitled to register and to vote in any election which is held on or after his eighteenth birthday.

~~[2.]~~ 3. No person who is adjudged incapacitated shall be entitled to register or vote. No person shall be entitled to vote:

(1) While confined under a sentence of imprisonment or under a probation or parole revocation;

(2) While on probation or parole after conviction of a dangerous felony, as defined in section 556.061, until finally discharged from such probation or parole; or

(3) After conviction of a felony connected with the right of suffrage or misdemeanor connected with the right of suffrage.

~~[3.]~~ 4. Except as provided in federal law or federal elections and in section 115.277, no person shall be entitled to vote if the person has not registered to vote in the jurisdiction of his or her residence prior to the deadline to register to vote."; and

Further amend said amendment, Page 1, Line 19, by inserting after all of said line the following:

"Further amend said bill, Page 7, Section 115.151, Line 18, by inserting after all of said section and line the following:

"115.155. 1. The election authority shall provide for the registration of each voter. Each application shall be in substantially the following form:

2. After supplying all information necessary for the registration records, each applicant who appears in person before the election authority shall swear or affirm the statements on the registration application by signing his or her full name, witnessed by the signature of the election authority or such authority's deputy registration official. Each applicant who applies to register by mail pursuant to section 115.159, or pursuant to section 115.160 or 115.162, shall attest to the statements on the application by his or her signature.

3. Upon receipt by mail of a completed and signed voter registration application, a voter registration application forwarded by the division of motor vehicle and drivers licensing of the department of revenue pursuant to section 115.160, or a voter registration agency pursuant to section

1 115.162, the election authority shall, if satisfied that the applicant is entitled to register, transfer all  
2 data necessary for the registration records from the application to its registration system. Within  
3 seven business days after receiving the application, the election authority shall send the applicant a  
4 verification notice. If such notice is returned as undeliverable by the postal service within the time  
5 established by the election authority, the election authority shall not place the applicant's name on  
6 the voter registration file.

7 4. If, upon receipt by mail of a voter registration application or a voter registration  
8 application forwarded pursuant to section 115.160 or 115.162, the election authority determines that  
9 the applicant is not entitled to register, such authority shall, within seven business days after  
10 receiving the application, so notify the applicant by mail and state the reason such authority has  
11 determined the applicant is not qualified. The applicant may file a complaint with the elections  
12 division of the secretary of state's office under and pursuant to section 115.219. If an applicant for  
13 voter registration fails to answer the question on the application concerning United States  
14 citizenship, the election authority shall notify the applicant of the failure and provide the applicant  
15 with an opportunity to complete the form in a timely manner to allow for the completion of the  
16 registration form before the next election.

17 5. The secretary of state shall prescribe specifications for voter registration documents so  
18 that they are uniform throughout the state of Missouri and comply with the National Voter  
19 Registration Act of 1993, including the reporting requirements, and so that registrations, name  
20 changes and transfers of registrations within the state may take place as allowed by law.

21 6. All voter registration applications shall be preserved in the office of the election  
22 authority."; and

24 Further amend said bill, Page 10, Section 115.157, Line 81, by inserting after all of said section and  
25 line the following:

27 "115.158. 1. The secretary of state shall implement a centralized, interactive computerized  
28 statewide voter registration list. This computerized list shall be known as the "Missouri Voter  
29 Registration System". The system shall be implemented by January 1, 2004, unless a waiver is  
30 obtained pursuant to the Help America Vote Act of 2002. If a waiver is obtained, the system shall  
31 be implemented by January 1, 2006. The system shall be maintained and administered by the  
32 secretary of state and contain the name and registration information of every legally registered voter  
33 in Missouri. In addition, the system shall:

- 34 (1) Assign a unique identifier to each legally registered voter in Missouri;  
35 (2) Serve as the single system for storing and managing the official list of registered voters  
36 throughout Missouri;  
37 (3) Be coordinated with other agency databases in Missouri;  
38 (4) Allow any election official in Missouri, including local election authorities, immediate  
39 electronic access to the information contained in the system;

1 (5) Allow all voter registration information obtained by any local election official in  
2 Missouri to be electronically entered into the system on an expedited basis at the time the  
3 information is provided to the local official. The secretary of state, as the chief state election  
4 official, shall provide such support as may be required so that local election officials are able to  
5 enter the registration information; and

6 (6) Serve as the official voter registration list for the conduct of all elections in Missouri.

7 2. The secretary of state and local election authorities shall perform system maintenance on  
8 a regular basis, which shall include:

9 (1) Removing names in accordance with the provisions and procedures of the National Voter  
10 Registration Act of 1993 and coordinating system maintenance activities with state agency records  
11 on death ~~and felony status~~;

12 (2) Requiring the name of each registered voter to appear in the system;

13 (3) Removing only voters who are not registered or who are not eligible to vote; and

14 (4) Eliminating duplicate names from the system.

15 3. The secretary of state shall provide adequate technological security measures to prevent  
16 the unauthorized access to the system established pursuant to this section.

17 4. The secretary of state shall develop procedures to ensure that voter registration records  
18 within the system are accurate and updated regularly. At a minimum, the procedures shall include:

19 (1) A system of file maintenance that makes a reasonable effort to remove registrants who  
20 are ineligible to vote. Consistent with the National Voter Registration Act of 1993, registrants who  
21 have not responded to a notice and who have not voted in two consecutive general elections for  
22 federal office shall be removed from the official list of eligible voters, except that no registrant may  
23 be removed solely by reason of a failure to vote; and

24 (2) Safeguards to ensure that eligible voters are not removed in error.

25 5. Voter registration information shall be verified in accordance with the Help America Vote  
26 Act of 2002.

27 (1) Except as provided in subdivision (2) of this subsection, an application for voter  
28 registration may not be accepted or processed unless the application includes:

29 (a) In the case of an applicant who has been issued a current and valid driver's license, the  
30 applicant's driver's license number; or

31 (b) In the case of any other applicant, other than an applicant to whom subdivision (2)  
32 applies, the last four digits of the applicant's Social Security number.

33 (2) If an applicant for voter registration has not been issued a current and valid driver's  
34 license or a Social Security number, the applicant shall be assigned a number which will serve to  
35 identify the applicant for voter registration purposes. The number assigned under this subdivision  
36 shall be used as the unique identifying number within the system.

37 (3) The secretary of state and the director of the department of revenue shall enter into an  
38 agreement to match information in the database of the voter registration system with information in  
39 the database of the motor vehicle system to enable the secretary to verify the accuracy of

1 information provided on applications for voter registration.

2 (4) The director of the department of revenue shall enter into an agreement with the  
3 commissioner of Social Security and comply with the Help America Vote Act of 2002.

4 6. In addition to using the system for voter registration, the election authorities and secretary  
5 of state may use the system for the collection and dissemination of election results and other  
6 pertinent information. Any information contained in any state or local voter registration system,  
7 limited to the master voter registration list or any other list generated from the information, subject  
8 to chapter 610, shall not be used for commercial purposes; provided, however, that the information  
9 may be used for elections, for candidates, or for ballot measures, furnished at a reasonable fee.

10 Violation of this section shall be a class B misdemeanor. For purposes of this section, "commercial  
11 purposes" means the use of a public record for the purpose of sale or resale or for the purpose of  
12 producing a document containing all or part of the copy, printout, or photograph for sale or the  
13 obtaining of names and addresses from public records for the purpose of solicitation or the sale of  
14 names and addresses to another for the purpose of solicitation or for any purpose in which the  
15 purchaser can reasonably anticipate the receipt of monetary gain from the direct or indirect use of  
16 the public record.

17 7. The secretary of state shall establish an advisory committee to assist in the establishment  
18 and maintenance of the Missouri voter registration system.

19 8. The secretary of state may promulgate rules to execute this section. No rule or portion of  
20 a rule promulgated pursuant to the authority of this section shall become effective unless it has been  
21 promulgated pursuant to chapter 536.

22 9. Election authorities and any agency required under the National Voter Registration Act of  
23 1993 to accept voter registration applications shall forward registration and other data in a manner  
24 prescribed by the secretary of state to assist with administering and maintaining the Missouri voter  
25 registration system in accordance with the Help America Vote Act of 2002.

26 115.195. 1. At least once each month, the state or local registrar of vital statistics shall  
27 provide to the election authority a list of the name and address, if known, of each person over  
28 eighteen years of age in its jurisdiction whose death has been reported to him or her and provide a  
29 copy of the list of any death reported in the state to the secretary of state. The secretary of state  
30 shall notify the election authority of the jurisdiction in which the deceased resided of the  
31 information received pursuant to this subsection.

32 2. At least once each month, the clerk of the circuit court of each county and city not within  
33 a county shall provide to the election authority a list of the name and address, if known, of each  
34 person over eighteen years of age in the court's jurisdiction who has been convicted of any felony  
35 connected with the right of suffrage, or of a misdemeanor connected with the right of suffrage. A  
36 copy of the list shall also be submitted to the secretary of state. The secretary of state shall notify  
37 the election authority of the jurisdiction in which an offender resides of the information received  
38 pursuant to this subsection.

39 3. At least once each month, the clerk of the probate division of the circuit court of each

1 county and city not within a county shall provide to the election authority a list of the name and  
 2 address, if known, of each person over eighteen years of age in the court's jurisdiction who has been  
 3 adjudged incapacitated and has not been restored to capacity. A copy of the list shall also be  
 4 submitted to the secretary of state. The secretary of state shall notify the election authority of the  
 5 jurisdiction in which such person resides of the information received pursuant to this subsection.

6 4. All state and local registrars and all clerks of probate divisions of the circuit courts and  
 7 circuit courts shall provide the information specified in this section, without charge, to the election  
 8 authority or the secretary of state."; and"; and

10 Further amend said amendment, Page 2, Line 9, by deleting all of said line and inserting in lieu  
 11 thereof the following:

13 "newspaper, that identify the candidates and their positions on the issues, if available.

14 115.283. 1. Each ballot envelope shall bear a statement on which the voter shall state the  
 15 voter's name, the voter's voting address, the voter's mailing address and the voter's reason for voting  
 16 an absentee ballot. If the reason for the voter voting absentee is due to the reasons established under  
 17 subdivision (6) of subsection 1 of section 115.277, the voter shall state the voter's identification  
 18 information provided by the address confidentiality program in lieu of the applicant's name, voting  
 19 address, and mailing address. On the form, the voter shall also state under penalties of perjury that  
 20 the voter is qualified to vote in the election, that the voter has not previously voted and will not vote  
 21 again in the election, that the voter has personally marked the voter's ballot in secret or supervised  
 22 the marking of the voter's ballot if the voter is unable to mark it, that the ballot has been placed in  
 23 the ballot envelope and sealed by the voter or under the voter's supervision if the voter is unable to  
 24 seal it, and that all information contained in the statement is true. In addition, any person providing  
 25 assistance to the absentee voter shall include a statement on the envelope identifying the person  
 26 providing assistance under penalties of perjury. Persons authorized to vote only for federal and  
 27 statewide officers shall also state their former Missouri residence.
