9.236 & 208.184	HB 2658	Referred: Rules - Administrative Oversight(H)	This bill designates the third full week of September of each year as "Sickle Cell Awareness Week". This bill also requires the Advisory Council on Rare Diseases and Personalized Medicine to conduct at least one review annually.
9.347	HB 1838	Read Second Time (H)	This bill designates the month of October as "Substance Abuse Awareness and Prevention Month" in Missouri. Citizens of this state are encouraged to participate in appropriate events and activities to raise awareness about the dangers of substance abuse and the need to expand outreach and educational efforts.
9.364 & 9.365	Floor Amendment 5066H01.18H to HB 2310	Perfected with Amendments (H)	Language from amendment 5066H01.18H on HB 2310 designating "Black Maternal Health Week" & "Minority Health Month".
135.690	HB 2595	Referred: Rules - Legislative Oversight(H)	Beginning January 1, 2023, this bill creates a tax credit for any community-based faculty preceptor, as defined in the bill, who serves as the community-based faculty preceptor for a medical student core preceptorship or a physician assistant student core preceptorship, as defined in the bill.
160.485	HB 1722	Placed on the Informal Perfection Calendar (H)	This bill creates the "Stop the Bleed Act", defines "bleeding control kits" and requires the Department of Elementary and Secondary Education (DESE) to develop a traumatic blood loss protocol for school personal by January 1, 2023. The bill outlines the specific requirements for the blood loss protocol which shall include a bleeding control kit be placed in areas where there is likely to be high traffic or congregation, and areas where risk of injury may be elevated.
167.625	SB 710 (Senate Perfected)	(Senate Perfected) Third Read and Passed (S) - EC adopted	This bill establishes "Will's Law," requiring individualized health care plans to be developed by school nurses in public schools and charter schools for students with epilepsy or seizure disorders. Emergency clause adopted.
170.047, 170.048 & 173.1200	HB 2238	Read Second Time (H)	This bill establishes the "Jason Flatt/ Avery Reine Cantor Act". The bill states that beginning in the 2022-23 school year, each school district can offer at least two hours of suicide prevention training for all practicing teachers. All teachers, principals, and licensed educators can attend such a training or complete training on suicide prevention through self-review of suicide prevention materials. This bill also requires public schools, charter schools, and public institutions of higher education that issue pupil identification cards to have printed on the card specific phone numbers including those for the National Suicide Prevention Lifeline and the Crisis Text Line.
172.800	Added in HCS		Deletes outdated reference to the Alzheimer's Disease and Related Disorders Task Force.

190.245	HB 2109	Executive Session Continued – Action Postponed (H)	This bill provides ambulance operators and other emergency service personnel pursuant to Section 190.001-190.245, RSMo, shall be considered health care professionals for purposes of participating in and being subject to peer review committees pursuant to Section 537.035. Any quality improvement or quality assurance activity required by persons licensed as ambulance operators or other emergency service personnel shall be considered an activity of a peer review committee.
191.116	HB 2174	Placed on the Informal Perfection Calendar (H)	This bill changes the date the Alzheimer's State Plan Task Force must deliver their report of recommendations to the Governor and members of the General Assembly from no later than June 1, 2022 to no later than November 1, 2022.
191.500, 191.515, 191.520, 191.525, 335.230 & 335.257	HB 2881	Read Second Time (H)	This bill expands the pool of eligible students that may apply to the Department of Health and Senior Services for a student loan under Chapter 191, RSMo, from students pursuing a degree of doctor of medicine or doctor of osteopathy to now include students seeking a degree in the area of psychiatry, a degree of doctor of dental surgery or dental medicine, or a bachelor of science degree in dental hygiene and provides that all eligible students must be residents of the state.
191.743, 196.866 & 196.868	HB 2331 (House Introduced)	Second read and referred: Professional Registration (S) – Public Hearing Held	This bill repeals in their entirety Sections 191.743, 196.866, and 196.868, RSMo, dealing with frozen dessert licensure and perinatal substance abuse.
192.2001, 251.070 & 660.010	HB 2377	Read Second Time (H)	This bill amends Sections 251.070 and 660.010, RSMo, to accurately reflect that the state's responsibilities under Public Law 73, the Older Americans Act of 1965, are no longer under the Department of Social Services but are instead under the Department of Health and Senior Services under Chapter 192.
192.2225, 197.100, 197.256, 197.258, 197.415, 198.006, 198.022, 198.026, 198.036, 198.525, 198.526 & 198.545	HB 2848	Read Second Time (H)	This bill requires the Department of Health and Senior Services to conduct at least one unannounced inspection per year for licensed adult day care programs. This bill requires inspections of hospitals to be performed in accordance with the schedule set forth under federal Medicare law
194.210, 194.255, 194.265, 194.285, 194.290, 194.297, 194.299, 194.300, 194.304, 301.020 & 302.171	HB 2680	Referred: Health and Mental Health Policy (H) – Executive Session Continued	Modifies provisions relating to the Organ Donor Program Fund. Specifies that any amounts that may be received from appropriations, grants, gifts, bequests, the federal government, or any other source may also be deposited into the Fund. The Department of Health and Senior Services may pursue funding to support programmatic efforts and initiatives as described in the bill. This bill specifies that the Department may conduct a survey of a hospice facility to evaluate the quality of services rendered by the applicant. This bill changes the inspection requirement of a hospice facility and home health agency to be performed in accordance with the schedule set forth under federal Medicare law. This bill requires notice of noncompliance or revocation of a license to be sent by a delivery service to the operator or administrator of the facility. This bill modifies the "Missouri Informal Dispute Resolution Act" relating to informal dispute resolutions between the Department and licensed long-term care facilities.
195.010	Added in HCS		Removes fentanyl testing strips from the definition of “drug paraphernalia” for purposes of Chapters 195 and 579.

195.206, 579.040, and 579.076	SB 690	Underlying Bill	Any licensed pharmacist may sell and dispense an addiction mitigation medication under a physician protocol or a statewide standing order. Any entity registered with the Department of Health and Senior Services that possesses, distributes, or delivers hypodermic needles or syringes for the purposes of operating a syringe exchange program or otherwise mitigating health risks associated with unsterile injection drug use shall be exempt from the offense of unlawful distribution, delivery or sale of drug paraphernalia, if such entity is not located within a quarter-mile of a school building, as well as the offense of unlawful manufacturing with intent to deliver drug paraphernalia.
196.1170	HB 1667 (House Perfected)	(House Perfected) Third Read and Passed (H)	This bill establishes the "Kratom Consumer Protection Act", which requires dealers who prepare, distribute, sell, or expose for sale a food that is represented to be a kratom product to disclose on the product label the basis on which this representation is made. A dealer is prohibited from preparing, distributing, selling, or exposing for sale a kratom product that does not conform to these labeling requirements.
197.400 and 197.445	SS HB 2149	Fiscal Review (H) – Reported Do Pass	This bill expands those practitioners eligible to create a plan of treatment for a home health agency providing home health services from physicians to now include nurse practitioners, clinical nurse specialists, or physician assistants, as defined in the bill.
198.640, 198.642, 198.644, 198.646, 198.648 & 210.921	HB 2605	Placed on the Informal Perfection Calendar (H)	This bill establishes procedures and requirements for the registration and qualifications of supplemental health care service agencies, defined as persons or entities engaged in the business of providing or procuring temporary employment in health care facilities for health care personnel.
208.151 and 208.662	HB 2604	Referred: Rules - Administrative Oversight(H)	Currently, low-income pregnant and postpartum women receiving benefits through MO HealthNet for pregnant women or the Show-Me Healthy Babies Program are eligible for pregnancy-related coverage throughout the pregnancy and for 60 days following the end of the pregnancy. This bill provides MO HealthNet coverage for such women will include full Medicaid benefits for the duration of the pregnancy and for one year following the end of the pregnancy.
208.152	HB 2368	Referred: Rules - Administrative Oversight(H)	MO HealthNet beneficiaries shall be eligible to receive coverage for health home services for children with medically complex conditions under 42 U.S.C. Section 1396w-4a. The Department of Social Services shall submit a state plan amendment necessary to implement this coverage.
208.798	HB 2820	Voted Do Pass (H) – Health and Mental Health Policy	Currently, the state pharmaceutical assistance program, known as the "Missouri RX Plan", is set to terminate on August 28, 2022. This bill extends the Missouri RX Plan to instead terminate on August 28, 2029

334.530 and 334.655	HB 2149	Third Read and Passed (H) (House Perfected Version)	Currently, an individual applying to be licensed as a physical therapist must provide evidence of completion of a program of physical therapy education approved as reputable by the Board of the Healing Arts. Also, an individual applying to be licensed as a physical therapist assistant must provide a certificate of graduation from an accredited high school or its equivalent and evidence of completion of an associate degree program of physical therapy education accredited by the Advisory Commission for Physical Therapists. This bill allows for the applicant to provide evidence of eligibility to graduate from the relevant programs within 90 days in lieu of the evidence of completion of the program.
338.010	Added in HCS		Repeals language from current law defining the practice of pharmacy as including the administration of specific vaccines by written physician protocol for specific patients and adds language defining the practice of pharmacy as including the ordering and administering of U.S. FDA-approved or authorized vaccines, with certain exceptions provided for in the bill. Repeals provisions of current law requiring pharmacists to administer vaccines by protocol in accordance with treatment guidelines established by the CDC and provisions requiring a pharmacist who is administering a vaccine to request a patient remain in the pharmacy a safe amount of time after administration of the vaccine to observe any adverse reactions.
338.061	HB 1644	Referred: Rules - Administrative Oversight(H)	This bill establishes the "Tricia Leann Tharp Act" and states that the Board of Pharmacy shall recommend two hours of continuing education in suicide awareness and prevention for all licensed pharmacists.
376.427	HB 2743	Referred: Rules - Legislative Oversight(H)	This bill adds a prepaid dental plan to the definition of a health benefit plan and requires a prepaid dental plan to issue a payment within 30 days of the receiving of all documents reasonably needed to determine a claim.
376.1575	HB 2199	Referred: Rules - Legislative Oversight(H)	The bill modifies the definition of "health carrier", as used in statutes relating to the credentialing of health care practitioners, to include prepaid dental plans.
376.1800	HB 2340	Referred: Rules - Legislative Oversight(H)	This bill allows dentists and chiropractors to sell, offer, and market medical retainer agreements.
630.980	HB 2253	Read Second Time (H)	This bill provides that, subject to appropriation, the Department of Mental Health shall establish and administer a Behavioral Crisis Grant Program to assist nonprofit organizations in the creation or maintenance of programs that support individuals that experience a behavioral crises, as defined in the bill.
Section B (Emergency Clause)	Various Sections	Various bills added in the HCS	Emergency Clause – Sections 167.625 (SB 710), 191.116 (HB 2174), and 208.151 and 208.662 (HB 2604) shall be in full force and effect upon passage and approval.
