

SPONSOR: Basye

COMMITTEE ACTION: Voted "Do Pass with HCS" by the Standing Committee on General Laws by a vote of 8 to 4.

The following is a summary of the House Committee Substitute for HB 2734.

This bill provides that no athletic team or sport designated for females, women, or girls may be open to students of the male sex as assigned at birth for games in the post-season or playoff season including, but not limited to, districts, conference, sectionals, state, or nationals.

No government entity or oversight body shall entertain a complaint, open an investigation, or take adverse action against a school or institution for maintaining separate athletic teams or sports for students of the female sex. No public or private school that has biological males as assigned at birth playing women's sports during the post-season or playoff seasons shall be eligible for any moneys appropriated by the General Assembly.

The following is a summary of the public testimony from the committee hearing. The testimony was based on the introduced version of the bill.

PROPONENTS: Supporters say that athletic opportunities for female athletes are in question if biological males are allowed to compete. Biological men have an unfair advantage in sports competition over women and biological men should not be allowed to compete in women's sports. This bill protects women athletes, their right to fair competition, and the integrity of women's sports. Allowing biological males to compete in female sports continues a practice of unfair sex-based disadvantage for women. Female athletes are at risk for losing scholarship opportunities and collegiate experience if forced to compete against biological males. It is fair that athletes should compete against their biological peers in any athletic contest.

OPPONENTS: Those who oppose the bill say that youth want the ability to be recognized for who they are. This bill unfairly discriminates against transgender youth and students, who deserve the same chances to learn teamwork, sportsmanship, leadership, and self-discipline, and to build a sense of belonging with their peers. Similar bills that have passed into law in other states are currently being challenged in court. This bill weaponizes sports against vulnerable youth. Sports governing bodies and experts have done exhaustive work and research to reach fair and balanced position on this issue, having implemented rigorous standards for participation in sports by transgender athletes. This bill undermines this work with government overreach. This bill is unnecessary and ultimately has the potential to cause great harm. Bills like this are consistently opposed by women athletes and do not address actual issues faced by women and girls in sports. This bill encourages bullying and strips fundamental rights of transgender youth.
