The County Auditors support moving the publication date to June 30 to meet the industry standard. For the larger counties whose finances and managed on an accrual basis rather than a cash basis, it is difficult to publish accurate financial statements by March 1st because transactions are still accruing. The date change resolves this problem and does not impact the smaller counties because the legislation says that the statements must be published on or before June 30th. If they were publishing earlier in the year they still can.
