4	"211.575. 1. The "Task Force on Juvenile Justice and Education" is hereby created to study
5	and make recommendations on the processes, procedures, and protocols regarding education for
6	adjudicated youth in Missouri. The task force shall consist of the following members:
7	(1) One member of the general assembly appointed by the president pro tempore of the
8	senate;
9	(2) One member of the general assembly appointed by the minority floor leader of the
10	senate;
11	(3) One member of the general assembly appointed by the speaker of the house of
12	representatives;
13	(4) One member of the general assembly appointed by the minority floor leader of the house
14	of representatives;
15	(5) The secretary of state or his or her designee;
16	(6) The attorney general or his or her designee; and
17	(7) A current or former judge from the juvenile and family court appointed by the St. Louis
18	juvenile court system.
19	2. Members of the task force shall be individuals who are actively involved in or have a
20	well-documented interest in the fields of education, special education, or adjudicated youth. The
21	appointment of members shall reflect the geographic diversity of the state.
22	3. The task force shall elect a presiding officer by a majority vote of the members of the task
23	force. The task force shall meet at the call of the presiding officer.
24	4. The task force shall study nationally recognized best practices and make
25	recommendations regarding the development and implementation of effective state-wide processes
26	and procedures for the appropriate education of adjudicated youth. In making the recommendations
27	the task force shall:

1	(1) Gather information concerning current processes, procedures, protocols, and adherence
2	from throughout the state;
3	(2) Receive reports and testimony from individuals, state and local agencies, community-
4	based organizations, and other public and private organizations; and
5	(3) Create goals for state policy that would ensure adjudicated youth receive free,
6	appropriate, and consistent education.
7	5. The recommendations may include proposals for specific statutory changes and additions
8	or methods to foster cooperation among state agencies and between the state and local government.
9	6. The task force shall consult with employees of the department of social services, the
10	department of public safety, the department of elementary and secondary education, the department
11	of corrections, and any other state agency, board, commission, office, or department as necessary to
12	accomplish the task force's responsibilities under this section.
13	7. The task force shall meet within two months of August 28, 2023.
14	8. The members of the task force shall serve without compensation and shall not be
15	reimbursed for their expenses.
16	9. The secretary of state's and attorney general's office shall provide administrative support
17	to the task force.
18	10. On or before December 31, 2023, the task force shall submit a report on the task force's
19	findings to the governor and general assembly.
