- (8) The state recognizes the rights and duties of the parents, or legal guardians if applicable, to provide direction to the child in the exercise of the child's rights in a manner consistent with the evolving capacities of the child;
- (9) The state recognizes the rights of the child to freedom of association and freedom of peaceful assembly;
- (10) It is the policy of the state that no child shall be subjected to arbitrary or unlawful interference with his or her privacy, family, home, or correspondence;
- (11) The state recognizes that both parents have common responsibilities for the upbringing and development of a child. Parents, or legal guardians if applicable, have the primary responsibility for the upbringing and development of the child. The best interests of the child shall be the parents', or legal guardians' if applicable, basic concern;
- (12) It is the policy of the state to render appropriate assistance to parents, or legal guardians if applicable, in the performance of their child-rearing responsibilities and to ensure the development of institutions, facilities, and services for the care of the child;
- (13) It is the policy of the state to ensure that children of working parents have the right to benefit from child care services and facilities for which the children are eligible;
- (14) The state shall take all appropriate legislative, administrative, social, and educational measures to protect the child from all forms of physical or mental violence; injury; and abuse, neglect or negligent treatment, maltreatment, or exploitation, including sexual abuse, while in the care of the parents, the legal guardians, or any other person or entity;
- (15) A child temporarily or permanently deprived of his or her family environment, or in whose best interests cannot be allowed to remain in that environment, shall be entitled to special protection and assistance provided by the state;
- (16) It is the policy of the state that a child has a right to the highest attainable standard of health and to facilities for the treatment of illness and rehabilitation of health. The state shall ensure that no child is deprived of his or her right of access to such health care services;
  - (17) The state recognizes the right of the child to education that shall be directed toward:
- (a) The development of the child's personality, talents, and mental and physical abilities to the child's fullest potential;
- (b) The development of respect for human rights and fundamental freedoms and for the principles enshrined in the Charter of the United Nations;
- (c) The development of respect for the child's parents and the child's cultural identity, language, and values; for the national values of the country in which the child is living and the country from which the child may originate; and for civilizations different from the child's civilization;
