1 AMEND Senate Bill No. 28, Page 1, Section 43.253, Line 13, by inserting after said section and line
2 the following:

4 "509.520. 1. Notwithstanding any provision of law to the contrary, beginning August 28,
5 [2009] 2023, pleadings, attachments, ~~[or]~~ exhibits filed with the court in any case, as well as any
6 judgments or orders issued by the court, or other records of the court shall not include the following
7 confidential and personal identifying information:

8 (1) The full Social Security number of any party or any child ~~[who is the subject to an order~~
9 ~~of custody or support]~~;

10 (2) The full credit card number ~~[or other]~~, financial institution account number, personal
11 identification number, or password used to secure an account of any party;

12 (3) The full motor vehicle operator license number;

13 (4) Victim information, including the name, address, and other contact information of the
14 victim;

15 (5) Witness information, including the name, address, and other contact information of the
16 witness;

17 (6) Any other full state identification number;

18 (7) The full name, address, and date of birth of a minor; or

19 (8) The full date of birth of any party; however, the year of birth shall be made available.

20 2. The information provided under subsection 1 of this section shall be provided in a
21 confidential information filing sheet contemporaneously filed with the court or entered by the court,
22 which shall not be subject to public inspection or availability.

23 3. Nothing in this section shall preclude an entity including, but not limited to, a financial
24 institution, insurer, insurance support organization, or consumer reporting agency that is otherwise
25 permitted by law to access state court records from using a person's unique identifying information
26 to match such information contained in a court record to validate that person's record.

27 4. The Missouri supreme court shall promulgate rules to administer this section.

28 5. Contemporaneously with the filing of every petition for dissolution of marriage, legal
29 separation, motion for modification, action to establish paternity, and petition or motion for support

6 the Social Security number of the respondent; and

7 (3) The names, dates of birth, and Social Security numbers of any children subject to the

9 ~~[3:]~~ 6. Contemporaneously with the filing of every responsive pleading petition for
10 dissolution of marriage, legal separation, motion for modification, action to establish paternity, and
11 petition or motion for support or custody of a minor child, the responding party shall file a
12 confidential case filing sheet with the court which shall not be subject to public inspection and
13 which provides:

14 (1) The name and address of the current employer and the Social Security number of the
15 responding party, if a person;

16 (2) If known to the responding party, the name and address of the current employer and the
17 Social Security number of the petitioner or movant; and

18 (3) The names, dates of birth, and Social Security numbers of any children subject to the
19 action.

20 [4:] 7. The full Social Security number of any party or child subject to an order of custody
21 or support shall be retained by the court on the confidential case filing sheet or other confidential
22 record maintained in conjunction with the administration of the case. The full credit card number or
23 other financial account number of any party may be retained by the court on a confidential record if
24 it is necessary to maintain the number in conjunction with the administration of the case.

25 ~~[5:]~~ 8. Any document described in subsection 1 of this section shall, in lieu of the full
26 number, include only the last four digits of any such number.

27 ~~[6:]~~ 9. Except as provided in section 452.430, the clerk shall not be required to redact any
28 document described in subsection 1 of this section issued or filed before August 28, 2009, prior to
29 releasing the document to the public.

30 ~~[7:]~~ 10. For good cause shown, the court may release information contained on the
31 confidential case filing sheet; except that, any state agency acting under authority of chapter 454
32 shall have access to information contained herein without court order in carrying out their official
33 duty."; and
